OPENING CEREMONIES

1. CALL TO ORDER

The Torrance City Council was called to order in a regular meeting on Tuesday, August 20, 1996, at 5:30 P.M. There being no quorum at that time, the City Council convened in a regular meeting on Tuesday, August 20, 1996, at 6:32 P.M., in the Council Chamber of Torrance City Hall.

7f. PURCHASE ORDER FOR TRAFFIC CONTROL EQUIPMENT AND SIGNAL HARDWARE

RECOMMENDATION

It is recommended by the General Services Director and the Director of Street Services that the City Council authorize a purchase order to Econolite Products of Anaheim, California, in the anticipated amount of \$75,000.00, plus a 10% contingency, for a total of \$82,500.00 for the sole source purchase of traffic control equipment and signal hardware on an "as needed" basis.

7g. VANPOOL PROGRAM AND RENEWAL OF A CONTRACT THE EMPLOYEE RIDESHARE PROGRAM COORDINATION

RECOMMENDATION

It is recommended by the City Manager that the City Council appropriate \$39,639.84 in vanpool fare box revenue to the City's Vanpool Program; and approve the renewal of a contract for the employee rideshare program coordination with Brohman & Brohman in the amount of \$65,520 per year from August 26, 1996 - August 25, 1997.

7h. PURCHASE ORDER TO FURNISH ALL EQUIPMENT, MATERIALS, AND LABOR REQUIRED FOR TREE AND/OR STUMP REMOVAL

RECOMMENDATION

It is recommended by the General Services Director and the Director of Street Services that the City Council authorize a purchase order be issued for \$119,586.00, plus a 10% contingency, for a total of \$131,544.60, to West Coast Arborists, Inc., of Anaheim, California, to furnish all equipment, materials, and labor required to completely remove City trees and/or tree stumps on an "as needed" basis for a period of three (3) years.

18. ADDENDUM MATTERS

18a. SUPPORT OF SENATE BILL 1690 (KOPP)

City Attorney Fellows informed the Council members that, in order, to consider this issue, the Council would need to take action, recognizing by a two-thirds vote, that the subject matter and the need to take related action arose subsequent to the posting of the agenda, noting that such action may be taken pursuant to Brown Act Section 54954.2 (b)(2).

MOTION: Councilwoman Cribbs so moved. The motion was seconded by Councilman Messerlian and roll call vote of those present reflected unanimous approval (Councilman Lee absent).

RECOMMENDATION

It is recommended by the City Manager that the City Council approve and that the Mayor sign a letter in support of Senate Bill 1690 (KOPP) and that this letter be forwarded to the Senate.

For Councilman Nakano, Management Assistant Lopez confirmed that the Bill does exclude transitional shelter facilities, foster family homes, and residential care facilities for the elderly. Mr. Nakano apprised staff that he had received a phone call from a Southwood Riviera resident, expressing concern with the placement of a third residential care facility within a one-block area. Councilman Nakano requested that additional clarification/information with regard to residential care facilities be provided such as whether Federal statute or State legislation precludes local municipalities from imposing any type of regulations on these facilities. Councilwoman O'Donnell recommended forwarding communication to State legislators, requesting the imposition of an allowable limit on such facilities per block and the need to establish local control in an effort to retain the integrity of the City and neighborhood.

Although the KOPP Bill does not address all concerns/issues raised by the residents at the August 6, 1996, Workshop, Mayor Hardison noted that the Bill would address future issues which may, at this point in time, not yet be present in the City. In response to the Southwood Riviera resident's concern, City Manager Jackson replied that it would be researched through the Fire Department whether or not a third facility is being proposed within a one-block area.

MOTION: Councilman Messerlian moved to concur with the City Manager's recommendation. The motion was seconded by Councilwoman Cribbs and roll call vote of those present reflected unanimous approval (Councilman Lee absent).

At 7:29 P.M., the City Council convened as the Redevelopment Agency of the City of Torrance. The meeting of the Redevelopment Agency was adjourned at 7:30 P.M., and consideration of regular Council business was resumed.

City Manager Jackson noted that staff will discuss the matter with Mr. Cole.

Ms. Helen Doyle, 18626 Yukon Avenue, commended Parks and Recreation Director Barnett and the Parks and Recreation Department on its efforts associated with the recent Neighborhood Community Picnic at Columbia Park and requested that if the event were sponsored by the Department again next year, that it be better advertised to ensure increased participation. Although this was a pilot program, Mr. Barnett advised that the standard methods of public notification were followed.
