

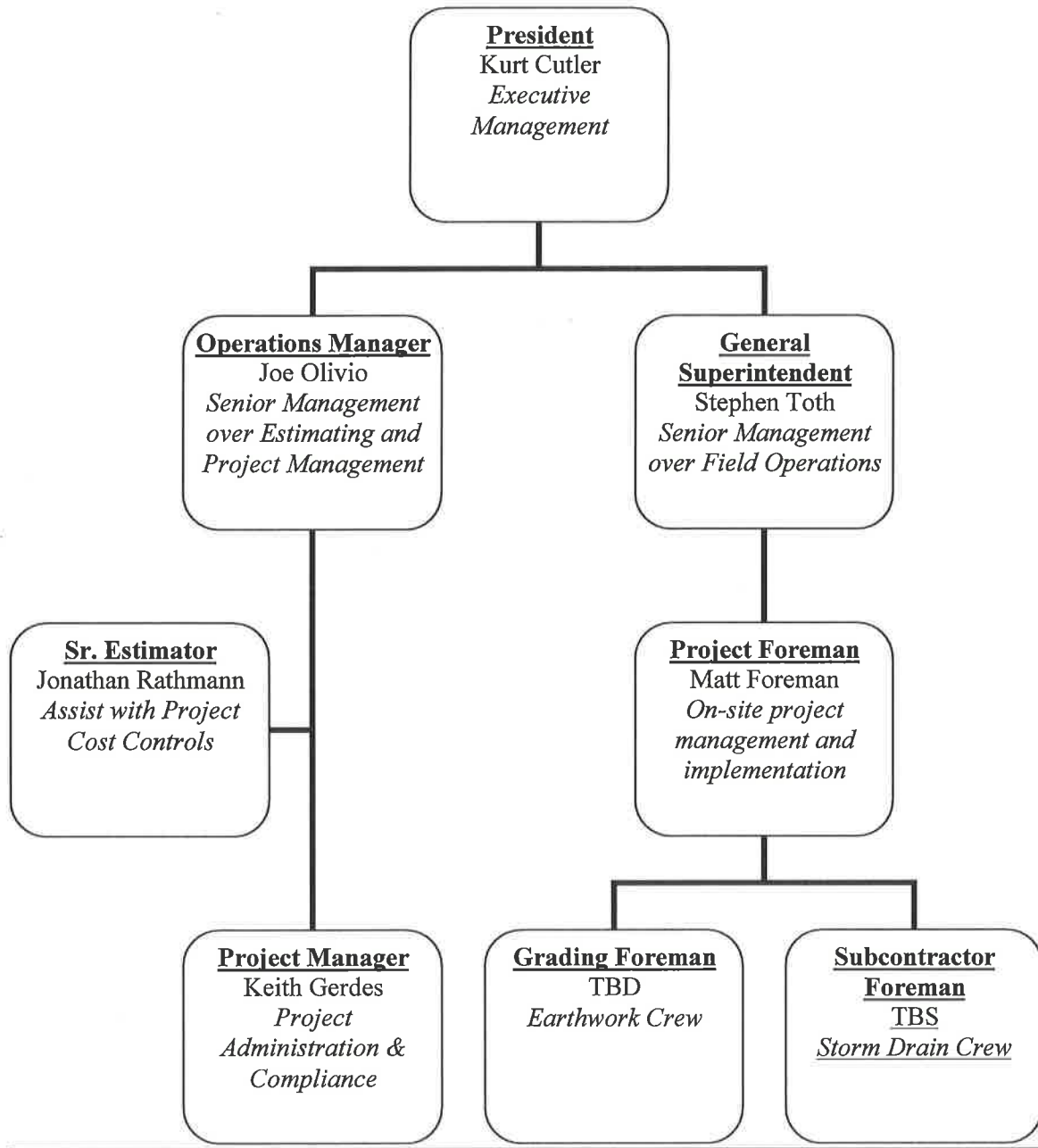

Statement of LEED Experience

Southern California Grading, Inc. (SCG) has been in the site clearing & earthwork business here in the State of California for more than 40 years. As the business of construction has evolved and changed over the decades, SCG has evolved and changed to meet the needs of our clients and the industry.

One of those changes has been by being actively engaged on construction projects that have LEED (Leadership in Energy & Environmental Design) goals and requirements. The scope of these projects range from New Construction to Expansion and Renovation projects, which have Site Clearing and Earthworks components to them.

The activities and components that impact SCG's typical scopes of work as they pertain to the LEED requirements include:

1) Site Clearing

- a. Green Waste disposal at a green waste recycler.
- b. PCC and AC hardscape disposal to a certified crusher/recycler.
- c. PCC and AC hardscape disposal on-site after being run through a mobile crusher, for re-use within the project limits.
- d. Metal (rebar, fencing, light poles, etc.) sent to a scrap metal recycler.

2) Earthworks

- a. Export: Export soils from projects very rarely gets "wasted". The majority of the soil we export from our projects is re-used by other construction projects when suitable, or if it is sent to a landfill and used to fulfill the requirement of "daily cover" over the trash. This allows the landfill to preserve virgin aggregates that would otherwise be needed to meet this need.
- b. Import: Import soil very often comes from other construction projects if it can meet the specifications of the project. The use of Recycled Aggregate Base material is often a viable alternative to aggregate based from virgin aggregate pits.

3) Equipment

- a. SCG maintains a fleet of Tier 3 and Tier 4 heavy construction equipment, in compliance with the mandates required by the State of California.

The chain of custody of these materials get documented through individual load tickets during the transportation of the material. In addition, at certified disposal/recycling

facilities, "weight" tickets are issued and submitted to the project Owner for their records and credit. This is handled through the project foreman and project manager.

The LEED projects in which SCG is involved, are typically from the roll as a subcontractor. We have performed work and continue to perform for multiple large General Contractors on projects all across Southern California. A few of the General Contractors in which we have been a subcontractor on project with LEED requirements include:

- McCarthy Construction
- Clark Construction
- Turner Construction
- Whiting-Turner Construction
- Swinerton Builders

The project team for SCG on this project is well versed in working with Owners and General Contractors to help meet the project's LEED goals. Meeting these goals has become second nature and is a component of the majority of the projects at Southern California Grading.
