

### **Statement of LEED Experience**

For over 21 years, Crew Inc. has been a dedicated partner in helping our customers produce developments that are as environmentally responsible as possible, as well as helping many clients achieve LEED certification recently—including but not limited to the Oxnard Advanced Water Purification Facility, the Learning Resource Center at Palomar Community College, and multiple projects for Chaffey Joint Union High School District (Etiwanda High School, and Oxnard High School).

Crew Inc.'s commitment to environmental stewardship affects three main areas of our operation: Site Clearing, Earth Moving (import/export), and Diesel Equipment Technology.

- (1) Demolition: Our scope of work often requires the demolition and/or removal of materials from a site before construction operations can take place. Crew Inc. is experienced in working with green waste recyclers for removal of vegetation, taking anything constructed of metal to a scrap metal recycler, hauling asphalt and concrete materials to certified crushers/recyclers, or mobilizing a portable on-site crusher when feasible to produce an aggregate product that can be re-used directly on the new development being constructed. When hauling materials from a site, the chain of custody of these materials get documented through load tickets during the trucking/hauling of these materials. Crew Inc. is also highly experienced in working with the SCAQMD to assure asbestos and other potentially hazardous materials are handled and disposed of in accordance with air quality regulations, and that water is utilized on site at all times to prevent dust particles from entering the atmosphere.
- (2) Earth Moving (import/export): Again, Crew Inc. utilizes water placement to minimize dust when performing our earthwork scope. Shaker plates ("track cleans") and other devices are used whenever possible to mitigate dust. When a project has excess soil that needs to be removed due to the project design, our first priority is to identify a project nearby that is in need of fill soil, and to do a short-haul to that development to minimize the amount of diesel trucking required to re-locate the material. If fill material is needed at a local land-fill to meet their environmental plan, we may haul the material there to help our local public agencies manage community waste in an environmentally sensible way.
- (3) Diesel Equipment Technology: In July 2007, the California Air Resources Board passed sweeping new regulations in the area of off-road diesel construction equipment. The

regulations were amended further in December 2011. Since the beginning, Crew Inc. has been an industry leader in complying with CARB regulations in the areas of reporting, limits on idling, replacing old Tier-0 machinery, re-powering T-0 machines with new, cleaner diesel engines, and purchasing new Tier-3, Interim Tier-4 and Final Tier-4 machines as they have become available to market. Because of our commitment in this area, we are proud to have been awarded multiple air quality grants that have allowed us to retrofit even more of our fleet with cleaner-burning diesel engines.
