# 7B. Approval of Recognized Obligation Payment Schedule

Assistant Finance Director Flewellyn stated that staff recommended that the Oversight Board adopt a resolution approving the Recognized Obligation Payment Schedule (ROPS) for the period of January 1 through June 30, 2014 in accordance with ABX1-26 and AB 1484.

Assistant Finance Director Flewellyn presented a brief history of all of the previous ROPS that had been presented to the Board and noted that this was the fifth ROPS to be presented. He explained that the ROPS was designated as ROPS 13-14B, as it represented the six month period of January through June 2014.

Assistant Finance Director Flewellyn noted that loans that had to be removed from the first ROPS had now been able to be added back to the ROPS as enforceable obligations, although with reduced interest rates.

Oversight Board for Successor Agency to City of Torrance Redevelopment Agency September 25, 2013 Assistant Finance Director Flewellyn stated that the supplemental material was aerial views of the development of the area at the American Honda site from 1965 to the present, which was a result of the City loans that appear on lines 20 through lines 36 of the ROPS.
