# City of Torrance Review of Agenda Item #6B for the Oversight Board Regular Meeting on August 15, 2012

The Successor Agency for the City of Torrance has requested that the Oversight Board review and approve the Recognized Obligation Payment Schedule (ROPS) for the period of January 2013 through June 2013 (see Agenda item #6B) on August 15, 2012.

This memo offers information and recommendations for Oversight Board members related to the agenda item listed above. This analysis is not a legal opinion.

Please note the Department of Finance has issued an updated ROPS template. It is suggested that the Oversight Board request the Successor Agency submit ROPS 3 as required by DOF, per Health and Safety Code (HSC) Section 34177 (a)(2) and should conform to the instructions recently posted on the DOF website <a href="http://www.dof.ca.gov/assembly\_bills\_26-27/view.php">http://www.dof.ca.gov/assembly\_bills\_26-27/view.php</a>). The ROPS submitted is missing a few execution dates for the Bond Administration Fees (items #4, 5) and American Honda Interest (Industrial) (item #8).
