He stated that after the DOF issued the determination letter, then the City could file for a finding of completion. He noted that the City would quickly file for the finding of completion, because receiving the finding would allow the discussion of placing the eligible obligation City loans back on the ROPS.

- April 1: DOF determination letter was due from the DOF

Assistant to the City Manager Sunshine recommended that the Board meet on February 20 to discuss and approve ROPS 4.
