RECOMMENDATION

The Public Works Director recommends that the Traffic Commission collect public input and approve the installation of centerline traffic striping on Calle de Arboles from Via Alameda to Via Colusa.

BACKGROUND

Beginning in June 2020, staff received requests from residents of Calle de Arboles between Via Alameda and Via Pasqual to implement measures to reduce vehicle speeds in this portion of the street. A virtual public meeting was conducted with residents on November 19, 2020. At this meeting, representatives from the City's Police, Fire and Public Works Departments were present as well as members of the City Manager's Office. The Police Department indicated they could perform spot checks for speed enforcement as staffing would permit. Speed humps were discussed and staff explained that speed humps are not used in the City of Torrance due to their impact on emergency response times. Public Works Department staff suggested installation of a centerline stripe as a method of calming traffic by constraining traffic into the delineated lane as has been used elsewhere in the City and the group agreed to move ahead with this alternative. The portion from Via Alameda to Via Colusa (Approximately 2600 feet in length) was selected for the centerline striping. On February 16, 2021, Public Works crews started placing the centerline striping. Beginning February 17, 2021 several residents called the City to object to the proposed centerline striping. Installation efforts were stopped pending public discussion of the proposed striping at Traffic Commission. Only faint layout markings have been placed. No striping has been completed at this time. Speed limit signs (25 mph) were installed on existing posts during the last two weeks.

ANALYSIS

Calle de Arboles between Via Alameda is a local street serving single family residential properties in southwest Torrance (see Attachment 1). All-way stop signs exist at Via Alameda, Via Pasqual and Via Colusa (see Attachment 2). The roadway is 34-feet-wide and equipped with rolled curbs and gutters. The speed limit is 25 miles-per-hour and was unposted until the new speed limit signs were recently installed. Parking is permitted on both sides of the roadway. Sidewalks exist at only a few addresses. The roadway alignment is straight and the roadway grade slopes gradually to a low point approximately 300 feet west of Via Pasqual which enhances driver visibility. Presently there is no centerline striping within this segment of Calle de Arboles. Drivers use the full width of the roadway unless an oncoming vehicle is encountered.

In July and November 2020, City staff took traffic counts on Calle de Arboles. On July 1,

2020, the data was collected at the intersection of Via Pasqual and Calle de Arboles from 8:00 AM to 9:00 AM and from 4:00 PM to 5:00 PM. Total daily traffic on Calle de Arboles is estimated to be 650 vehicles. Eastbound traffic is dominant in the AM period and westbound traffic is dominant in the PM period. Overall traffic volumes are greatest in the PM period. While investigating, staff observed vehicles that appeared to be exceeding the 25 miles per hour speed limit, however, radar equipment was not used to make these observations.

Staff believes that the excellent visibility provided by the street grade and the lack of traffic delineation allows drivers to feel comfortable driving at higher speeds. Staff recommends placement of a centerline stripe to constrain traffic between the stripe and parked vehicles which would result in lower vehicle speeds (see Attachment 3).

Centerline striping is used on several streets in the neighborhood (see Attachment 4). The portion of Calle de Arboles west of the Via Alameda is equipped with centerline striping (see Attachment 5).

Staff reviewed the collision data for Calle de Arboles between Via Alameda and Via Colusa. There were three reported collisions on Calle de Arboles between Via Alameda and Via Colusa in the five-year period from 2015 to 2019, inclusive. They were all related to improper turning violations.

A public notice (Attachment 6) was mailed to 89 parcels notifying residents of tonight's meeting. The public notification area is shown in Attachment 7. Written comments received prior to posting of the agenda are provided as Attachment 8.

It is recommended that the Traffic Commission collect public input and approve the proposed centerline striping on Calle de Arboles from Via Alameda and Via Colusa.







Councilmember Mattucci,

We have a very dire situation on Calle de Arboles in the upper Riviera. With it being a wide street and a main thoroughfare through the neighborhood it is not uncommon to see vehicles traveling 40+ miles per hour. The pandemic has only exacerbated this problem. More people are out walking (elderly citizens and families included) and I have noticed an increase of delivery drivers (DoorDash, Uber eats, Amazon contract delivery drivers, etc) who not only drive well beyond the speed limit but are also on their mobile devices. I live on the Redondo side where it's more perilous as we do not have sidewalks or streetlights.

At home, I am the father of a 2 year old and the husband of a pregnant wife so you can naturally see my concern. Professionally, I am a firefighter/paramedic of 15 years. I have seen the ramifications of an auto vs pedestrian accident time and time again and I believe you would be just as mortified as I would be knowing someone was hurt or killed in our neighborhood as a result of being struck by a vehicle. I can say without reservation that this is a real concern.

My neighbor Bill Slutter has been corresponding with Councilmember Goodrich regarding installation of speed humps. Without question, this will provide for safer streets. I have heard there was a concern over Torrance Fire Departments response times and if that is the case, this is what I will offer: I am currently a fire apparatus operator and have been for 7 years. There is no excuse for an emergency responder to drive in speeds in excess of 25 mph in a residential neighborhood. You do not risk creating an additional emergency in attempts to mitigate another. If an emergency vehicle traveled from Paseo de Las Tortugas to Paseo de las Reyes it is approximately 1.5 miles. The response time with the addition of 15mph speed humps would slow the response time by mere seconds.

As the head of the transportation committee I think this deserves your attention. I thank you for you consideration sir. I hope we can address this problem expeditiously as it's only a matter of time before something tragic happens.

Dear Steve, and traffic commissioners,

In preparation for the Zoom meeting on March 1 at 7pm, I wanted you to be aware of all the residents on Calle De Arboles that have signed a petition against this project. There are 86 homes on Calle De Arboles in the proposed stretch of the striping project. The petition contains the signatures of 30 of those home owners, all of whom feel very strongly against doing this project. We obviously were not able to meet with every residence on the street, so the actual number of opponents to this project is likely even higher.

Aside for the reasons that are already stated in this petition, there is one more reason against striping that I wanted to bring up.

Calle De Arboles, (in the proposed stretch of the street were the work is contemplated) has no sidewalks and is only 33 ft from curb to curb. There is also parking on both sides of the street, which we, as residents of the street, enjoy and would never want to give up. By introducing striping, we are taking a street that is 33 ft wide, and after you subtract 16 ft (8 ft on either side, used for parking), you have approximately 16 to 17 ft of drivable street space, which when divided into two, makes each drivable lane only 8 to 8.5 ft. That is <u>very narrow and provides a significant risk to pedestrians</u>, who have no other alternative than walking on the street itself since there are no sidewalks.

I am also including some internet articles that have arguments against street striping. I am sure that there are many situations where striping is acceptable and potentially accomplishes the intended purpose, we just don't believe that is the case for Calle De Arboles. We would like to explore other options for slowing vehicular traffic.

Please let me know how public notification of the 3/1/21 7pm Zoom meeting is being handled. Most of the residents of the section of Calle de Arboles were caught by surprise regarding this project as it was never announced, and we would like all concerned residents to have the opportunity to be present on the meeting.

I realize that the city of Torrance is doing their best to make everyone happy and we appreciate that. Our goal is to make sure that our position is also heard, and other options are explored.

I would appreciate it if you would email back verification of receipt of this email, and also forward it to the appropriate traffic commissioners in advance of the Zoom meeting.

My name is Justin Scarpetti. I live in the Riviera on Calle de Arboles. I believe you have spoken with my neighbor, Bill Slutter, in the past (maybe a few months ago).

I am reaching out today because, unfortunately, the speeding has not gotten any better. I woke up Saturday at 4am after having a nightmare of my kid getting hit by a car. I figured that it had to be a sign we need to keep pressing on the issue. So I am emailing you today hoping we can get the ball rolling again, I also emailed many of my neighbors this morning giving them a heads up so you may hear from some of them as well. Here goes my plee...

I grew up on Calle de Arboles. I have lived here since I was 10 years old. I moved away for a few years during college and then got married but shortly after my wife and I were blessed with a once in a lifetime opportunity to move back to the street, next to my parents, and we couldn't have been happier. Everything about this street is amazing, except for the speeders.

I don't own a radar gun but I truly believe some people drive 60+ down our street. From beaters, to Mini Coopers, to lifted trucks... several times a day someone just flies down the street like they are on a freeway. I work from home so I witness it all day long. I am also right in the middle of the block, so I catch them at their fastest. I believe our speed limit is technically a 20mph zone (not 25mph) because we do NOT have sidewalks on a lot of the street.

On just our block alone I believe there are 20 kids under the age of 10 years old... I have a 3 year old and a 9 month old. My dad, who lives right next to me, is in a wheelchair and does not have the mobility like most people do. It would be catastrophic if he was getting in/out of his ramp van at the wrong time while someone was speeding and clipped him. I have kids run into the street multiple times to get a toy. My heart starts racing anytime I just see a kid playing in their front yard.

We have families with kids (myself included), elderly people, couples, dog walkers, etc... really anyone who just wants to go on a walk is forced to walk in the street since we do not have sidewalks. It is also scarier at night/dusk since we do not have street lights either.

Good afternoon Councilman Goodrich and Councilman Mattucci,

I hope the new year finds you healthy and well. I write to you as follow up to the dangerous situation we have on Calle De Arboles. My husband, Brett Pearson, along with many of our neighbors have contacted council members and Torrance Police Department regarding vehicles traveling in excess of 25 mph.

On October 26, 2020 my husband emailed both Councilman Goodrich and Councilman Mattucci.

Following the email exchanges, a community virtual meeting on November 19, 2020 was held to discuss the dire situation.

The virtual meeting proved to be a "listening session" and since, no action to remedy the very unsafe environment has been observed. We continue to experience unsafe speeds and have personally had a near miss of being struck by a vehicle. I have a near 2 month old and 2 year old who I no longer feel safe walking in my own neighborhood with.

I respectfully am asking for you, and or the appropriate parties, to provide an outline of the steps taken since bringing this to your attention last year and what next steps we may expect to enforce speed limits, slow vehicles and create a safe community.

We and our neighbors are desperately willing to join efforts with you to create the safe neighborhood our children deserve. I look forward to your timely response.

I am writing regarding the notice of traffic commission meeting being held on Monday, March at 7:00 pm for the proposed centerline striping on Calle de Arboles.

I have been a home owner in this area for the last 15 years. I purchased the \$2.1m home for it's appeal in having no street lights, yellow striping on the roads and speed limit signs.

Additionally, I feel in love with the quiet neighborhood in which most of my neighbors have lived here for generations. Everyone is cautious and looks after their neighbor.

Looking out for each other entails being aware of your neighbors as they ride their bikes, or walk their dogs, jog, etc. while driving. It is called being courteous.

Adding yellow centerline striping is not the answer to a very few that might break the speed limit. In fact, I strongly believe it will compound the problem. It will look like a drag strip and increase speeds of drivers.

The city streets I drive each day to and from work have yellow striping with speed limit signs and everyone is speeding. Just tonight people were passing me at speeds > 50 mph on PCH. My point speed limit signs and yellow striping is not the solution.

If the concern is a child walking into the street, yellow centerline striping will not rectify this problem. I suggest adding a fence or keeping your children in the backyard.

I strongly oppose the proposition to add the yellow centerline striping and speed limit signs on Calle de Arboles, I did not move into this neighborhood to look out my window to find a street with yellow striping and speed limit signs placed in our well maintained yards.
