He noted a Caltrans permit was secured in March 2020, a contract awarded, and construction scheduled to begin in February 2021. However, before construction began, members of the public raised concerns about the removal of the ficus tree in the median. He added that removal of the median would double the lane capacity from seven to 13 vehicles. He presented staff's recommendation to take public input related to the westbound left-turn lane extension and removal of the median and tree on Pacific Coast Highway between Palos Verdes Boulevard and Camino de las Colinas.

Commissioner Obejas and Chairperson Thomas spoke.

Members of the pubic spoke.

At 7:54 p.m., Chairperson Thomas closed the public hearing.

Chairperson Thomas received clarification that staff would need to submit a new permit to Caltrans if the proposal is changed.

RECOMMENDATION

The Public Works Director recommends that the Traffic Commission approve installation of yellow centerline traffic striping on Calle de Arboles from Via Alameda to Via Colusa on a trial basis.

BACKGROUND

In 2020, staff has received requests from residents of Calle de Arboles between Via Alameda and Via Pasqual to implement measures to reduce vehicle speeds on this segment of roadway.

On November 19, 2020, a virtual public meeting was conducted with residents and representatives from various City departments and installation of a centerline stripe was suggested to constrain traffic into a delineated lane as a calming measure. The portion from Via Alameda to Via Colusa (approximately 2600 feet in length) was selected for the centerline striping. On February 16, 2021, Public Works crews started placing the centerline striping after which several residents called the City objecting to the proposed centerline striping. Installation efforts were stopped pending public discussion at the Traffic Commission. Only faint layout markings have been placed along street centerline. No striping has been completed at this time.

On March 1, 2021, staff recommended that the Traffic Commission take public input and recommended that the Commission approve installation of the centerline striping. At the meeting, the majority of the residents who spoke did not support the proposed centerline striping. The Traffic Commission took no action on this item and directed staff to bring the issue back to the Commission for further discussion at the May 3, 2021 Traffic Commission meeting.

ANALYSIS

Staff recommends that the Traffic Commission approve a trial installation of centerline striping along Calle de Arboles for approximately one year. Doing so would provide staff and the neighborhood time to evaluate the efficacy of the centerline striping. Staff would return to the

Traffic Commission in 2022 to determine if the striping should remain in place or be removed. The City plans to slurry seal Calle de Arboles in 2022 and the striping could be removed at that time.






Attachment 1: Location Map
