Health Effects in Pets

- Pets exposed to secondhand smoke are at higher risk for cancer and other illnesses
- ► Can develop skin allergies and asthma
- Pets that ingest cigarettes can suffer from stomach and nerve problems

Secondhand Smoke in MUH

- A recent public intercept survey found:
 - ▶ 43% of Torrance residents living in multi-unit housing surveyed in 2020 reported having secondhand smoke drift into their home in the last year
 - ➤ Of these, **38**% of Torrance respondents or someone they live with have a medical condition that worsens due to exposure to SHS smoke
 - ▶ If given the option, **90**% of Torrance residents would choose to live in a completely non-smoking building, based on a 2020 Public Opinion Survey

Impact on Vulnerable Populations Families, Children, & Adults 65+

- ► Over two-thirds (68.6%) of all Torrance households are families, and about a third (33.1%) live with children under the age of 18
- ▶ 9.1% of households living alone who is 65 or older
- Per U.S. Census, 44.1% of all Torrance residents are also renters
 many of whom are directly at risk of being affected by secondhand or thirdhand smoke

Impact on Vulnerable Populations Uninsured People & Persons with Disabilities

- ▶ 4.9% of Torrance residents under age 65 have a disability
- Secondhand smoke can exacerbate existing medical conditions/disabilities
- ▶ 5.5% of all Torrance residents lack health insurance
- For those without health insurance, the medical consequences of secondhand or thirdhand smoke are even more serious



Smoke-Free Multi-Unit Housing

The U.S. Surgeon General has concluded:

Separating smokers from nonsmokers, opening windows, or using air filters does not prevent people from breathing SHS

What is a Smoke-Free Multi-Unit Housing Policy?

A law that limits or prohibits smoking in and around multi-family housing, including the establishment of non-smoking units and non-smoking common areas



What is a Smoke-Free Multi-Unit Housing (MUH) Policy?

A comprehensive MUH policy:

- Prohibits smoking in 100% of individual units, including balconies and patios
- Prohibits smoking in indoor common areas and outdoor areas (e.g., hallways, laundry rooms, pool areas, patios, play areas, etc.)
- Smoking includes tobacco, cannabis, and electronic smoking devices (ESD's)

Benefits of Smoke-Free Multi-Unit Housing Policies

- Protects nonsmokers from exposure to secondhand smoke
- ▶ Reduces risk for heart disease and lung cancer among nonsmokers
- ► Lowers smoking rates among youth and young adults
 - ► Lowers visibility of role models who smoke
 - ► Fewer opportunities to smoke alone or with others
 - Diminished social acceptability and social advantage for smoking
- Minimizes fire risk
- Provides economic benefits to landlords
- Improves overall quality of life

Smoke-Free Multi-Unit Housing Policies Manhattan Beach

- ► In May 2017, the City of Manhattan Beach partnered with the Beach Cities Health District to enact a smoke-free multi-unit housing policy
- ► All multi-unit housing with **3 or more units** in Manhattan Beach is **smoke-free**, and **non-smoking signage is posted** to notify tenants that the properties are non-smoking
- ► The law prohibits smoking both **indoors and outdoors of multi-unit properties**, excluding hotels
- The law includes e-cigarettes and does not allow for any designated smoking areas
