SUBJECT: REVIEW OF ALLOCATED PICKLEBALL HOURS AND LOCATIONS

BACKGROUND/ANALYSIS

At the June 9, 2021, Commission Meeting staff presented an item for signage approval for group open play pickelball hours at Sur La Brea Park. Since that time, interest for expanding locations and hours has increased. Currently, three parks offer shared court hours between tennis and pickleball: Sur La Brea Park, Walteria Park, and Wilson Park. Walteria Park currently offers senior programs, Wilson Park, and Sur La Brea Park offers group play.

While there has been overall cooperation regarding court usage between both pickleball and tennis users, there were concerns raised at the previous meeting regarding allotted time for pickleball. Due to this feedback, Park and Recreation staff have created a breakdown of locations and hours (see attachment A).

RECOMMENDATION

In order to alleviate future concerns, to encourage residents to continue participating in both pickleball and tennis, and to promote the City of Torrance as a central advocator for this both sports; it is the recommendation of the Community Services Director that the Commission host the discussion, gather feedback for review, and provide direction on potential actions.

Under lockdown, Americans of all ages have been spicing things up with a fun new pastime.

Lara Marmelstein had been a highly ranked (5.0) tennis player for more than 30 years when a buddy introduced her to a new racquet sport with a silly name: pickleball. The 54-year-old nurse from San Juan Capistrano was instantly hooked.

"I love, love, love, love pickleball!" Marmelstein gushes. "I love it so much that I gave up tennis I look forward to playing pickleball until I'm 100."


She means that literally. With its compact court and low-force volleys, pickleball is senior-friendly and uniquely well-suited for intergenerational play.

"There's less emphasis on running than in tennis. You can sort of hop over to one side or the other. That's why older people and children can play," says Marmelstein, who took up pickleball in 2015.

She had no trouble selling her 85-year-old mother, Mary Lou McCauley, and sister Kelley Mayeda on the sport. The fever quickly spread to Mayeda's adult sons, Mac and Jacob, and Marmelstein's own adult children, Mitchel and McKenna. Another sister, Marlo Blandford, and brother-in-law Johnny have since embraced the family pastime.

Marmelstein, who worked at Torrance Memorial for a decade before moving to Orange County in 2000, returns to the South Bay every week. By long-standing tradition, she and her siblings, their spouses and offspring gather on Thursdays at mom's house in Redondo Beach for "family night." Then bright and early Friday morning, these self-described "pickleheads" take to the courts at Manhattan Heights Park or Hermosa Beach.

"It's such a neat thing that I can play with my 85-year-old mom and my 30-year-old nephew. I could never do that in tennis," says Marmelstein, who plays pickleball five times a week. Her skill-level rating is 4.5 on a scale of 6. Pro level starts at 5.5.

Marmelstein's three-generation, pickleball-loving family is part of a trend sweeping the nation. According to the Sports & Fitness Industry Association, pickleball grew to 4.2 million players in 2020—up from 3.5 million in 2019. That's just in the United States. Forty-eight other member countries belong to the International Federation of Pickleball, which aims to take the sport to the Olympics.

Already one of the fastest-growing sports before the pandemic, pickleball exploded in popularity as rec centers, health clubs and public parks closed for much of the year. "You can play pickleball anywhere, really. People play in their cul-de-sacs. That's what we did throughout COVID-19," Marmelstein says.

All you need is a 20-by-44-foot paved surface, sidewalk chalk, a portable net, paddles and the sport's signature plastic ball resembling Swiss cheese. (A starter kit of four paddles, balls and net will set you back about \$100.)

Combining elements from badminton, tennis and ping-pong, pickleball is played on a badminton-sized court (or one-quarter of a tennis court) using a net that is near tennis height.



"It's super easy to learn," says pickleball enthusiast Steve Taylor, 53. "A single lesson is enough to start you playing." Taylor's sport of choice before he got bitten by the pickleball bug had been volleyball—but he's an outlier. Four of five pickleball players come from tennis or other racquet sports, he says.

A professional videographer, Taylor discovered the game while filming content for the Pickleball Channel on YouTube in 2015. Since then, pickleball has taken over his professional and personal life. Now nearly all his clients are pickleball organizations. "The sport is blowing up. Everybody needs photos and video," he says.

When he isn't shooting tournaments, pro tours or feature articles for Pickleball Magazine, Taylor is usually swinging a paddle. He plays six days a week, three to five hours a day, across the South Bay and Orange County. He also teaches private and group lessons on various local courts. "I'm just heavily addicted," he says, laughing.

What makes pickleball so addictive? "The secret sauce—and the reason the intergenerational stuff works—is because pickleball is very easy to learn, very easy to play and it's super social," Taylor says.

The social aspects are baked in. The small court size encourages chit-chat between partners and opponents. A single-match rule in drop-in open play promotes ever-changing player combinations because a new foursome takes the court after each set. A paddle queuing system keeps track of who's up next. If you show up alone, your paddle is randomly paired with another in the queue, sparking new friendships.

"That's what makes pickleball so great. I love all the people I get to interact with," Taylor says.



Pickleball Pros

Don't be fooled by pickleball's ease of play. As one grows into the sport, strategy and technique become crucial—which is why hard-bitten competitors like Marmelstein and Taylor can never get enough.

"If you play it well, you're moving all the time," says Marmelstein. "It's exhausting. Just watch some pro videos and see how fast and accurate and athletic they are—what amazing hands they have!"

The sport currently has three major tournaments: Margaritaville USA Pickleball Nationals at Indian Wells, California; the US Open in Naples, Florida; and the Tournament of Champions in Brigham City, Utah. Two pro tours—one with 18 stops, another with 12—pay purses up to \$125,000, and top players clear more than \$200,000 a year between winnings, brand sponsorships and clinics. Level Up, one of the sport's premiere academies, runs three-day training camps in 90 cities.

Tournament age brackets go from preteens to seniors. One of the world's top pro players is 14-year-old Anna Leigh Waters of Delray Beach, Florida.

Pickleball History

Pickleball was invented in 1965 by Joel Pritchard, a six-term U.S. congressman from Seattle, at his vacation home on Bainbridge Island, Washington. He and two other dads created the sport as a way to entertain their kids who complained of having "nothing to do."

According to the Pickleball Hall of Fame, the sport was possibly named for the Pritchard family dog, Pickles, who absconded with stray whiffle balls. By another account, the name was coined by Pritchard's wife, Joan. The mash-up of three racquet/paddle sports reminded her of "pickle boats" in crew, where oarsmen are chosen from the leftovers of other boats.

PARKS / FACILITIES

The Projects/mowing Crews:

- Assisted the Landscape and Maintenance Crews with summer maintenance.
- Removed and replaced concrete slabs at the east picnic area at Wilson Park.
- Installed a new park sign at La Romeria Park.
- Repaired a hole in the fence at the east end of Torrance Park and the north east side of Walteria Park.
- Installed a concrete slab and drinking fountain at Miramar Park.
- Installed 50' of new fencing at Del Amo Blvd and Wayne Avenue to assist Public Works.
- Delivered bleachers and assisted with parking lot clean up for a special event at Columbia Park.
- Continued mowing route now at 11-14 day cycle due to staffing and the speed the grass is growing

The Landscape Team:

- Completed installation of the fruit tree bubbler irrigation at Lago Seco Park.

The following is information regarding Recreation Division programs and facilities for August 2021:

YOUTH SPORTS / AQUATICS / EARLY CHILDHOOD EDUCATION – Allison Saufua, Acting Sr. Recreation Supervisor; Patti Goldenson, Recreation Supervisor; Kim Hibbard, Aquatics Program Coordinator

Aquatics:

- Summer programming at the Plunge has safely concluded with fall classes beginning the week of September 5.
- The drop-in lap swim accounted for 2,364 pool visits.
- The drop-in recreation swim accounted for 540 pool visits.
- Long-term pool rental, Swim Torrance, returned to the Plunge on August 30 with 78 pool visits.
- Long-term pool rental LAPS (Los Angeles Peninsula Swimmers) Master's Swim Team accounted for 676 pool visits.

Early Childhood Education (ECE):

• ECE is not in session this summer and will return in September 2021.

Youth Sports:

- The Summer Volleyball season concluded on Saturday August 21, 2021.
- 188 volleyball players participated in the program for 4th 8th graders.
- The season went great and we had positive response with everyone following the indoor mask mandate
- Flag Football is scheduled to begin in September, and registration is ongoing.

ADULT SPORTS / SEA-AIRE GOLF COURSE – Garrett Craig, Recreation Services Manager

Adult Sports:

- The Adult Softball Program concluded the Summer Season with 96 teams participating. Adult Softball Fall registration is currently open, with last registration on September 7, 2021.
- Our Summer Adult Basketball leagues concluded their season with 54 teams participating. Players and positive feedback for our new 6'2" & under league on Monday nights.
- Adult Roller Hockey leagues have returned to the rink Monday-Saturday. On Sundays, the rink also stays busy with private rentals.

• With summer now in full swing, The Toyota Sports Complex has soccer groups out on the fields almost every day of the week.

Sea-Aire Golf Course:

- The Sea-Aire Summer golf season started winding down in August with another record number of golf rounds played. Total rounds played in August were 3,795.
- Staff is finishing preparations for the annual *Sea-Aire* Labor Day junior golf challenge that is set for September 6th.
- The Friday morning Seniors golf club had a three player team golf tournament on august 13th.
- The Thursday morning Women's golf club had a running three-week golf score individual golf tournament.
- Patrons are happy with the new better quality green flags that were purchased in August.
- With the shorter late summer daylight hours the new last tee-off time is now earlier set at 5:30 p.m.

AFTER SCHOOL CLUB / DAY CAMPS / PARKS GRAB AND GO CRAFT PROGRAM/ ADAPTIVE PROGRAMS / SPECIAL EVENTS – Suzie Wand, Senior Recreation Supervisor; Nicole Madera, Acting Recreation Supervisor; Charlene Walker, Program Coordinator

After School Club Program:

- The program began on August 26 at 8 elementary and three middle school sites.
- The program was not able to begin on August 26 at four of our typical school sites. Bert Lynn, Casimir, Hull and Magruder had low enrollment numbers and this, coupled with a severe staffing shortage, caused us to pause the start of the program. It is hoped that enrollment numbers will grow and new staff will be hired on shortly.
- Parents were notified of the delay at the sites noted above and we will continue to monitor enrollment numbers and try to recruit new staff.
- The sites that are up and running have great enrollment numbers. Most are full and have waiting lists.
- The program follows guidelines set forth by the L.A. County Department of Public Health.

Parks Grab & Go Craft Program:

- The program which offered free craft kits at three parks during the week, concluded on August 12.
- Staff advertised the program on social media as well as utilizing a large pop-up tent with a banner to draw attention. Information was also shared with Camp Torrance participants and parents.

Camp Torrance:

- Camp Torrance concluded on August 13. All nine weeks were filled to capacity and it was a great success.
- Numerous parent surveys were received with excellent overall satisfaction ratings. Many staff were specifically named and praised for their care and performance at the program.

Carpenter Wagon:

• The Carpenter Wagon program concluded on August 4 at Walteria Park. Attendance was at its maximum and patrons enjoyed the wood projects created.

- During the final three weeks of the five-week program, painting of the kits resumed and the participants were very excited to add this feature to their projects.
- Very special thanks to our partner, Home Depot, for providing the woodcraft kits and orange aprons each year!

Adaptive Recreation:

- Volunteer count for August concluded at seven (7) with a total of 31 hours.
- Virtual programming continues via Zoom for *PALS* (*People Actively Learning and Sharing*) members. An average of 15 20 members attend each activity.
- A Beach Walk was held on August 23, which was a big hit! PALS members enjoyed a long walk and a beautiful sunset.
- The Summer Basketball Clinic concluded on Sunday, August 29. Certificates were presented to all athletes who participated in the program. The program, attended by an average of 27 athletes each week, was a huge success!
- Bocce Ball is offered on Friday evenings at Columbia Park with average attendance of 20 participants. Special thanks to the South Bay Bocce Club for their support; members of the Club come out to play bocce with PALS members once a month.

Special Events:

A Family Movie in the Park took place at Greenwood Park on Saturday, August 28. An approximate 175 were on hand to view Disney Pixar's Onward under the stars! Feedback received on the surveys was very positive, with the overwhelming majority giving an excellent overall satisfaction rating.

THE ATTIC Teen Center:

- THE ATTIC continued its summer hours though the month of August 2021, opening Monday-Thursday 12pm-3pm. Members were able to participate in socially distant physical fitness classes every Monday, enjoy a movie and snacks on Tuesdays, join outdoor games and crafts on Wednesdays, and learn various life skills on Thursday. THE ATTIC averaged four (4) participants a day.
- The Zoom Lunch Room program met twice a week every Monday and Thursday from 11:00am-11:45am. Students had time to share, chat, and play games together online. These programs averaged five (5) participants per meeting.
- Staff continued to make wellness calls to participating members.

ATTIC Advisory Committee:

• There was no regular meeting this month. Applications were due on July 26, 2021.

S.P.I.N. (Serving People in Need): (Not currently meeting)

Co-Rec (Co-Recreation):

There were no virtual or in-person programming for July and August. Programming will resume September 24.

Babysitting Preparedness Course: The second Babysitting Preparedness class was offered during the week of July 12, with full participants enrolled. The class met Monday – Thursday

from 10:00am to 2:00pm. Participants learned how to plan for a babysitting job, what to expect from children of all ages, how to select toys/ projects and how to plan fun recreational activities. Participants also learned about the safety issues surrounding babysitting, possible hazards and were trained in CPR. Participants finished the course with a walking field trip to the Civic Center Library, where they learned about appropriate reading content for different age levels.
