7B. Presentation – James Lee: Administration Manager: Transit Department (considered out of order)

Transit Administration Manager Lee presented an overview of the Transit Department, which was established in January 1940, and discussed the routes and services, the number of divisions and employees. He added that the Department was now an 100% alternative fuel fleet. He noted that electrical buses, purchased through grant awards, were now being added to the fleet. He discussed the service available through the Senior Taxi Program and added that the Department was investigating additional options.

Transit Administration Manager Lee discussed areas of improvements that the Department was exploring. He stated that department had completed a depot at the Del Amo Mall, launched the Line 13 Artesia Corridor in June 2021 and had been named as California's 2019 Transit Agency of the Year. He discussed some upcoming projects: the completion of the Torrance Transit Park and Ride Regional Terminal, the extension of Line 10 to SoFi Stadium, the Torrance Rubber Wheel Trolley and types of microtransit.
