Application for approval of a Business License to allow the operation of a restaurant serving alcohol

Mr. Sanford Sarconi, general manager of Islands Restaurant, LLC confirmed his application for a business license to allow the operation of a restaurant serving alcohol, located at 2647 Pacific Coast Highway in Torrance, and verified that he had met with the Police Department and understood the rules and regulations pertaining to this type of business.

License Supervisor Bittner noted that the name had only been updated on the California Department of Alcoholic Beverage Control license, as shown in Item 7A Supplemental 1, but had not been updated for the Los Angeles County Health permit.

MOTION: Member Botiller moved to approve Item 7A, the application for a business license to allow the operation of a restaurant serving alcohol to Islands Restaurant, LLC dba Islands Fine Burgers & Drinks, located at 2647 Pacific Coast Highway in Torrance with the conditions that the applicant provide a copy of their amended Los Angeles County Health permit to the City to the Finance Department and with the conditions as set forth by California Department of Alcoholic Beverage Control. Responding to questions from City Attorney Sullivan, Mr. Sample confirmed that: he was responsible for all activities that occurred at the business, whether he was present on site or not, including the activities of the employees, that he or any employees providing massages would need to be licensed by the California Massage Therapy Council, that he needed to maintain an up-to-date list of his employees with the Finance Department and inform the Finance Department if he hired any employees or let any employees go and that if he or any of his employees performed any illegal or illicit acts, in violation of California Penal Code, California Health and Safety Code or the Torrance Municipal Code or any other laws, he could be held responsible, he could have his business license suspended or revoked and if he or an employee violated the California Penal Code, the California Health and Safety Codes or the Torrance Municipal Code or any other laws, he could also be prosecuted in a criminal court of law.

License Review Board Hearing – September 16, 2021

On 08 SEP 2021, I interviewed Mr. Gutierrez regarding his application for a business license for "Gutierrez Bodyworks and Massage," 19800 Hawthorne Blvd; #208, Studio 116, in the City of Torrance.

Mr. Gutierrez is opening a new business at the location and is the sole owner. Mr. Gutierrez has worked in the massage industry for about 5 years, previously working at the Hide's Shiatsu Massage (2396 Crenshaw, Torrance, CA) for approximately 2 years. He also does independent on-call massage for his clients. This will be Mr. Gutierrez' first business. The business will be providing body massage by appointment and "walk-in" type customers.

Mr. Gutierrez is a certified massage therapist (CAMTC #72442, Expiration Date 1-18-23). Mr. Gutierrez will be the sole worker at the location and will be responsible for bookkeeping and reception for his clients.

An inspection of the establishment (specific to the concerns of law enforcement) was met as required by TMC Section 35.14.080 and 35.14.090.

It should be noted that Mr. Gutierrez is renting a studio at Phenix Salon Suites. Phenix rents out approximately 40 separate individual studio spaces to health/beauty practitioners. There is one main entrance for Phenix Salon Suites and then each studio has its own lockable entrance within the main complex. At the time of my inspection the main entry door for the Phenix complex was locked and the initial reception was not staffed. The sign advised customers to call their individual service provider for entry. I spoke to Mr. Gutierrez about the requirement that the entry/exit doors remain unlocked during his business hours. Mr. Gutierrez explained that the main reception is typically staffed and the door is unlocked during regular business hours. I reminded Mr. Gutierrez that it must remain unlocked while he is operating his business at the location.

Mr. Gutierrez was advised of the laws regulating his occupation, and he was provided with a "Torrance Municipal Section Highlights" form, which detailed these laws and regulations. I completed a Massage Establishment Licensing Interview Questionnaire with him which he signed indicating that he understood the laws regulating this occupation. Mr. Gutierrez was advised to strictly adhere to record keeping and hours of operation, as well as all the other rules and regulations that apply to the massage business.

Closed cabinets shall be utilized for the storage of clean linen. All massage tables will be covered with a clean sheet or other clean covering for each patron. After use, each covering will be deposited in a closed receptacle and not used until properly sanitized in the immersion of water at least 140 degrees Fahrenheit for not less than 15 minutes. 

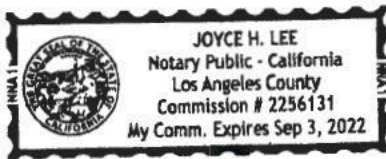

(c) It is improper advertising as provided in Section 4955 of the code to disseminate any advertising of a practice, technique or procedure which is not within the scope of the practice of acupuncture as defined in Section 4927 and 4937 of the code and which is the unlawful practice of medicine.

1399.456. Use of the Title "Doctor."

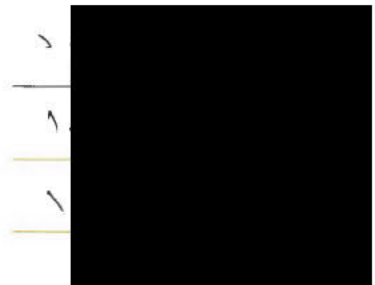
It is unprofessional conduct for an acupuncturist to use the title "Doctor" or the abbreviation "Dr." in connection with the practice of acupuncture unless he or she possesses a license or certificate which authorizes such use or possesses an earned doctorate degree from an accredited, approved or authorized educational institution as set forth under Article 4 (commencing with section 94760) of Chapter 7 of Part 59 which is in acupuncture, Oriental medicine, a biological science, or is otherwise related to the authorized practice of an acupuncturist as set forth in Sections 4927 and 4937 of the Code.

The use of the title "Doctor" or the abbreviation "Dr." by an acupuncturist as authorized above without further indicating the type of license, certificate or degree which authorizes such use, constitutes unprofessional conduct.
