# Joyce Bell, Cultural Services Senior Supervisor

<u>Administration</u> – Staff received approval to hire three Community Services Leader I (CSL I) employees. The CSL I staff are part-time employees that assist the division with class logistics, division special events, customer service and general office duties. They are instrumental in helping the division meet the needs of the community. Michelle Pinedo, Supervisor, announced her resignation, as of September 16.

<u>Classes</u> – Staff worked with the General Services Department to coordinate a location for the Los Angeles County Vote Center. The Vote center will be located in Dance Studio 2 from September 2-14. The fall session begins the week of September 13<sup>th</sup>. Staff will relocate classes that were scheduled in Dance Studio 2 during the voting period.

<u>Charter Clubs</u> –The Torrance Kendo Charter Club and Torrance Naginata Charter Club continued classes this month at the Cultural Arts Center. The Torrance Aikido Charter Club started their classes this month at the Cultural Arts Center. The Dog Obedience Club of Torrance continued classes at Walteria Park this month. The South Bay Judo Charter Club continued classes at Wilson Park this month.

#### Nico Clifton, Performing Arts Program Coordinator

The summer session ended the first week in August, with a few make-up classes ending the second week in August. Summer classes ran smoothly with the session having more classes than the spring session. The two weeks of yoga classes to introduce our new instructors generally received positive feedback – the results of the surveys showed 83% of returned surveys "Loved" the overall class experience for Maureen Davis (the remaining 16% said it was "Good"), and 71% of returned surveys "Loved" the overall class experience for Efrat Pomeranitz (with 7% saying it was "Good" and 14% saying it was "Okay").

Once classes finished, both the dance and art studios were cleaned and sanitized to prepare for the upcoming fall session. During the downtime, there has been an emphasis placed on promoting fall classes on social media. With so many classes coming back in the fall, we wanted to highlight those classes that haven't been offered since before the pandemic. The goal has been to post content at least twice a week and encourage our followers to comment on and share our post.

# Michelle Pinedo-Supervisor, Visual and Performing Arts

Summer classes ended the first week of August. Make-up classes ran the second week of August.

Fall class registration began August 17<sup>th</sup> for Torrance residents and Tuesday, August 24<sup>th</sup> for non-residents. During the summer downtime, staff have been preparing the classrooms for the fall session and promoting the fall classes.

<u>Charter Clubs</u> –The general meetings for Torrance Craftsmen's Guild returned to the Ken Miller Recreation Auditorium. Torrance Artists' Guild will meetings returned to the Garden Room. The South Bay Watercolor Society meetings will return to the Garden Room in September.

# Michael Field, Cultural Services Senior Supervisor

Outreach Specialist Jason Jenn has announced his departure from the Torrance Art Museum staff. His last day is scheduled to be September 25. Jason is responsible for volunteer coordination, the Stories in Art educational program at TAM, and external communications with press and the community. He will be sorely missed.

Marketing for NOMAD, the pop up contemporary art show, came together quickly. The public was blitzed with media mentions, social media content, and rack card distribution which resulted in more than 4,000 in attendance over August 28 – 29. After Nomad, staff is working to restore the space at Del Amo Crossing; deinstalling both Ultra! at the museum, around the community; and preparing for SUR Biennial which opens at TAM on September 18.

Staff is compiling final analytic statistics for online traffic for Ultra! and Nomad. Initial data projected a record increase for summer 2021 of more than 3x over the same period in 2019, and 2021.

Planning continues for the 2021 Excellence in Arts Awards Ceremony, set for Saturday, October 9, 2021 at 2pm. The invitation is being developed and is expected early September.

The Cherry Blossom Festival is tentatively reserved to be held at Columbia Park on Sunday, April 3, 2022 from 11 a.m. to 4 p.m. Staff will begin exploring the likelihood of proceeding in early November.

<u>Torrance Sister City Association</u> – Torrance Sister City Association held no monthly meeting in August. TSCA will continue to meet virtually in September, and return to the West Annex in October. The Culture Corner segment of the meeting with our friends from Kashiwa will continue on Zoom as a social function with no public actions being taken. A considerable number of rooms for next year's Bunka Sai and the August Activities for the Cultural Exchange Program are in need of meeting spaces, and leadership is exploring alternatives to indoor activities.

Torrance Rose Float Association – TRFA held their monthly meeting on August 3. Mary Hoffman stepped down as Director of membership, and Camilla Seferian is set to join in September. Membership efforts are picking up momentum and Restaurants for Roses fund raising efforts are resuming. The Utility Bill insert for the Rose Vial Campaign was completed in August and is set to begin distribution over eight weeks at the end of September to 28,000 households. Staff is working to get the signed contract back from Tim Estes, Inc., and the date for this year's Official's Night was confirmed by Tim Estes as Tuesday, December 28.

# Gia Jordahl, Producing Artistic Director, Torrance Theatre Company:

# **Torrance Theatre Company:**

In August the Torrance Theatre Company presented our 21st annual summer musical NUNSENSE: THE MEGA-MUSICAL. The show opened at the Armstrong Theatre on August 13 and closed on August 22<sup>nd</sup>. Attendance for the show was under our original estimate, but the overall reception of the production was very strong. There was no distancing or capacity requirements in the theatre, only an indoor mask mandate.

We continue to prepare for the five-show line-up at the downtown Torrance location, which includes *Murder in the Studio* by Agatha Christie; *The Importance of Being Earnest: A Wilde New Musical* Music by Bret Simmons, Book and Lyrics by David Howard, adapted from *The Importance of Being Earnest* by Oscar Wilde; *Holmes and Watson* by Jeffrey Hatcher; *Wait Until Dark* by Frederick Knott, Adapted by Jeffrey Hatcher; and *The Legend of Georgia McBride* by Matthew Lopez. Season ticket information, and details about the productions will be found on our website at TorranceTheatreCompany.com

We interviewed candidates for our second fully-funded internship with the Los Angeles County Arts Commission. We selected Daniel Scipio, an English major from El Camino College. He will begin in September, and work through the end of the year/early 2022, with his focus being on marketing and development.

## **Drama Camp:**

Drama camp with contractor Starlight Productions ended in August. Registration numbers were the highest that they have ever been for this program, and we hope to build on this success for not only next summer, but for some possible camps during the school holidays.

# **Torrance Civic Chorale:**

The city announced the job listing for the Torrance Civic Chorale director, and interviews occurred mid-August. There is an eligibility list for those candidates. Additionally, a second round of interviews will be held in September for new candidates. The fall session was cancelled, after a poll of members showed there was no consensus on how to move forward with in-person or virtual class.

# Max Presneill, TAM Curator and Director

Torrance Art Museum Public Art project Ultra! continued to bring in visitors to the Museum in large numbers, with an estimated 2000+ actively coming to see the exhibition at TAM as well as at its other locations around the City. We also recognize that many thousands would have seen and engaged with the art works on display as they passed them during their normal daily movements. Ultra! closed on August 28.

On August 28 and 29, TAM hosted a unique pop-up of contemporary art at the Del Amo Crossing medical center building. The visitor numbers passed 4000+ and close to 500 artists participated.

These two events brought over 6,500 visitors to the City of Torrance to interact with art. On Saturday 18<sup>th</sup> September we introduce the 6<sup>th</sup> edition of the SUR:Biennial and Social Fabric exhibitions, with the opening reception 6-9pm. These exhibitions will run through December 4.

# Joyce Chan, Farmers' Market and Community Gardens Manager

#### Farmers' Market

Summer produce was in full swing this August at the market. The stone fruit and melons are the sweetest and juiciest that I've tasted in a long time. Nectarines, pluots, cantaloupes, watermelon, red flame grapes, green muskat grapes, corn, peppers, tomatoes, okra, and green beans. We are just beginning to see kyoho grapes (deep purple in color) at the market. This is the best time of the year to shop at the Farmers' Market, right before our summer fruit leave us.

The Farmers' Market welcomed a new organic farmer form Santa Barbara County, Sunrise Ranch on Saturdays. They sell interesting produce not often seen at Farmers' Markets. Have you ever heard of a Kiwano Melon? They grow these melons, and it's got spikes all over, its' rind is yellow and green, and the inside tastes like a "cucumber melon", with cucumber-like seeds. It's refreshing and sweet, and is considered a super food, which means it's very good for you. They also grow a variety of "normal" produce like tomatoes, watermelons, broccoli, etc.

One of our farmers, Thao Farms, received top billing in a feature article in the L.A. Times. It was a very interesting article about the community of Hmong farmers, who came to America on a federal grant in the 1980s. Many of the Hmong community settled in Fresno, knew how to grow Asian vegetables, and supported their families through farming, keeping their family ties strong. The Torrance Farmers' Market was mentioned and in the pictures in the article.

# **Community Gardens:**

The gardeners are getting ready to plant for the fall and winter. Many gardeners had covered their plots for the summer.

We are experiencing some plots owners who are over-watering and are addressing those plot owners as we come across them.

I hope you all had the opportunity to experience both ULTRA! and NOMAD, exhibition events produced by the Torrance Art Museum. Staff is still finalizing a report on the positive impact these events had, but so far we know the following:

- NOMAD had over 4,000 attendees over the two day period and close to 500 artists participated
- The Torrance Art Museum Advocates raised over \$10,000 through the Odyssey Fundraising auction and bar sales at NOMAD
- On-line traffic for both events increased three-fold over what it was for the same period in 2019
- Both exhibitions garnered very favorable press reviews and many positive comments on Facebook and Instagram.

Staff learned a great deal about putting on events at this scale so close together, which probably will never happen again. However, staff is planning to relaunch both events again, and we would like to hear your feedback about your experiences.
