### **RECOMMENDATION:**

The Deputy Community Development Director recommends that the Commission review the Stewardship of the Environment Strategic Priority and discuss possible implementation projects for the Commission to undertake.

### **BACKGROUND AND ANALYSIS:**

Attached is a copy of the Stewardship of the Environment Strategic Priority for the Commission's review. The Priority has been strengthened in the 2021 version of the plan to more clearly demonstrate the importance of environmental stewardship and the need for action. While the bulk of implementation activities will be undertaken at the staff level, nonetheless, the Commission can identify areas within the priority that they would like to address.

The Commission will continue their discussion of an award/recognition program at their next meeting. Depending on how it is structured, such a program can support Goal 2: Actively inform, educate, and motivate the community regarding the value and benefit of environmental stewardship; Goal 4: Create and promote sustainable/green practices for use in daily life; and, Goal 7: Create a positive environment for businesses and industries to adopt sustainable/green practices. With the Strategic Plan in mind when designing categories for recognition, the recognition/award program could become a strong supporter of the Stewardship of the Environment Priority as well as an educational tool.

Although it is unsure when the Environmental Fair will return, the Fair also provides an opportunity to educate the public in support of environmental priorities. The Commission can discuss areas of focus for the Fair or other possible outreach events in support of the Stewardship sub-goal 2.1: Develop and implement a comprehensive environmental stewardship outreach plan that raises awareness of the issues and the importance of local action; educates and provides information; actively involves the community; and inspires action.
