






Line 10 – Torrance to Florence Special Event Service

- On NFL game days, extend Line 10 from Crenshaw C-Line (formerly Green Line)
 Station to Downtown Inglewood to service SoFi Stadium.
- Trips every 30 minutes pre-game and post game. 50-60 minutes during the game.
- Special Event Fare (round trip):TBA
- Park and Ride pick up at Wilson Park
 (Future service to SoFi will be from the new Regional Transit
 Center)
- Special event service to begin November 2021.





Line 13 Update

- Route
 - Western portion from Artesia A-Line (formerly Blue Line) Station to Redondo Beach
 - Start of service: June 27, 2021
- Benefits
 - Expanded service area
 - Provide service on Artesia Blvd west of Vermont Ave.
 - Improve frequency between Harbor Gateway Transit Center and Artesia Station

Performance

- 19,000 Average Monthly Boarding's
- 762 Average Weekday Boarding's
- o 12.3 Weekday Boarding's per hour
- 79% On Time Performance



Bus Operator Recruitment

- Recruitment Campaign to hire Apprentice Relief Bus Operators (ARBO) and Temporary Relief Bus Operators (Temp RBO's)
- Expedited testing process to hire ARBO's and Temporary RBO's
- Coordination with HR, Workforce Investment Network and Employment Development Department
- Social Media advertising & sourcing of candidates from additional agencies – faith based/churches, social services, veterans & educational institutions







Bus Operator Safety Shield "BOSS"

- With COVID-19 Pandemic and Bus Operator assaults nationwide, the Transit Fleet Maintenance Division developed a safety barrier for Operators
- The BOSS is a durable, transparent barrier designed for use of use while offering maximum protection
- The "sliding" door allows the BOSS to be safely secured while not in use, while minimal effort is required for deployment and operation
- BOSS shields have been installed on all the Transit fleet
 - Staff is currently in progress of installing anti-reflection film
 - Expected completion end of October

Metro Board Motions

In May 2021, Board unanimously approved implementation of the Fareless System Initiative, subject to a final financial plan, while pursuing cost-sharing agreements, with reports to the Board monthly on the development, launch, and performance of FSI.

Requirements included:

- Streamlined, efficient application and administration
- Cost-sharing agreements with K-12 districts and community colleges
- Maintaining existing agreements between colleges and transit agencies
- Identifying new funding source
- In September 2021, Metro Board approved Phase 1 Launch effective 10/1/2021

Background for Phase 1 (K-14)

- 69% of 1.4 million K-12 students qualify for Free and Reduced-Price Meal programs for low-income families
- 20% of junior high school students and 23% of LA adults are obese
- People who take transit are 44% less likely to be overweight
- An AA degree increases income potential by up to 47%
- Only 30% of community college students graduate, and only 26% of African American students and 22% of Latino students

Program Goals - Phase 1 (K-14)

Increase ridership, increase student success, and improve student health by building on existing Metro and regional student pass programs, to make access to transit fareless for all K-12 and community college students in LA County through cost-sharing partnerships with districts (school and community college) and transit agencies

K-12 District Partnerships: Status

Cost-sharing for District K-12 Partnerships is \$3 per student per year for all students in district and includes:

- Distribution of free TAP Cards through District
- Unlimited rides on all participating transit agencies in LA County

41 districts have expressed interest in becoming Partners representing:

- 1,201 schools
- 726,735 students
- Cost-sharing revenue of \$2.18M/year (out of \$49.9M pilot cost)

Metro Youth Council

- Missing youth voices in existing planning process, advisory councils and committees.
 - Youth Council is aimed at students between 14 and 17 who represent the diverse demographics and geographic areas of LA County.
- Youth Council will be made up of 26 members representing Metro's nine sub-regions.

Fareless System Initiative

 FSI Plan-Phase 1 will leverage the Youth Council efforts

Public Participation

 Build a pipeline of riders and transit leaders as it moves towards engaging K-14 students in LA County.

FSI Community College Partnerships


Maintain all existing agreements between colleges and transit agencies

- Under Muni/College agreements, student fees range from \$7-\$9.50 per term
- Pass loaded would be FSI Regional College Pass, instead of local pass

Recommend U-Pass schools transition from opt-in to opt-out programs

- Proposed cost-sharing for new Community College Partnerships for Year 1 would be \$7 per student per year for all students in district for first year:
 - Distribution of free TAP Cards through District
 - Unlimited rides on all participating transit agencies in LA County
- This would give U-Pass community colleges time to assess usage and pass student referendum for student fee for Year 2, if desired

Regional Universal Student Pass (U-Pass)

Phase 1 Funding Plan

Identified new funding for Phase 1:

- Metro plans to propose ARPA to fund Metro's participation
- In consultation with regional transit operators, Metro is recommending use of their ARPA allocations to fund their participation
- K-12 school districts and community college cost-sharing
- Revenue from district cost-sharing will be distributed between participating transit agencies

Continue to seek additional funding to support the pilot and beyond

Next Steps

- Continue Phase 1 launch and outreach and planning with school districts, community colleges, and regional and local transit operators.
- Staff Continue advocacy efforts to secure funding for the Phase 2 financial plan. In addition, staff will finalize the administrative strategies for ease of implementation of the Phase 2 pilot.
- Continue LIFE Program Enhancements and Fare Capping Testing
- Resume full fare collection in January 2022

Regional Transit Center Construction Update

West Building

- Building now encapsulated for interior work including HVAC, fire systems, electrical and plumbing
- Generator in place
- Exterior framing in progress
- Bike lockers to be placed along northern wall
- Includes transit store, security office, staff and retail space

East Building

- Both floors interior framing in progress
- Fire Systems, electrical, plumbing, roof drains, patio work on going
- LED wall work continues plans in review
- AV specs for interior spaces ongoing
- Includes conference room, training room, exercise room, locker/restrooms and offices







Regional Transit Center Construction Update

Site

- Landscaping and irrigation work continues
- Decorative concrete being poured
- Working on joint trench for 208th St

Schedule

- Work progresses each week
- Material delays due to shortages and shipping times
- Experiencing longer lead times with utility coordination
- Staff continually working with contractor to pursue schedule acceleration
- Anticipated completion of project early 2022
