Thank you for taking public input regarding proposed overnight parking restrictions on Paseo del la Playa between Calle Miramar and Via Riviera. Due to the fact there are no parking restrictions (except for Street Sweeping) there are a number of people who chose to live in the vehicles/vans for extended periods of time only to move the vehicle on street sweeping days - and they usually move to the Torrance Beach Parking lot on Tuesdays between 9am-11am. There is also a 1973 VW bus that promotes "van living"on Airbnb that is parked on Paseo de la Playa -for \$125 a night you can live in the van to experience "van living".

I understand there are Torrance residents who live in the apartments/condos on Paseo de la Playa who park on Paseo de la Playa - I would propose Resident Parking Permit Signage similar to the signage on Ave G and Ave F for the Redondo Beach residents stating NO - similar to the photos attached.

To: City of Torrance,

I support this proposal for no overnight parking on Paseo de la Playa. As a 22 year resident on Paseo de la Playa, we have seen an increase of non residents parking on the street. They are sleeping and living in their vehicles day and night. The campers, vans, cars and conversions line the street and leave little to no parking for the residents of the street.

This has also added additional problems of trash, garbage, broken glass, defecation and urination on the sidewalk and street.

It is also a safety issue to walk on the sidewalk as many of these vehicles doors open to the west. The vans and campers have make shift drapes, blankets, cardboard and beach towels giving them some privacy from the walking traffic on the sidewalk as they are living in the vehicles day and night. It is only a matter of time before a serious issue could occur.

The sidewalks are broken, uneven causing an additional problem of safety of someone falling and tripping. The ice plant is over grown and not maintained. The street sweeping does not take place often on Tuesdays.

Good evening Torrance Traffic Commission and fellow residents. My name is Jessica Borello and I have lived across the street from Torrance Beach with my family for 4 years. Parking has always been a problem in the [REDACTED] Paseo De La Playa, especially because my family has two cars with only one parking spot on the property we live. Since 2019, we have all seen the displacement of homeless into our neighborhoods. Due to no street lights, Paseo De La Playa has attracted many people sleeping in their vehicles/trucks and RV trailers. I understand it is not a crime to sleep in your car, however these people defecate, urinate, throw up, and leave behind used condoms and dirty diapers which is a hazmat condition. I no longer can walk my dog along the ice plants or the side walk due to the human feces and other excrements that these people leave behind. Many of the people occupying these vehicles do not just sleep once on our street and leave. Paseo De La Playa is their campground and they remain even during street sweeping hours. Some occupants wait for the ticket enforcement to arrive (if they happen to have enough people working that day for enforcement) then drive around the block and re-park in the same spot.

I have called the police and parking enforcement several times regarding loud music, the revving of a vehicle engine which wakes my family up at odd hours, as well as the lack of street cleaning.

One night I contacted the non emergency dispatch line and was told by an officer that the police would not make contact with anyone in their vehicle unless they were doing something illegal. I've provide the police with expired license plates over 6 months (tow authority) as well as made noise complaints for one subject who revved his engine every night on the hour to keep his car from stalling. During this particular non emergency call I placed, I advised the officer that I too was a police officer and the issue was what we called a Quality of Life issue that I was willing to sign a citation or be contacted if needed. I also advised this officer that I do the same job he does everyday in a neighboring city and WE make contact with these individuals daily. My conversation with this officer stopped once he stated, "what if we get in a police shooting upon contact?" I responded, welcome to the duties of a police officer and respectfully ended the phone call.

Knowing I was in my own, I decided to do my job off-duty and contact the vehicle occupant myself. The occupant appeared high (through my training and experience), however listened to my concern and stopped revving his engine for the night. It should be noted this person was arrested about 6 months later inside his vehicle outside of my house for an unknown reason. I have not seen him since.

In conclusion, I am respectfully requesting you make the west side of Paseo De La Playa a Permit Only parking area for residents. I'm tired of looking outside my front windows and seeing a sea wall of trailers and RVs blocking my view of the ocean as well as dealing with their garbage and human waste they leave behind.

As I write this, I can see trash that has been discarded onto the street that I have not yet had an opportunity to pick up.


A VW van is used as an overnight "hotel". Are they assessed a tax or fee to cover costs to Torrance? Their patrons use the restrooms and showers on the beach below.

There is nighttime noise that emanates at times from the beach itself as well as the street, most especially on weekends. Police patrols could peacefully disperse these people, but their patrols need to be regularly conducted and maintained over time.

I emphasize that if restrictions are voted in that it is essential that they be enforced by regular police patrols. Otherwise, the restrictions are for naught.

Please note that people also park on Paseo de la Concha and the same issues apply.


RE: Proposed Overnight Parking Restriction on Paseo de la Playa

We make the following comment to the proposed ban on overnight parking on Paseo de la Playa. I represent Riviera Beach Colony Homeowners Association in the capacity as President.

See the photograph below: Riviera Beach Colony is accordance with California Coastal Commission Permit No. 5-91-480, issued February 18, 1992, operates, and maintains a “Public Park” extending from approximately 100 Via Riviera and into Calle Miramar.

While we favor overnight parking restrictions along Paseo de la Playa, we voice our concern these persons and vehicles will move around the corner and overnight park along the Public Park extending along Via Riviera. Parking along Via Riviera is currently populated by vehicles owned to Tenants living in apartment building on Paseo de la Concha and Via Riviera. The Riviera Beach Colony Public Park is used by families and children residing in the general area. This Park will be an attractive to overnight offending vehicle owners should they be evicted from overnight parking along Paseo de la Playa.

We respectfully request Torrance Public Works and Torrance City Council consider that overnight vehicles currently parking along Paseo de la Playa will move their overnight domicile to the closest available area being the Via Riviera (along Riviera Beach Colony Public Park); and should the City of Torrance ban parking along Paseo de la Playa they extend this ban to Via Riviera curb along the Riviera Beach Colony Public Park. To accommodate homeowners, we recommend a “permit” system like the system used by Redondo Beach.



Again, we favor plans to remove overnight persons sleeping in their vehicles along Paseo de la Playa, and respectfully request this ordinance be extended to include the street parking along the Riviera Beach Colony Public Park. Having these vehicles and their inhabitants parked along Via Rivera would infringe, jeopardize, and endanger residents (adults and children) who regularly use the Park.

I live at [REDACTED]. Our family has lived here since the 1960s. I STRONGLY URGE THE COMMISSION ENACT AND ENFORCE OVERNIGHT PARKING RESTRICTIONS ON NON-RESIDENT VEHICLES.

Over the last couple of years, more and more transients and campers have been camping out on Paseo De La Playa opposite the Torrance Beach parking lot. Most recently, I have noted about 12 such vehicles parked there day and night. Many of them only leave on street sweeping days. Several of them have out of state license plates. The numbers are increasing every week. They are there late at night and are there early in the morning. I walk the area daily and also drive by regularly at night.

There are also a few vehicles which are clearly used for business purposes. One in particular is a camper van being advertised for rent. This vehicle is parked in the same place pretty much 365 days a year and rarely is moved.

I strongly urge you to place overnight parking restrictions on these non-resident, transient vehicles and on vehicles advertised for hire. This is needed for the following reasons:

1. The condition of most of these vehicles is getting more and more run down. Many are dilapidated and appear to be barely operational. Some look like they are being used for storage sheds. This is a blight on an otherwise beautiful neighborhood.
2. The number of transient vehicles is increasing. The word is out because there is no parking restriction. This needs to stop now. We do not want our neighborhood to become like Venice or Santa Monica where dilapidated vehicles are parked everywhere and people dump sewage from their campers in front of people's houses. Paseo de la Playa is a residential street. It was never intended to be a transient camp ground for junk vehicles. This is blighting the area.
3. Parking in the area is already at a premium, especially in the summer months. These long-term campers and transients are needlessly depriving residents of adequate parking, which adversely affects quality of life.

I have attached pictures of some of the vehicles I see every morning on my walks. They are the same ones, parked in the same spaces everyday, and they rarely move. Others come and go and stay for weeks and months.

Please do not let Torrance turn into a haven for run down campers and other transients like we unfortunately see in other areas such as Venice, Santa Monica and Los Angeles. Now is the time to nip this in the bud and enact controls.

The solution is to enact, AND ENFORCE, a prohibition on overnight non- resident vehicle parking between 8:30 p.m. and 6:30a.m. which is the same as the Torrance Beach parking lot. This could readily be done with a resident permit sticker system that many cities in the South Bay already have.

We received a notice about an upcoming Traffic Commission Meeting scheduled for Monday, April 4. In this notice, a proposed parking restriction was described on Paseo de la Playa that would limit overnight parking between Calle Miramar and Via Riviera. Also in this notice was an invitation to provide input via email which is what we are providing here.

We oppose any new limitation that is greater than the existing parking limits set for street sweeping. Overnight parking is valuable for those living on this street and nearby. Limiting overnight parking would just force those who park there now onto adjacent streets, which are already constrained.

Those who park on this street now are required to move their vehicles at least once a week for street sweeping. Failure to move vehicles results in parking tickets. This consequence is sufficient to limit any long-term parking. As we walk down this street twice a day, we do not see any long-term parking taking place due to this existing street sweeping regulation.

I walk 3-4 times daily. I have been frightened- passing by the large vans & RVs. There is no street lighting!
