MINUTES OF AN ADJOURNED REGULAR MEETING OF THE TORRANCE CITY COUNCIL

1. CALL TO ORDER

The Torrance City Council convened in an adjourned regular session at 5:30 p.m. on Tuesday, April 12, 2016 in the Council Chamber at Torrance City Hall.

Assistant City Manager Giordano joined the meeting at 8:13 p.m.

Agenda Item 13A was considered out of order at this time.

13A. <u>APPEAL OF CIVIL SERVICE COMMISSION DECISION SUSTAINING TERMINATION</u> OF A POLICE OFFICER

Recommendation of the City Manager that the City Council conduct a hearing on the appeal of the Civil Service Commission decision sustaining the termination of a Police Officer and that the hearing will be conducted in closed session, unless the employee requests to have the hearing in public session and that the City Council's deliberation of this matter shall occur in executive session.

The City Council immediately recessed to consider this matter in closed session.

<u>MOTION:</u> Councilmember Weideman moved to uphold the Civil Service decision sustaining the termination of a Police Officer. The motion was seconded by Councilmember Goodrich and passed by a 6-0 vote, with Councilmember Rizzo abstaining.

Agenda Item 18 was considered out of order at this time.

18. EXECUTIVE SESSION

The City Council reconvened at 7:20 p.m. with all members present. No formal action was taken on any matter considered in closed session.

2. FLAG SALUTE/ INVOCATION

3. REPORT OF CITY CLERK ON POSTING OF THE AGENDA/ MOTION TO WAIVE FURTHER READING

City Clerk Poirier reported that the agenda was posted on the Public Notice Board at 3031 Torrance Boulevard on Thursday, April 7, 2016.

MOTION: Councilmember Rizzo moved that after the City Clerk has read aloud the number and title to any resolution or ordinance on the meeting agenda, the further reading thereof shall be waived, reserving and guaranteeing to each Councilmember the right to demand the reading of any such resolution or ordinance in regular order. The motion was seconded by Councilmember Weideman and passed by unanimous vote.

MOTION: Councilmember Ashcraft moved for the approval of Consent Calendar Items 8A, 8B and 8C. The motion was seconded by Councilmember Goodrich and passed by unanimous vote.

Consent Calendar Item 8D was considered separately at this time.

8D. <u>CONTRACT FOR PURCHASE/INSTALLATION OF PLAYGROUND EQUIPMENT AT LOS ARBOLES "ROCKETSHIP" PARK</u>

Recommendation of the Parks and Recreation Commission and the Community Services Director that City Council authorize a contract in the amount of \$128,019.47 with Dave Bang and Associates, Inc. of Tustin, CA, for the purchase and installation of new playground equipment at Los Arboles 'Rocketship' Park, 5101 Calle De Ricardo.

Councilmember Griffiths commended Community Services Department staff for their efforts with regard to this much-needed project.

MOTION: Councilmember Griffiths moved to concur with the staff recommendation. The motion was seconded by Councilmember Goodrich and passed by unanimous vote.

12. ADMINISTRATIVE MATTERS

12A. APPROPRIATION OF FUNDING FOR OPAL STREET SEWER PROJECT

Recommendation of the Public Works Director that City Council:

- 1) Accept \$525,000 from Del Amo Fashion Center and \$175,000 from Madrona F&FLLC and appropriate the combined amount of \$700,000 to the Opal Street Sewer Project (B2016-04) as provided in an agreement with the City of Torrance and Del Amo Fashion Center and Madrona F&FLLC; and
- 2) Appropriate \$372,442.60 from the Sewer Enterprise Fund balance to the Opal Street Sewer Project (B2016-04) to provide the balance of funds needed for construction, inspection, geotechnical services and in-house project management.

Engineering Manager Dettle provided a brief summary of the Opal Street Sewer Project.

Arthur Plourde requested clarification of the cost of in-house project management, which was provided by Public Works Director Beste.

MOTION: Councilmember Rizzo moved to concur with the staff recommendation. The motion was seconded by Councilmember Weideman and passed by unanimous vote.

12B. AGREEMENTS RE OPAL STREET SEWER PROJECT

Recommendation of the Public Works Director that City Council:

- 1) Approve the plans and specifications for the Opal Street Sewer Project (B2016-04); and
- 2) Waive a minor irregularity in the Bidder's Submittal from Cedro Construction, Inc., of Santa iPaula, CA, the lowest responsive bidder; and
- 3) Award a two-year Public Works Agreement to Cedro Construction, Inc. of Santa Paula, CA in the amount of \$851,094 and authorize a 5% contingency in the amount of \$42,555 to construct the Opal Street Sewer Project (B2016-04); and
- 4) Award two-year Consulting Services Agreement to KOA Corporation of Monterey Park, CA in the amount of \$80,016 to provide construction inspection services for this project; and
- 5) Award a two-year Consulting Services Agreement to Inspection Services, Inc. of Torrance, CA in the amount of \$48,777.60 to provide geotechnical services for this project.

Engineering Manager Dettle reviewed the staff recommendation.

MOTION: Councilmember Rizzo moved to concur with the staff recommendation. The motion was seconded by Councilmember Weideman and passed by unanimous vote.

12C. CHANGE ORDER RE TRAFFIC CONTROL EQUIPMENT, SIGNAL CONTROLLER HARDWARE, SOFTWARE, AND SUPPORT

Recommendation of the Public Works Director that City Council approve change order #2 to purchase order 2015-181 with Econolite Control Products of Anaheim, CA for the purchase of traffic control equipment, signal controller hardware, software and support on an as-needed basis. This change order will increase the amount of the purchase order from \$500,000 to a new not-to-exceed amount of \$915,000 (increase of \$415,000) and extend the term for an additional year to June 30, 2017.

Street Operations Manager Cooper reviewed the staff recommendation.

Responding to questions from the Council, Street Operations Manager Cooper confirmed that the City seeks reimbursement for damage to traffic control equipment caused by power surges and traffic accidents and these claims are handled by the City's Risk Management Department. He reported that cameras to be installed at several intersections in conjunction with this project are designed to monitor and expedite traffic flow and the intersections were selected because they meet eligibility requirements for grant funding from L.A. County Metropolitan Transit Authority.

MOTION: Councilmember Rizzo moved to concur with the staff recommendation. The motion was seconded by Councilmember Weideman and passed by unanimous vote.

12D. CONSIDERATION OF REMOVAL OF TRAFFIC COMMISSIONER

Pursuant to Council direction, the City Manager recommends that City Council consider the removal of Patrick Furey, Jr. from the Traffic Commission.
