### MINUTES OF AN ADJOURNED REGULAR MEETING OF THE TORRANCE CITY COUNCIL

### 1. CALL TO ORDER

The Torrance City Council convened in an adjourned regular session at 5:30 p.m. on Tuesday, April 26, 2016 in the Council Chamber at Torrance City Hall.

#### **ROLL CALL**

Agenda Item 18 was considered out of order at this time.

### 18. EXECUTIVE SESSION

The City Council immediately recessed to closed session to confer with the City Manager and the City Attorney on agenda matters listed under 18A) Conference with Labor Negotiator, and 18B) Real Property – Conference with Real Property Negotiator, pursuant to California Government Code § 54957.6 and § 54956.8.

The City Council reconvened at 7:00 p.m. with all members present.

City Attorney Fellows announced that the City of Torrance had reached an agreement with the property owners of 3756-3758 Pacific Coast Highway, Torrance, California, 90505 and will purchase the property for \$1,450,000 through a 30-day escrow.

The motion was seconded by Councilmember Weideman and passed by unanimous vote.

## 8I. AGREEMENT FOR REPLACEMENT OF FLOORING AT TORRANCE CULTURAL ARTS CENTER

Recommendation of General Services Director that City Council:

- 1) Award a public works agreement with JJJ Floor Covering, Inc. of Pico Rivera, CA in the amount of \$69,636.00 with a 5% contingency of \$3,481.80 for the Replacement of Flooring at the Torrance Cultural Arts Center (B2016-01); and
- 2) Approve a 10% project management fee of \$6,963.60.

## 8F. PURCHASE ORDER FOR COMMUNITY SERVICES DEPARTMENT PROGRAM SUPPLIES

Recommendation of the Community Services Director that City Council authorize a two-year Purchase Order to Smart and Final, Iris Company, of Torrance, California in a total amount not to exceed \$101,300 (with an annual not to exceed amount of \$50,650) to furnish various Community Services Department program supplies, effective July 1, 2016 through June 30, 2018.

Councilmember Ashcraft requested that staff provide a report on how much of the cost of these supplies was recovered by program fees at the end of the fiscal year.

**MOTION:** Councilmember Ashcraft moved to concur with the staff recommendation. The motion was seconded by Councilmember Goodrich and passed by unanimous vote.

### 11A. JOINT POWERS AGENCY AGREEMENT TO FORM INTEROPERABILITY NETWORK

Recommendation of the City Manager and Communication and Information Technology Director that City Council authorize a Joint Powers Agency (JPA) agreement to form the Interoperability Network of the South Bay (INSB).

Communications Manager Gallo reviewed the staff recommendation.

Councilmember Ashcraft noted that her concern about the financial liability of withdrawing members was addressed in the JPA agreement under Section 6.03(a).

**MOTION:** Councilmember Rizzo moved to concur with the staff recommendation. The motion was seconded by Councilmember Weideman and passed by unanimous vote.

## 12A. APPOINTMENT OF CITY COUNCIL AD HOC NAMING OF PUBLIC FACILITIES COMMITTEE

Recommendation of the City Manager that the Mayor appoint the chair and members to the City Council Ad Hoc Naming of Public Facilities Committee to consider renaming individual City owned hangar rows and gates at Torrance Municipal Airport – Zamperini Field.

Management Associate Jones reviewed the staff recommendation.

**MOTION:** Councilmember Rizzo moved to appoint Councilmember Barnett as chair and Councilmembers Ashcraft and Weideman as members of the City Council Ad Hoc Naming of Public Facilities Committee.

## 12B. <u>AGREEMENT WITH STATE FRANCHISE TAX BOARD TO OBTAIN BUSINESS</u> LICENSE INFORMATION

Recommendation of the Finance Director that City Council adopt a resolution approving and authorizing the City Manager to enter into a non-financial agreement with the State Franchise Tax Board ending on December 31, 2018 for the City to participate in the City Business Tax and Data Exchange Program.

Senior Accountant Bittner reviewed the staff recommendation.

**MOTION:** Councilmember Rizzo moved to concur with the staff recommendation. The motion was seconded by Councilmember Weideman and passed by unanimous vote.

**MOTION:** Councilmember Griffiths moved to adopt Resolution No. 2016-32. The motion was seconded by Councilmember Barnett and passed by unanimous vote.

#### 12C. MODIFICATIONS TO LEASE RE 3233 PACIFIC COAST HIGHWAY

Recommendation of the City Manager that City Council:

 Approve modifications to a Lease by and among the City of Torrance (Landlord), a municipal corporation, Peyton Cramer Infiniti, a California Corporation (Current Tenant), and Carwell LLC, a Delaware limited liability company operating as Land Rover (New Tenant effective November 1, 2016) which includes: Assignment of Lease, Consent to Assignment of Lease, and Third Amendment to Lease; and 2) Approve a Consent to Sublease Agreement of site for the period April 27, 2016 through October 31, 2016 to Nissan and Infinity.

Assistant City Manager Giordano reviewed the proposed modifications to the lease.

**MOTION:** Councilmember Rizzo moved to concur with the staff recommendation. The motion was seconded by Councilmember Weideman and passed by unanimous vote.

#### 12D. REVISIONS TO TORRANCE BAIL SCHEDULE

Recommendation of the Torrance Police Department on behalf of the City Treasurer and City Attorney that City Council adopt resolutions amending the bail schedule for Torrance Municipal Code misdemeanors and infractions, and amending the bail schedule for parking penalties assessed for the City of Torrance parking violations, and repealing Resolutions 2014-82 and 2014-83.

Deputy City Attorney Studwell briefly reviewed the proposed amendments to the bail schedules.

Councilmember Ashcraft cautioned residents who are keeping bees without a permit that they could be charged with a misdemeanor, noting that the Council spent a considerable amount of time drafting an ordinance allowing residents to keep bees and some residents admitted during the drafting process that they were already doing so, but so far no one has applied for a permit.

Elaine Wilson commended Councilmember Ashcraft for her diligence.

**MOTION:** Councilmember Rizzo moved to concur with the staff recommendation. The motion was seconded by Councilmember Weideman and passed by unanimous vote.

**MOTION:** Councilmember Griffiths moved to adopt Resolution No. 2016-33. The motion was seconded by Councilmember Barnett and passed by unanimous vote.

**MOTION:** Councilmember Griffiths moved to adopt Resolution No. 2016-34. The motion was seconded by Councilmember Barnett and passed by unanimous vote.

## 12E. RESOLUTION OF INTENT TO CONSIDER A PETROLEUM PRODUCTS PIPELINE FRANCHISE APPLICATION

Recommendation of the City Manager that City Council adopt a resolution of intent to consider a petroleum products pipeline franchise application from Mobil Pacific Pipeline and set the date for the required public hearing on May 17, 2016 at 7:00 PM during the regular Council meeting to be held in the City Council Chamber at 3031 Torrance Boulevard, Torrance, CA 90503.

Assistant to the City Manager Sunshine provided a brief summary of the staff report and noted supplemental material available at the meeting.

In response to Councilmember Weideman's inquiry, Mr. Sunshine confirmed that the franchise was transferable should ExxonMobil complete the sale of the refinery to PFB Energy as scheduled.

John Bailey, Southeast Torrance Homeowners Association, noted that he submitted an inspection report from the State Fire Marshal's Office and a report from the U.S. Department of Transportation regarding an accident involving this pipeline that occurred in August 2011 (Supplemental #2) and requested that staff follow-up on this information prior to the May 17

hearing. He suggested that the City may wish to consider not awarding this franchise and instead require that the pipeline be removed.

Councilmember Goodrich requested that staff provide information about safety protocols necessary to bring this pipeline back into operation at the May 17 hearing.

Councilmember Griffiths, with the concurrence of Council, requested that staff provide a summary of chemical-related pipelines in Torrance, including information about who owns them and where they are located, and create a website where the public can access this information.

City Manager Jackson reported that Mr. Sunshine is forming a team to research this information and it should be available in the next quarter.

Councilmember Griffiths suggested that it would also be helpful to include information about safety testing and identify the party who would be responsible in the event of a leak.

Elaine Wilson expressed concerns about the reactivation of this pipeline; reported on the August 2011 accident; and urged that the matter be fully researched prior to the May 17 hearing.

Councilmember Weideman noted that he was initially inclined to vote against the resolution, but now supports the holding of a hearing so there can be a public airing of the facts.

MOTION: Councilmember Weideman moved to concur with the staff recommendation. The motion was seconded by Councilmember Rizzo and passed by unanimous vote.

**MOTION:** Councilmember Griffiths moved to adopt Resolution No. 2016-35. The motion was seconded by Councilmember Barnett and passed by unanimous vote.

# 13A. RESOLUTION RE ACQUISITION OF INTERESTS IN REAL PROPERTY LOCATED AT 3756-3758 PACIFIC COAST HIGHWAY

Recommendation of the City Attorney and Public Works Director that City Council:

- Conduct a hearing for the purposes of permitting comment from the owners or other parties with interests in the property that is being considered for acquisition of the Pacific Coast Highway (SR-1) at Hawthorne Boulevard (SR-107) Intersection Improvement Project. ("Project") located at 3756-3758 Pacific Coast Highway (APN #7534-002-008); and
- 2) Adopt a resolution making the appropriate findings and authorizing the City Attorney and Special Counsel to proceed with preparing and filing necessary actions to acquire the interests in property necessary for the project to proceed by way of the eminent domain.

City Attorney Fellow noted that as he reported earlier in the meeting, the City has reached an agreement with the property owners of 3756-3758 Pacific Coast Highway and will purchase the property for \$1,450,000 through a 30-day escrow, therefore he was recommending that the hearing be continued to June 14, 2016.

For the benefit of the public, City Attorney Fellows clarified that Measure R funds will be used for this purchase and it does not involve City funds.

**MOTION:** Councilmember Rizzo moved to continue the hearing to June 14, 2016. The motion was seconded by Councilmember Weideman and passed by unanimous vote.
