1. CALL MEETING TO ORDER

The Torrance Airport Commission Agenda convened in a regular session at 7:00 p.m. on Thursday, June 9, 2022, via teleconference.

<u>MOTION</u>: Commissioner Zygielbaum moved to excuse the absence of Commissioner De Rago. Commissioner Cohen seconded the motion; a roll call vote reflected 4-0 approval (Commissioners De Rago and Gong absent).

Commissioner Gong joined the Commission at 7:03 p.m.

2. FLAG SALUTE

Commissioner Witherill led the Pledge of Allegiance.

3. REPORT FROM THE AIRPORT STAFF ON THE POSTING OF THE AGENDA

Chair O'Brien reported that the agenda was posted on the Public Notice Board at 3031 Torrance Boulevard and on the City's Website on Thursday June 2, 2022.

4. ANNOUNCEMENT OF WITHDRAWN, DEFERRED, AND/OR SUPPLEMENTAL ITEMS

5. ORAL COMMUNICATIONS

Commissioner Cohen thanked Facility Operations Manager Gerry Pinela for arranging the cleanup of the weeds in front of the Torrance Airport.

Commissioner Witherill requested information regarding the movement of the helicopter pad at the Torrance Airport. City of Torrance Airport Manager Herrera replied that due to Sling's growth, additional tiedowns were requested; to alleviate congestion, the helicopter pads have been moved.

Chair O'Brien requested Staff explain the difference between a helipad and a parking spot for non-pilots. City of Torrance Airport Manager Rafael Herrera replied that there are no helipads currently, there are only parking stalls for helicopters against the grass area. Although there are 13 spots, approximately 2-3 helicopters are parked against the grass area. Staff is attempting to shift congestion toward the grass area since there are empty tiedowns available; Staff is not attempting to eliminate helicopter tiedowns or operations.

Commissioner Zygielbaum stated that this may be his last Commission and thanked Staff and the Commission. Chair O'Brien thanked Commissioner Zygielbaum for his service.

Chair O'Brien stated that with the President in town, a temporary flight restriction was put in place exceeding the normal 10-mile no fly zone making it complex for pilots to figure out how to operate legally and safely.

Commissioner Gong stated that his term ends June 30, 2022 and thanked the Commission. Chair O'Brien thanks Commissioner Gong for his service.

A member of the public spoke.

Facility Operations Manager Pinela thanked Commissioners Gong and Zygielbaum for their service.

Facility Operations Manager Pinela stated that Commissioners do not have to wait until Commission meetings to bring up issues, they can reach out to him, and he can provide updates accordingly.

Chair O'Brien inquired about the tower gate. Facility Operations Manager Pinela stated that the gate is in the process of being built and should be completed within the next few weeks.

City of Torrance Airport Manager Herrera reported a monthly update of aeronautical operational information under the purview of the general services department:

- There are 5 vacancies for hangars and 62 tiedowns available.
- Staff continues to meet with vendors and contractors regarding AWOS; a job walk was held May 26, 2022.
- Hangar wait list continues to grow; the month of May had 5 new additions.
- Non-aviation hangar wait list has 7 parties acquiring a hangar for non-aviation usage, the priority is to supply / offer hangars to aviation. Currently, no offers have been made to non-aviation requests based on aviation demand.
- A total of 14,457 operations took place in the month of April with zero incidents reported.

• Compared to April 2021's operations, April 2022 saw an increase in 1,000 operations.

Chair O'Brien inquired if lease violators had converted or had been evicted. City of Torrance Airport Manager Herrera replied that the new non-aviation was instituted June 1, 2022, Staff would need to investigate to see which hangars are in violation. Once a violation has been identified, a letter will be drafted stating that they're in violation of the hangar agreement and they have 30-60 days to remedy the matter. Torrance Airport Manager Herrera noted that Staff have done inspections and currently no one has converted.

Chair O'Brien inquired if the Commission could get a monthly report of the number of non-aviation hangars in use. Torrance Airport Manager Herrera replied and confirmed.

Facility Operations Manager Pinela stated that non-aviation hangars have been inspected and Staff is in the process of converting or requesting the hangars back.

Facility Operations Manager Pinela presented a summary of the new implementation of the FAA IFR Departures and Runways 11L and 11R.

Definitions:

ACCIDENTS: An occurrence associated with the operation of an aircraft, which takes place between the time any person boards the aircraft with the intention of flight and all such persons have disembarked, and in which any person suffers death or serious injury, or in which the aircraft receives substantial damage.

SUBSTANTIAL DAMAGE means damage or failure which adversely affects the structural, strength, performance, or flight characteristics of the aircraft, and which would normally require major repair or replacement of the affected component. Engine failure or damage limited to an engine if only one engine fails or is damaged, bent fairings or cowling, dented skin, small punctured holes in the skin or fabric, ground damage to rotor or propeller blades, and damage to landing gear, wheels, tires, flaps, engine accessories, brakes, or wingtips are not considered "substantial damage".

SERIOUS INJURY means any injury which: (1) requires hospitalization for more than 48 hours, commencing within 7 days from the date the injury was received; (2) results in a fracture of any bone (except simple fractures of fingers, toes, or nose); (3) causes severe hemorrhages, nerve, muscle or tendon damage; (4) involves any internal organ; or (5) involves second or third degree burns; or any burns affecting more than 5% of the body surface.

<u>INCIDENT</u>: Any occurrence other than an accident associated with the operation of an aircraft, which affects or could affect the safety of operations.

NOTE: Per the FAA, Airport Operations totals will no longer be reported for the previous month. Due to automation, the totals will now be reported two months after they occur.



Since the last update at the Airport Commission meeting of May 12, 2022, the below actions have taken place or will need to take place.

- Radios and ATC recorder has been installed at the Noise Abatement Office, with recordings being loaded into Casper Noise.
- 3 out of the 7 Noise Monitor sites have been installed and are in testing mode, which will take 1-2 weeks.
- The 3 operational monitors are collecting data which will be available soon.
- Radar and FAA System Wide Information Management (SWIM) data are up and running.
- The Consultant is still on track to have the noise monitors operational in mid-July, barring any supply chain delays.
- Staff and Casper are working on the development of Noise Lab Community outreach page.
- · Casper has set a tentative date for training Staff in the first week of August.
- Casper has set a tentative date of August 11, 2022 to present to the Airport Commission.
- Staff continues to meet with the Consultant bi-monthly to help keep the project on track and update Commission and City Council on a regular basis.

Staff will continue to update the Commission as the project progresses.

Hello,

I would like to bring to your attention and log a formal complaint about the excessive noise from the training flights at the Torrance airport which have been increasing over the past few months. I had been told in a previous email from the Community Development Dept that they recommend pilots conduct training exercises to the north whenever possible. I have also reviewed the letter from Sling to the Airport Commission where they noted that they have asked all of their pilots to voluntary avoid training in the South Pattern. Neither of these seem to be happening for whatever reason.

On top of that, without a noise monitoring system in place, the airport has become a nuisance and terrible neighbor to its tax paying citizens. There are many days where the planes will circle directly over the houses in the Torrance Riviera for hours on end with 7-10 continuous touch and go loops. In addition to the noise pollution, several seem to be flying dangerously low for a high-density residential area (600-800' altitude when tracked with flight tracking app). Attached are a few recent pictures showing how low they fly when training over the south loop.

While I understand living near an airport will come with expected noise, the increase in the amount of flight schools using the airport and weekly training over the south loop has resulted in prolonged exposure to loud and excessive noise that negatively impacts overall health and wellbeing.

I, along with several neighbors, will be joining the Airport Commission Meeting on July 12th to voice a complaint there as well. I ask that you seriously consider solutions to address this request to make noise mitigation a serious consideration for the residents of Torrance. I look forward to hearing your response.
