8A. Consideration of PRE22-00003, WAV22-00003: MELISSA REYES (LOVETTE MIONI)

Planning Commission consideration for approval of a Precise Plan of Development to allow the construction of a new two-story single family residence, in conjunction with a Waiver of the minimum rear yard setback requirement and the average front yard setback requirement, on property located within the Hillside Overlay District in the R-1 Zone at 167 Via la Circula. This project is Categorically Exempt from CEQA per Guidelines Section 15303 – New Construction and 15305 – Minor Alterations. (Res. Nos. 22-044, 22-045)
