MINUTES OF A REGULAR MEETING OF THE AIRPORT COMMISSION

1. CALL MEETING TO ORDER

The Torrance Airport Commission Agenda convened in a regular session at 7:00 p.m. on Thursday, July 14, 2022, via teleconference.

ROLL CALL

2. FLAG SALUTE

Commissioner Witherill led the Pledge of Allegiance.

3. REPORT FROM THE AIRPORT STAFF ON THE POSTING OF THE AGENDA

Chair O'Brien and Facility Operations Manager Pinela reported that the agenda was posted on the Public Notice Board at 3031 Torrance Boulevard and on the City's Website on Wednesday, July 6, 2022.

4. ANNOUNCEMENT OF WITHDRAWN, DEFERRED, AND/OR SUPPLEMENTAL ITEMS

Facility Operations Manager Pinela stated that Supplemental Items were posted online.

5. ORAL COMMUNICATIONS

Commissioner Cohen thanked Commissioner Witherill for his report on helicopters during the previous meeting and requested that more informative / educational reports are presented at Commission meetings.

Chair O'Brien acknowledged the letters that came in regarding Torrance Airport noise and stated that the letters had been read. Chair O'Brien stated that there's a pilot lead initiative to reduce unnecessary noise at the Torrance Airport.

Chair O'Brien acknowledged the women who gathered data on Torrance Airport noise and who flew the south pattern to gather additional data. Chair O'Brien welcomed the public to contact her to learn more about aircrafts, aircraft noise, the patterns, the National Aerospace Standards, and how airplanes work.

Members of the public spoke.

Facility Operations Manager Pinela stated that Staff has been working on the trash situation on the east tees and around the Torrance Airport.

6. CONSENT CALENDAR

6A. APPROVAL OF MINUTES: JUNE 9, 2022

<u>MOTION</u>: Commissioner De Rago moved to approve the June 9, 2022 minutes as amended. Commissioner Gong seconded the motion. A roll call vote reflected unanimous approval.

7. <u>ADMINISTRATIVE MATTERS</u>

7A. <u>ACCEPT AND FILE MONTHLY UPDATE OF AERONAUTICAL OPERATIONAL INFORMATION UNDER THE PURVIEW OF THE GENERAL SERVICES DEPARTMENT</u>

City of Torrance Airport Manager Herrera reported a monthly update of aeronautical operational information under the purview of the general services department for the month of June 2022:

- There are 6 vacancies for hangars and 59 tiedowns available.
- Specifications for the AWOS system continues; Staff has met with the FAA and electrical contractors and held a job walk May 26, 2022, meeting with several contractors during a mandatory meeting for contractors interested in the project.
- The hangar waitlist, non-aviation waitlist, and meeting room schedule continue to grow.
- There was one incident May 26, 2022 (Cessna citation) resulting in a grazed hangar and broken beacon light; an FBO mechanic made repairs.

Commissioner De Rago inquired if pilots on a month-to-month lease can service their planes at tiedown locations. City of Torrance Airport Manager Herrera replied that mostly, planes are not serviced at the tiedowns, but occasionally light maintenance does take place.

Commissioner De Rago inquired where pilots who lease month-to-month service their planes. City of Torrance Airport Manager Herrera replied that planes are taken to the maintenance shop.

Commissioner Gong requested that a correction be made to the report regarding a discrepancy on the May 2022 Operations Graph. City of Torrance Airport Manager Herrera replied and acknowledged the request.

Commissioner Cohen inquired who, out of aviation and non-aviation tenants, had priority on the hangar waitlist. City of Torrance Airport Manager Herrera replied that aviation would have priority.

Rick Bohner inquired if non-aviation use hangars had reservations for non-aviation use only. City of Torrance Airport Manager Herrera replied that priority would be given to tenants who have aircrafts, but if there is no use for hangars, opportunities for non-aviation use would be available. Facility Operations Manager Pinela clarified that small hangars would only be available for non-aviation use; medium and executive hangars would not qualify.

<u>MOTION</u>: Commissioner De Rago moved to accept and file Item 7A, the Monthly Update of Aeronautical Operational Information report. Commissioner Cohen seconded the motion; a roll call vote reflected unanimous approval.

7B. <u>COMMUNITY DEVELOPMENT – ACCEPT AND FILE TORRANCE MUNICIPAL</u> AIRPORT (ZAMPERINI FIELD) NOISE ABATEMENT UPDATE

Environmental Quality Officer Nora Duncan presented an update on the noise abatement system:

- Radios and ATC recorder have been installed in the noise abatement office and recordings are being loaded in the CASPER noise application.
- All 7 monitors have been installed and are in testing mode.
- Radar, FAA System, and System Wide Information Management data (SWIM) are in operation.
- Staff is working with CASPER to develop the noise lab community outreach page; demonstrations will be provided August 2022.
- The first week of August 2022, Staff will be fully trained on the CASPER system.
- The CASPER team has committed to provide insight and demonstrations August 11, 2022; Environmental Quality Officer Nora Duncan stated that she will coordinate with City of Torrance Airport Manager Herrera and Facility Operations Manager Pinela on this.

Commissioner De Rago inquired when CASPER would be fully operational. Environmental Quality Officer Nora Duncan replied that an exact date has not been set in place, but by the evening of the August 11, 2022 presentation, the system should be live.

Commissioner De Rago inquired how the public would be informed about the presentation. Environmental Quality Officer Duncan stated that Staff is working to get information out via social media and City cable. Environmental Quality Officer Duncan stated that there are no plans to present to City Council at this time, but a presentation can be given upon request.

Commissioner De Rago requested to have the Airport Commission webpage updated with current information.

Community Development Director Ramirez stated that Staff is putting together a Torrance Airport website for easier access to information pertaining to the Torrance Airport.

Commissioner Witherill inquired if the 7 monitors are new and if they're in the same location. Environmental Quality Officer Duncan replied and confirmed that all monitors are new and are in the same location.

Commissioner Cohen inquired if the reports from the new noise abatement system would be reviewed by the Commission. Environmental Quality Officer Duncan replied that reports based on violations, complaints, and quarterlies will be available in quarterly reports and on the public-facing noise lab page.

Liz H. voiced her concerns on the noise from the Torrance Airport and inquired what will be done and when.

Judy Brunetti inquired at what decibel level is a violation recorded on the new noise monitors. Environmental Quality Officer Duncan replied that any noise above 65 decibels will trigger a recording; this decibel is not a violation. Notices of the violation will be sent to the pilot

and Staff will work with the pilot to correct the issue; if the issue is not corrected the pilot will go before a hearing board. If a pilot is guilty three times in a three-year period, they will be banned from the Torrance Airport.

Donald inquired who would be enforcing the violations and what the discipline process entails. Environmental Quality Officer Duncan replied that the Community Development Environmental Division will be enforcing the violations.

Commissioner De Rago inquired who set the violation decibel levels. Environmental Quality Officer Duncan replied that violation decibel levels were set in 1977 after an extensive study. Commissioner De Rago inquired if the decibel levels were in line with other neighboring airports.

Commissioner Witherill inquired if the noise abatement system could be contacted by pilots to get a report on what their noise levels would be. Environmental Quality Officer Duncan replied that noise tests had been done in the past and Staff can investigate getting this to the public and pilots again.

Chair O'Brien inquired if noise tests were available currently and if pilots could call right away, call ahead of time, or call and leave a message. Environmental Quality Officer Duncan replied that pilots would need to call ahead for a noise test.

James Pickard stated that more people work from home and are affected by the Torrance Airport noise; Pickard suggested the Commission do a review of the decibel levels in place currently.

Tom inquired why pilots aren't fined. Environmental Quality Officer Duncan replied that Torrance Codes are not written to fine pilots, it was written to correct pilots, if that didn't work, pilots would be banned after continuance of violations.

Chair O'Brien stated that pilots at the Torrance Airport are working on methods to reduce the noise being generated and offered a presentation to show the community; Chair O'Brien inquired if the Commission would be interested in hearing the solutions the pilots are working on. The Commission replied and agreed to hear a presentation.

Commissioner De Rago requested that the noise reduction presentation offered by the pilots at Torrance Airport be agendized for the August 2022 Commission meeting.

Commissioner Cohen inquired if the presentation could be placed on the City Council agenda and if it could be presented to City Council members due to the bigger impact it would have. Chair O'Brien replied that the presentation could be placed on both the City Council and Airport Commission agenda and presented August 2022.

Facility Operations Manager Pinela stated that agendizing anything outside Item 7B would have to be brought under Oral Communications during the August 2022 meeting; no concurrence can be made that's not related to Item 7B.

<u>MOTION</u>: Commissioner De Rago moved to accept and file Item 7B, Torrance Municipal Airport (Zamperini Field) Noise Abatement Update. Commissioner Gong seconded the motion; a roll call vote reflected unanimous approval.

Engine failure or damage limited to an engine if only one engine fails or is damaged, bent fairings or cowling, dented skin, small punctured holes in the skin or fabric, ground damage to rotor or propeller blades, and damage to landing gear, wheels, tires, flaps, engine accessories, brakes, or wingtips are not considered "substantial damage".

SERIOUS INJURY means any injury which: (1) requires hospitalization for more than 48 hours, commencing within 7 days from the date the injury was received; (2) results in a fracture of any bone (except simple fractures of fingers, toes, or nose); (3) causes severe hemorrhages, nerve, muscle or tendon damage; (4) involves any internal organ; or (5) involves second or third degree burns; or any burns affecting more than 5% of the body surface.

<u>INCIDENT</u>: Any occurrence other than an accident associated with the operation of an aircraft, which affects or could affect the safety of operations.

NOTE: Per the FAA, Airport Operations totals will no longer be reported for the previous month. Due to automation, the totals will now be reported two months after they occur.





Thank you for bringing this to our attention, we apologize for the delay in our response. While there have been no official changes to the flight patterns, Noise Abatement staff is aware of the increase in flights over the New Horizons neighborhood while the North Pattern is being used for training. Airport staff and Noise Abatement staff are currently doing outreach with flight schools in Torrance and outside airports, the Pilot's associations, and the local FAA Control Tower in order to lessen the disturbance to residents while we complete the installation of the new noise abatement system. Part of this outreach is to redirect training to the commercial/industrial area north of the airport, while avoiding the residential areas. We are hoping this outreach will create a better relationship between the Airport and the surrounding community on a more permanent basis. Once our new Noise Abatement system is operational, we will be able to investigate noise violations and follow up with the pilots. While we will be able to address violations of the Torrance municipal code, especially concerning noise levels, we do not direct pilots where to fly and/or how high to fly. Our current outreach is an effort to work with the pilots to be more mindful of the surrounding residential communities while using our airport.




Dear Members of the City Council,

First let me start by thanking you for your service to the community. I would also like to preface this email by saying that I am NOT "anti-airport", or against private aviation in any way as I have seen some angry or concerned residents labeled as such in the online "Nextdoor" community in regards to this very subject. I do respect the history and presence of the Zamperini Field, and have enjoyed the old air shows, the Collings Federation vintage weekends, the Tiger Squadron practices, and just watching all the different private planes come and go on their daily journeys.

When my wife and I purchased and moved to Paseo De Las Tortugas up on the hillside in 1996 we were told that it is illegal (or against regulations) for pilots to turn south after takeoff until they reached the coast due to elevation safety and noise issues. This did appear to be true, as for decades it remained as such and the noise was very manageable and reasonable as to what could be expected living in sight of an airport. We had no problems whatsoever and things seemed to be ok for all during this time.


Very recently however "something" changed. I do not now know what, or how, or by whom, but that decades-standing regulation of not turning south right after takeoff has been entirely abandoned and now the lid has been blown completely off. We are now directly under the flight path and the constant noise is clearly touch-and-go training that the local flight schools are now performing (turning both north and south loops). And by using a flight scanner it's apparent that flight schools from all across SoCal are also coming down to Torrance to exploit this new freedom for their own touch and go loops. We are now experiencing up to a hundred passovers a day, or more, for about 10 hours, 6 days a week, and some on Sundays. It is essentially a constant noise pollution, with very little---if-any—relief until 8pm or so, and as my wife and I both work from home requiring at least a reasonable amount of concentration it has made being in our own home miserable and is greatly affecting our every day lives. This screenshot is just an example, one plane, but this was just over about 30 minutes or so. You can extrapolate this out with multiple planes running all day long (the black dot represents us):






Aside from the noise which has become a form of torture upon ours and the adjacent neighborhoods to the south, we are at least 300 hundred feet above sea level, and the planes are passing over much closer to us than what appears to be stated in their regulations. I'm not privy to this exact info, but I do know that a plane that passes over you at 1000 feet vs one that passes over you at 500 or 600 feet sounds and feels different and often looks too close for comfort. The best example I can show was a couple nights ago we saw one coming right towards our house, and while I couldn't get a picture in time, I was able to track him and confirm that he was well below where he should have been. These screenshots show his elevation at 800 ft above sea level as he passed over us once, and then again up to Valmonte which is even higher than we are. At just a few hundred feet above us this is absolutely way too low but is just one example of what we are experiencing on a daily basis:











This particular pilot had passed over too low a few times and had also had apparently come from Riverside flight school to do his loops:


Thanks for the meeting last night. I'm eager to engage directly with the noise monitoring system.

Honorable Councilmen Mattucci and Griffiths:

Airport noise is primarily concentrated in your districts. The City Council last considered the issue four months ago. At that time the Council approved a number of motions including asking legal to explore options for enforcement of the city's "no left turn" law and requesting that staff obtain a formal written opinion from the FAA as to their position. We have been told nothing about the status of either of these motions. It has been THREE YEARS since staff suspended enforcement of the city's no left turn law (TMC Section 51.2.3) in order to revisit its legal authority. The city has had plenty of time to resolve the legal issue but has not done so.

The new noise abatement system is about to become operational (hopefully soon). We have heard that staff is meeting with tenants of the airport and preparing written informational materials. Presumably, the purpose of these meetings is to advise

pilots of the procedures to be implemented. However, the left turn rule is apparently still in limbo. This issue should be resolved before implementing the new system so that the city's policy is clear from the outset.

As shown on the attached five slides, the magnitude of this problem is growing significantly. Many of us are hoping you will exercise the leadership needed to resolve this issue without any further delay.

I am available any time to explain further and discuss any questions or comments you may have.

Good morning Mr. Svensson,

We apologize for the delay in response as we were short staffed due to the holiday season.

To address your concerns, there is currently not a noise abatement system in place so we are unable to verify if complaints regarding noise result in violations. However, in December, our City Council approved the installation of a new noise abatement system at the airport and we are working on execution of the installation at this time. We anticipate the installation to take a few months and once the system is in place and operational we will be able to investigate for noise violations.

The Torrance Airport is a General Aviation airport and does not keep a schedule for the aircraft using the airport, nor is there a limit on how many aircraft operations can be performed in a day. The Torrance Airport does however have certain curfews:

M-F departure curfews are 10pm-7am and Saturday and Sunday 10pm-8am.

Training curfew M-F 8pm-8am and Saturday no training before 10am or after 5pm. No training on Sundays or the following holidays: New Years Day, Memorial Day, Independence Day, Labor Day, Thanksgiving and Christmas.

Aircraft may land at the airport 24 hours a day, 7 days a week.

The Torrance Airport/Noise Abatement also do not determine the altitude or flight paths aircraft use. The authority to determine altitudes or flight paths is held by the FAA/Air Traffic Control and the pilot operating the aircraft. If you have concerns aircraft are flying too low, too frequently in an area, or flying in a dangerous manner we recommend contacting the FAA Flight Standards District Office at http://www.faa.gov/about/office_org/field_offices/fsdo/.
