MINUTES OF AN ADJOURNED REGULAR MEETING OF THE TORRANCE CITY COUNCIL

1. CALL TO ORDER

The Torrance City Council convened in an adjourned regular session at 5:35 p.m. on Tuesday, June 10, 2014 in the Council Chamber at Torrance City Hall.

ROLL CALL

Agenda Item 18 was considered out of order at this time.

18. <u>EXECUTIVE SESSION</u>

The City Council immediately recessed to closed session to confer with the City Manager and the City Attorney on agenda matters listed under 18A) Conference with Labor Negotiator, pursuant to California Government Code §54957.6.

The City Council reconvened at 7:08 p.m. with all members present. No formal action was taken on any matter considered in closed session.

2. FLAG SALUTE/ INVOCATION

The flag salute was led by Public Works Director Rob Beste.

The non-sectarian invocation was given by Monsignor Michael Meyers, St. James Church.

3. REPORT OF CITY CLERK ON POSTING OF THE AGENDA/ MOTION TO WAIVE FURTHER READING

City Clerk Herbers reported that the agenda was posted on the Public Notice Board at 3031 Torrance Boulevard on Friday, June 6, 2014.

City Librarian Theyer expressed appreciation to the Friends of Torrance Library for this generous donation, which will fully fund the online homework assistance program for three years.

- **7B.** June Lee, Torrance, wanted to alert residents that unattended donation collection bins that are proliferating throughout Torrance are operated by for-profit companies, not charities.
- **7C.** Janet Payne, Torrance, commented positively on the City Yard Open House/ Environmental Fair held at the City Yard on Saturday, June 7.
- **7D.** Ryan Mand, Torrance, asked about the appointment process to fill Councilmember Furey's position, which will be left vacant when he becomes mayor, and Mayor Scotto advised the process will be decided when the new City Council takes office on July 15.

12A. <u>MEASURE R PROJECT F-58: I-405 AT 182ND STREET/CRENSHAW BOULEVARD</u> OPERATIONAL IMPROVEMENT PROJECT

Recommendation

Recommendation of the Public Works Director that City Council:

- 1) Approve the South Bay Measure R Highway program funding agreement (#MOU.MR312.26) to be executed with Los Angeles County Metropolitan Transportation Authority ("LACMTA");
- Approve the Measure R project F-58, I-405 at 182nd St./Crenshaw Blvd. Operational Improvements Project, Infrastructure Action Plan (IAP) Project T 155 in the City's Capital Budget Plan; and
- 3) Upon approval of Funding Agreement with a total amount of \$15,300,000 appropriate Measure R funding and approve the updated IAP T 155.

Engineering Manager Semaan provided an overview of the I-405 at 182nd Street/Crenshaw Boulevard Operational Improvements Project.

Mark Stephenson, Torrance, requested clarification regarding the Measure R funding process, which was provided by Public Works Director Beste.

MOTION: Councilmember Brewer moved to concur with the staff recommendation. The motion was seconded by Councilmember Barnett and passed by unanimous vote.

12B. <u>APPROVAL OF CONCEPTUAL DESIGN AND FUTURE MAINTENANCE FOR</u> HOLLYWOOD RIVIERA GATEWAY PROJECT

Recommendation

Recommendation of the City Council Citizen Development and Enrichment Committee that City Council approve the proposed design and future maintenance of the Hollywood Riviera Gateway Project.

Engineering Manager Overstreet reviewed the proposed design for the Hollywood Riviera Gateway Project consisting of a planter and a sign in the median on Pacific Coast Highway at Monte D'Oro identifying the area as being Hollywood Riviera established in 1928. She reported that the Friends of Hollywood Riviera (FHR) has a benefactor who will pay the \$15,000 cost of the project and FHR has agreed to perpetually maintain the sign and planter with the City to continue mowing the area around it.

<u>MOTION:</u> Councilmember Brewer moved to concur with the committee's recommendation. The motion was seconded by Councilmember Barnett and passed by unanimous vote.

12C. RESOLUTION APPROVING FY2014-15 APPROPRIATIONS LIMIT AND SELECTION OF ANNUAL ADJUSTMENT FACTORS

Recommendation

Recommendation of the Finance Director that City Council:

- 1) Adopt a Resolution approving the City of Torrance appropriations limit for fiscal year 2014-15 in the amount of \$2,493,014,347; and
- 2) Select the percentage of change in Total Assessed Valuation Due to Non-Residential New Construction as the cost of living factor, together with the increase in the county's population, as the annual adjustment factors for the same fiscal year.

Sr. Administrative Analyst Eng reported that this action is necessary to comply with the Gann Initiative.

Mark Stephenson, Torrance, expressed concerns that Torrance's appropriations limit seems extremely high as compared to other California cities.

Finance Director Tsao advised that the cost factors used are provided by outside agencies and the City's calculations are checked by an independent auditor on a yearly basis, noting that calculations from past years are available for review in the City Clerk's office.

MOTION: Councilmember Brewer moved to concur with the staff recommendation. The motion was seconded by Councilmember Barnett and passed by unanimous vote.

RESOLUTION NO. 2014-74

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TORRANCE APPROVING THE 2014-15 APPROPRIATIONS LIMIT AND SELECTION OF THE ANNUAL ADJUSTMENT FACTORS FOR THE SAME FISCAL YEAR

MOTION: Councilmember Weideman moved to adopt Resolution No. 2014-74. The motion was seconded by Councilmember Furey and passed by unanimous vote.

12D. <u>CHANGE ORDER RE COMPRESSED NATURAL GAS FOR ALTERNATE FUEL VEHICLES</u>

Recommendation

Recommendation of the Transit Director and Public Works Director that City Council:

- 1) Authorize a sole-source purchasing agreement with Clean Energy Fuels Corporation of Seal Beach, California in an amount not to exceed \$2,064,218.75 to furnish Compressed Natural Gas (CNG) on an as needed basis from July 1, 2014 to June 30, 2015; and
- 2) Approve a change order to increase the amount of the agreement with Clean Energy Corporation of Seal Beach, California (2014-128) in the amount of \$15,000 for a new not to exceed amount of \$136,800.

Transit Administration Manager Mills reported that Clean Energy is the only company that has CNG fueling station within the boundaries of Torrance and that a second fast-fill CNG fueling station is currently under construction in the City Yard but it will not be operational until the end of 2014.

MOTION: Councilmember Brewer moved to concur with the staff recommendation. The motion was seconded by Councilmember Barnett and passed by unanimous vote.

12E. <u>ACCEPTANCE/APPROPRIATION OF FRIENDS OF TORRANCE LIBRARY DONATION</u>

12F. AGREEMENT RE RESIDENTIAL SLURRY SEAL PROGRAM AND ARTERIAL STREET PAVEMENT SEALING PROGRAM

Recommendation

Recommendation of the Public Works Director that City Council:

- 1) Determine that the approval of the Residential Slurry Seal Program, I-159 and Arterial Street Pavement Sealing Program, I-139 (B2014-21) is categorically exempt from environmental review pursuant to Section 15301(c) of the Guidelines implementing California Environmental Quality Act (CEQA);
- 2) Approve the plans and specifications for the Residential Slurry Seal Program, I-159 and Arterial Street Pavement Sealing Program, I-139 (B2014-21); and
- 3) Award a public works agreement to All American Asphalt for an amount not-to-exceed \$1,225,180 to construct the Residential Slurry Seal Program, I-159 and Arterial Street Pavement Sealing Program, I-139 and authorize a 10% contingency in the amount of \$122,518.

Project Engineer Stephanie Comon provided an overview of the Residential Slurry Seal Program and the Arterial Street Pavement Sealing Program. She noted that all residents and businesses affected by the work will be notified and the schedule will be posted on the Public Works website.

In response to questions from the Council, Public Works Director Beste provided clarification regarding the products to be used.

<u>MOTION:</u> Councilmember Brewer moved to concur with the staff recommendation. The motion was seconded by Councilmember Barnett and passed by unanimous vote.

12G. FIRST AMENDMENT TO PROPERTY DEDICATION AND CONTRIBUTION AGREEMENT TO REALIGN CITY BOUNDARY WITH ROLLING HILLS ESTATES

Recommendation

Recommendation of the City Manager that City Council approve the First Amendment to Property Dedication and Contribution Agreement by and between the City of Torrance ("Torrance"), a California charter city, Chandler Ranch Properties, LLC and BRI, LLC (collectively "Chandler").

City Manager Jackson reported that the City has been working on the proposed boundary realignment for some time, which will allow a new residential development to be constructed within the City of Rolling Hills; that the Local Agency Formation Commission (LAFCO) had concerns about the original proposal so the boundary between the City of Torrance and the City of Rolling Hills Estates has been adjusted; and that the new proposal provides for open space to create a buffer between existing homes in Torrance and the new development.

MOTION: Councilmember Barnett moved to concur with the staff recommendation. The motion was seconded by Councilmember Brewer and passed by unanimous vote.

12H. FIRST AMENDMENT TO BOUNDARY MODIFICATION AND ANNEXATION AGREEMENT WITH THE CITY OF ROLLING HILLS ESTATES

Recommendation

Recommendation of the City Manager that City Council approve a First Amendment to a Boundary Modification and Annexation Agreement ("Agreement") by and between the City of Torrance ("Torrance"), a California charter city, and the City of Rolling Hills Estates ("Rolling Hills Estates"), a California general law city.

Mark Stephenson, Torrance, requested clarification regarding the land swap involved in the boundary adjustment, which was provided by City Manager Jackson.

MOTION: Councilmember Brewer moved to concur with the staff recommendation. The motion was seconded by Councilmember Barnett and passed by unanimous vote.

12I. REVISED AND RETITLED CLASS SPECIFICATION FOR HUMAN RESOURCES TECHNICIAN AND RESOLUTION TO IMPLEMENT SALARY RANGE

Recommendation

Recommendation of the Civil Service Commission and the Human Resources Administrator that City Council:

- 1) Approve the revised class specification for the revised and re-titled class specification for Human Resources Technician; and

- 2) Adopt a Resolution approving a General Plan Amendment from Commercial Center to Medium Density Residential;
- 3) Adopt an Ordinance approving a Zone Change from P-1 (Open Area, Parking, Planting) to R-3 (Limited Multiple-Family Residential);
- 4) Adopt a Resolution approving the construction of a four-unit condominium development;
- 5) Adopt a Resolution approving a subdivision for condominium purposes; and
- 6) Approve an Ordinance Summary for publication.

Mayor Scotto announced that this was the time and place for a public hearing on this matter. City Clerk Herbers confirmed that the hearing was properly advertised.

With the aid of slides, Planning Manager Lodan briefly reviewed the proposed four-unit detached condominium project, noting that the site was formerly used as an off-site parking lot for the Switzer Center, which is no longer necessary because the Switzer Center has moved and the lot has been redeveloped with adequate on-site parking. He reported that the Planning Commission considered the project on April 2, 2014 and voted to approve it by a vote of 4-1, with 2 commissioners absent.

Councilmember Brewer expressed concerns about rezoning one parcel, and Planning Manager Lodan advised that staff believes residential use is most appropriate for this site because it is not large enough for a commercial development and it would be consistent with the residential neighborhood to the north and west.

Mayor Scotto asked about the location of trash bins, and Community Development Director Gibson reported that trash bins will be located off the alley but there may have to be modifications to landscaped areas next to the garages to accommodate them.

In response to Councilmember Ashcraft's inquiry, Randy Morris, project architect, confirmed that the existing curb cut on Sartori Avenue will be closed and all vehicular access to the site will be from the alley.

<u>MOTION:</u> Councilmember Brewer moved to close the public hearing. The motion was seconded by Councilmember Barnett and passed by unanimous vote.

<u>MOTION:</u> Councilmember Sutherland moved to approve the project, as conditioned, with the following modification:

Modify

No. 13 That the applicant shall verify if trash is to be collected by private hauler or City service and a trash enclosure shall be provided to the satisfaction of the Community Development Department and the Public Works Department.
