MINUTES OF A REGULAR MEETING OF THE TORRANCE COMMISSION ON AGING

1. CALL TO ORDER

The meeting convened on Tuesday, January 3, 2023 at 9:30 a.m. at the West Annex Commission Room at City Hall.

Recreation Services Manager Craig stated that Commissioner Snyder had requested an excused absence.

2. FLAG SALUTE

Commissioner Mayfield led the Pledge of Allegiance and Commissioner Hileman read inspirations provided by Irene Griffith.

3. REPORT OF THE CITY CLERK ON THE POSTING OF THE AGENDA

Recreation Services Manager Craig reported that the agenda was posted on the Public Notice Board at 3031 Torrance Boulevard and on the City's website on Thursday, December 29, 2022 by City Clerk Poirier.

4. ANNOUNCEMENT OF WITHDRAWN, DEFERRED, AND/OR SUPPLEMENTAL ITEMS

Recreation Services Manager Craig stated that there were supplemental items in the packet for Item 7B: Discussion of Older Americans Awards, which included a nominee form, a list of addresses for organizations which would receive the nominee forms and a list of past recipients.

5. ORAL COMMUNICATIONS

Recreation Services Manager Craig formally introduced Jesus Castro as the new Senior Supervisor for Senior Programs, Teen Programs, Adaptive Recreation Programs, Special Events, and Pre School-Programs. He thanked Charlene Walker for her assistance at the meetings during the recruitment process.

7A. DISCUSSION: JOINT COUNCIL/COMMISSION MEETINGS

Recreation Services Manager Craig noted that the joint meeting would take place on February 7, 2023 beginning at 4:30 p.m. with a meal and added that the meeting would begin at 5:00 p.m. and end by 6:00 p.m. He noted that the Council and the Commission would both provide brief agendas for the meeting. He suggested that the Older Americans award program be part of the discussion.

Chairperson Dojiri suggested that the agenda contain: the mission of the Commission, a discussion of last year's projects and items discussed under the monthly reports, as well as possible upcoming projects, such as the AARP Plan for an Age Friendly City.

Commissioner Grundhaus discussed Senate Bill 9 and explained that the City of Torrance had joined with Redondo Beach and Carson to fight the bill. She noted that the Cabrillo Family Apartments on Cabrillo Avenue had a wait list of over 500 people and Legacy Partners was proposing to build a 5-story, 200 unit apartment complex near Del Amo Circle. She stated that the Department of Housing and Development had determined that in the next 8 years, Torrance would need 2467 housing units reserved for very low-income individuals with 2472 units reserved for moderate income.

Recreation Services Manager Craig reported that the Gable House project had been approved with 186 apartments units, of which 26 would be reserved for low-income.
