RECOMMENDATION

The Public Works Director recommends that the Traffic Commission receive and file a report from staff and obtain public input regarding a proposal to establish a permit parking district in the Hollywood Riviera neighborhood west of Palos Verdes Boulevard.

BACKGROUND

In early 2022, residents of Paseo de la Playa reported increasing incidents of long-term vehicle parking with overnight occupation, specifically on the west side of Paseo de la Playa between Calle Miramar and Via Riviera. The Traffic Commission met three times about the issue (April 4, 2022, May 2, 2022 and September 6, 2022). Staff implemented nighttime parking restrictions to eliminate overnight parking; however, those restrictions were subsequently removed due to receiving complaints of reduced parking availability for residents and also a relocation of the problem of long-term vehicle parking with overnight occupation to other nearby streets. Establishment of an overnight permit parking district was proposed to mitigate these issues. Tonight's meeting will discuss the proposed permit parking district and boundaries.

The following is a chronology of previous events related to the issue:

April 4, 2022 Traffic Commission Meeting

On April 4, 2022, the Traffic Commission took public input regarding long-term vehicle parking on Paseo de la Playa with overnight occupation. Staff proposed implementation of overnight parking restrictions on the west side of Paseo de la Playa between 9:00 p.m. to 5:00 a.m. which is consistent with parking restrictions on the Esplanade between Knob Hill Avenue and Vista del Mar in the City of Redondo Beach. Comments from the public focused primarily on safety, sanitation and parking impacts. Several residents requested permit parking. Others requested that the proposed overnight restriction time be revised to better accommodate residential visitors.

May 2, 2022 Traffic Commission Meeting

On May 2, 2022, the Traffic Commission took public input regarding the proposal to restrict parking on the west side of Paseo de la Playa between 1:00 a.m. to 5:00 a.m. The time period of the restrictions was changed to accommodate concerns expressed at the April 4, 2022 meeting. Again, there were resident requests at this meeting to establish a permit parking district.

July 11, 2022 Installation of Overnight Parking Restriction Signs

On July 11, 2022, the Public Works Department installed signs prohibiting parking from 1:00 a.m. to 5:00 a.m. on the west side of Paseo de la Playa between Calle Miramar and Via Riviera. There is no parking allowed on the east side of Paseo de la Playa. Police began enforcement after a two-week grace period.

Immediately following the installation of signs to prohibit overnight parking from 1:00 a.m. to 5:00 a.m., staff received positive comments from residents that the issue of overnight occupation of vehicles parking on Paseo de la Playa was resolved. However, significant negative impacts occurred including: a) the lack of overnight parking for residents on Paseo de la Playa; and b) the movement of long-term and vehicles with overnight occupation to other nearby streets in the neighborhood, particularly Via Riviera and Paseo de la Concha. Essentially, the implementation of the overnight parking restriction on Paseo de la Playa resulted in moving the problem to other streets.

August 25, 2022 Removal of Overnight Parking Restriction Signs

The Public Works Department investigated the residents' concerns and determined that immediate removal of the parking restriction signs was required. The Police Department was notified and the signs were removed on August 25, 2022.

September 6, 2022 Traffic Commission Meeting

On September 6, 2022, the Traffic Commission held a third meeting to obtain public input regarding on-street parking conditions on Paseo de la Playa between Calle Miramar and Via Riviera. Since the initial attempt to mitigate long-term and overnight vehicle occupation by prohibiting overnight parking on Paseo de la Playa resulted in unacceptable and negative impacts, the City introduced an alternative to implement a permit-parking program in the area to provide an area-wide resolution.

ANALYSIS

Tonight's Traffic Commission Meeting is to obtain public input regarding the proposal to implement a permit parking district in the Hollywood Riviera neighborhood to provide an area-wide resolution to long-term vehicle parking and overnight vehicle occupation, including the related negative impacts.

Choosing the proper limits of the proposed permit-parking district is critical to avoid moving the problem to other streets. Staff is recommending that the entire residential area of Torrance west of Palos Verdes Boulevard (See map Attachment 1) be considered for the district as we believe it would discourage movement of the problem to nearby streets. In this area, only vehicles displaying parking permits would be permitted to park from 9:00 p.m. to 6:00 a.m. This timeframe is most consistent with the existing overnight parking restrictions (9:00 p.m. to 5:00 a.m.) in place on the Esplanade in Redondo Beach as well as the hours of operation [6:00 a.m. to 8:30 p.m. (April 1st to October 31st) and 6:00 a.m. to 6:30 p.m. (November 1st to March 31st)] for the public parking lot maintained and operated by Los Angeles County Department of Beaches and Harbors that is adjacent to Paseo de la Playa. Tonight, we want to hear what the public thinks about this proposal.

The proposed permit-parking district is within the Coastal Zone overseen by the California Coastal Commission (CCC). The goal of the CCC is to maintain or enhance coastal access. Staff recently spoke with the CCC to ask about their requirements related to this issue. The CCC does not have defined written policies related to permit parking in the Coastal Zone and

could not provide definitive guidance that was consistent for all beach cities within the Coastal Zone. Consequently, staff has configured a proposed permit parking district in Torrance that will, at minimum, maintain general public/coastal access to the coast in keeping with CCC goals. The proposed permit-parking district would only restrict parking from 9:00 p.m. to 6:00 a.m., which is less restrictive than the hours of operation for the parking lot operated by Los Angeles County Department of Beaches and Harbors. Essentially, public parking would be allowed during primary hours of coastal use. In addition, the City firmly believes that the creation of a permit parking district would actually enhance coastal access because it will eliminate problematic long-term vehicle parking with overnight occupation that extends into primary hours of public use of the coastal zone, thereby restricting access by others to coastal zone. That access is further impacted by the recurring negative impacts of recurring unsanitary conditions, unpleasant odors and trash.

The permit-parking program would involve the following:

- 1. **All vehicles** would be subject to weekly street sweeping parking restrictions as is the case today.
- 2. **All vehicles** would be subject to the 72-hour parking restriction per the California Vehicle Code as is the case today.
- 3. Vehicles **without parking permits** would be subject to a parking restriction for a specified period of the day (i.e. 9:00 p.m. to 6:00 a.m.).
- 4. Vehicles **with parking permits** would be exempt only from the parking restriction mentioned in item 3 above.

Torrance Municipal Code Section 61.6.32 RESIDENTIAL PERMIT PARKING governs implementation of residential permit parking districts. Implementation would require significant costs to the City including but not limited to enforcement, administrative, and associated material costs to place signs and issue permits. The process is extensive and would not be implemented immediately. The item would require public hearings, City Council approval, and changes to the municipal code by ordinance.

At tonight's meeting, only public input will be taken. No decisions related to the proposed parking permit program will be made.

A public notice notifying residents of tonight's meeting (Attachment 2) was mailed to 436 parcels in the area west of Palos Verdes Boulevard to the northerly, southerly and westerly City limits. The public notification area is shown in Attachment 3.







Dear Honorable Traffic Commissioners,

We're sorry we are not able to attend the meeting and provide input in person regarding a proposal to implement permit parking in the area of West of Palos Verdes Blvd. to the Westerly city limits.

We live at _____, and have observed the challenges with non-residents using our street as long term parking. Here are some of our observations:

- Trash collection, becomes challenging because cars tend to park very close to our trash bins after we have put the bins out for trash collection. Very often we are even unable to put our trash bins out in front of our house because of parked cars.
- Street cleaning is also met with obstacles, because non-residents tend not to be familiar with street cleaning days and they don't move their cars. So our streets end up being dirtier than they should be.
- We've observed some people have multiple cars and they use our street to store their cars.
- Some of the same people work on their cars in the street because the cars tend to be in not the best shape.
- We have heard that some pick up trucks have had items stolen out of their beds while parked on our street, our fear is that having these cars sitting long term on our street, draws the criminal element looking for an easy score.
- Trucks and vans park extremely close to our driveway even though we have the 3 foot red curb painted. This makes it very difficult to see if there's any oncoming traffic when we pull out of our driveway in the morning or evening, and as you know, there's a lot of bicycle traffic on our street as well. This is a serious concern and dangerous. (Please see photo attached from tonight)
- We have had trash thrown into our yard from these parked cars.
- It also seems that there are some people that are living in their vans on our street.

We look forward to the study and a proposal for permit parking.

Dear Commissioners,

We received the notice of the proposed permit parking in the lower Hollywood Riviera neighborhood and are in full support. Since we are unable to attend the public input meeting on February 6th we are sending our comments by email.

When the Traffic Commission put up the no parking signs between 1 am - 5 am last year on Paseo de la Playa it did not address a few issues that came up which alarmed and frustrated residents. First, the vans just relocated from Paseo de la Playa to Via Riviera and residents of the area were unable to use the parking spots during the night.

If the permit parking is only required between 1 am- 5 am it will allow beach access to everyone during the day and visitors of the residents of the neighborhood. It will also limit the amount of time the area needs to be patrolled by parking enforcement to a few hours during the middle of the night which should relieve the concern of adding additional hours needed by the parking enforcement agency. The only cars parked on the street would be residents with parking permits. This would also be an additional source of revenue for the city.

We love our neighborhood and community but are concerned about the sanitation issues that arise with people living in their vans cause. The public restrooms are not open at night.
