A. The following pay is hereby assigned to Fire Recruit **Effective January 29, 2023**

Fire Recruit	1	40.54	7,027.63	84,331.52

The Fire Trainee hourly rate shall be set at the annual rate of Step 1 of 56-Hour Fire Fighter divided by 2,080 hours.

B. The following pay is hereby assigned to Police Trainee *Effective November 20, 2022* 

Classification	Step	Hourly	Monthly	Annual
Police Trainee	1	42.00	7,280.00	87,360.00

The Police Trainee monthly salary shall always be the same as Step 1 of Police Officer, rounded to the nearest dollar.
