TMC section 51.5.5, Prohibited Operations on Weekdays, prohibits training, stop and go, touch and go, and low approaches between 8PM on one day and 8 AM of the following day, Monday through Friday inclusive.

VIOLATION

This hearing is convened to consider a violation of the Torrance Municipal Code by aircraft N294JY, a Sling, piloted by Rodney Carter II.

- Date of Violation: June 14, 2023
- Operation: Closed traffic
- Runway: 29 Right
- Violation of Torrance Municipal Code 51.5.5

(See Attachment B for Enforcement Report)

On June 14, 2023, at 21:18, aircraft N294JY announced to any local flights in the area, the Torrance Air Traffic Control Tower was closed at this time, that he would be departing runway 29 (two-nine) Right for closed traffic. "Closed traffic" is a term frequently used to describe training patterns and operations. The violation occurred on departure and subsequent training operations. (See Attachment C for LAX Webtrak map). The Noise Abatement recordings revealed no indication from the pilot that an emergency or other flight difficulty existed.

On August 2, 2023, staff discovered an error in the pilot's name. A corrected Notice to Appear for the August 10, 2023, Noise Hearing Board was sent via standard and certified mail and email to the pilot Rodney Carter II.

On August 3, 2023, No contact from pilot.



RECOMMENDATION

Recommendation of the Torrance Airport Noise Abatement Office that the Airport Noise Hearing Board render a finding of guilt for pilot, Aryan Mashayekhi, for a violation of the prohibited operations on Sunday for training, stop and go, touch and go and low approaches that occurred on June 11, 2023.

BACKGROUND

Sections 51.5.5, 51.5.6 and 51.5.7 of the Torrance Municipal Code (TMC) establish the allowed times for training, stop and go, touch and go, full stop-taxi back and low approaches for aircraft taking off from the Torrance Airport (TOA). TMC section 51.5.7, Prohibited Operations on Sundays and Holidays, prohibits training, touch and go operation, stop and go operation or low approach operations on the Airport on Sundays, nor on any of the following holidays: New Year's Day, Memorial Day; Independence Day, Labor Day, Thanksgiving Day and Christmas Day.

VIOLATION

This hearing is convened to consider a violation of the Torrance Municipal Code by aircraft N148AC, a Sling, piloted by Aryan Mashayekhi.

- Date of Violation: June 11, 2023
- Operation: Taxi-back and training pattern
- Runway: 29 Left
- Violation of Torrance Municipal Code 51.5.7

(See Attachment B for Enforcement Report)

On June 11, 2023, at 15:42, aircraft N148AC requested taxi-back to runway 29 left from Ground personnel and was granted the taxi-back. Pilot then requested "left closed traffic" from Torrance Tower. Tower personnel approved a takeoff on 29 left, then advised the pilot that he was clear for the "options.". "Closed traffic" and "option" are terms frequently used to

describe training patterns and operations. The violation occurred on departure and subsequent training operations. (See Attachment C for LAX Webtrak map). The Noise Abatement recordings revealed no indication from the pilot that an emergency or other flight difficulty existed.

(See attachment D for transcript of communication from the pilot.)

On July 10, 2023, the Owner and presumed pilot was notified of the violation and Pending Noise Hearing Board on July 27, 2023, via standard and certified mail.

On July 17, 2023, the pilot was notified of the change of date for the Noise Hearing Board to August 10, 2023, via standard and certified mail.

On July 27, 2023, Pilot Aryan Mashayekhi came into the Permit Center and spoke to staff, Nora Duncan, and Hilda Colclasure. Pilot said that he was in violation and asserted that it would not happen again. Pilot asked if it would be "worth it" to attend the meeting since he was admitting to being guilty. Staff Duncan advised that the Board members make the decisions on whether or not a pilot is guilty and it is always worth it to be heard by the Board.

There is no previous Hearing Board history for the aircraft or pilot/owner.

EXCEEDANCE HISTORY

The Pilot has been informed of City airport regulations. As of July 2023, N148AC had no other prohibited operations violations.

TEST HISTORY

The is no current test history.

TORRANCE NOISE OFFICE RECOMMENDATION

Based on the evidence presented we recommend that pilot Aryan Mashayekhi be found in violation of Torrance Municipal Code section 51.5.7 on June 11, 2023, while piloting aircraft decathlon N148AC.


