#### 7. ADMINISTRATIVE MATTERS

#### 7A. PRESENTATION: COMMUNITY SERVICES, JOHN LA ROCK, CITY FIREWORKS SHOW

Community Services Manager La Rock presented Item 7A.

- Commissioner Seferian joined the meeting at 7:04 p.m.
- Drones, an alternate to fireworks, have been explored. Research found that at least (2,500) drones would need to be used to have an impact / view corridor; drones have a flight time of 9-12 minutes and would need to switch out periodically. Drone shows are priced double that of firework shows, are typically choreographed with a one direction viewing, and has no audio component (audio would be a separate cost).
- Staff creates an RFP for firework shows every year and includes a drone analysis that's provided to City Council for their input.
- All personal fireworks are illegal in the City of Torrance.

Members of the Commission spoke.

Chair Stecker expressed his concerns on the effects fireworks have on pets, wildlife, individuals with PTSD, and smoke and air pollution. Community Services Manager John La Rock replied that drone technology will continue to evolve and could be an aspect of the Fourth of July show; ultimately, it's the City Council's discretion.

No members of the public spoke.

#### 7B. PRESENTATION: CLIMATE SMART AWARD RECIPIENT JIM MONTGOMERY, WATER

Mr. Jim Montgomery, Water Climate Smart Award recipient, provided a presentation, sharing his water conservation methods.

- Artificial lawns are not smart, use of drought tolerant, water efficient, wildlife friendly California native plant landscape was suggested. There are (6,500) plants native to California and the diversity of wildflowers can support the biodiversity of life.
- Mr. Montgomery suggested to revisit electrical lawn equipment instead of gas-powered equipment.
- Industrial-scale and animal-based agriculture have negative impacts on the environment (water, air, soil, farm workers, wildlife, and farm animals), the use of sustainable and plant-based agriculture that have no chemicals and herbicides was suggested. Mr. Montgomery noted that when your soil is healthy, it holds more water.
- Track water usage with a Flume system; strap the Flume system around the water main to measure various uses of water.

Members of the Commission spoke.

Commissioner Montoya inquired if newsletters about sustainability were available, and if not, suggested Mr. Montgomery coordinate with Community Development Director Ramirez to discuss monthly postings.

Commissioner Gunnar inquired on the Blue Zone Project and if the Commission would be interested in participating / getting additional information. Mr. Montgomery suggested that the City of Torrance tap into learning more on the Blue Zone Project.

Chair Stecker presented the award to Mr. Montgomery.

#### 7C. ACCEPT AND FILE - CITY YARD OPEN HOUSE UPDATE

Staff Liaison Duncan presented Item 7C.

 June 10, 2023, staff prepared a booth promoting the Environmental Quality and Energy Conservation Commission at the City Yard Open House and created an interactive survey on the most important item on the Strategic Plan; participants took part in the survey with the majority selecting Goal 5: Improvement of Water Reliability. Members of the Commission spoke.

Community Development Director Ramirez stated that the city puts on multiple events through the year and when the Environmental Quality and Energy Conservation Commission can participate, staff will inform the Commission.
