RECOMMENDATION

The City Librarian recommends the Library Commission accept and file the report regarding the Friends of the Torrance Library ("the Friends").

BACKGROUND/ANALYSIS

The Friends have been continually allied with the Library raising funds to support programming and materials purchases. With a dedicated group of volunteers, the Friends have sold gently used books at the Katy Geissert Civic Center Library continually and at larger book sales four times per year pre-COVID and three times per year after the buildings were reopened and COVID restrictions eased.

In fiscal year 2023-2024, the Friends donated over \$65,000 dollars to support annual programming, marketing and outreach, and the highly popular Summer Reading program. Thanks to those contributions, Library staff were able to offer:

- 201 Summer events for children, teens, and adults during the 2023 Summer Reading Program. This included bilingual and virtual programs featuring magic, animals, STEM, music, sustainability, and fitness, making it the largest summer programming the Library has offered.
- Continuing support for programming and equipment for use by library staff during the year. Purchases of programming supplies, author talks, and promotional materials help support engagement with the community and increase awareness of library resources.

Without the Friends, the Torrance Public Library would not be able to offer the rich diversity of resources to the community that make it the warm, welcoming space customers have come to enjoy for over five decades.
