1. CALL TO ORDER

The Torrance City Council convened in an adjourned regular session at 6:00 p.m. on Tuesday, May 7, 2002, in City Council Chambers at Torrance City Hall.

The Pledge of Allegiance was led by Councilmember Lieu.

City Clerk Herbers gave the invocation for the meeting.

5. COUNCIL COMMITTEE MEETINGS AND ANNOUNCEMENTS
