Mayor Pro Tem Scotto presented Resolution No. 2002-35 to former Councilwoman Marcia Cribbs, honoring her for her many years of dedicated service to the City of Torrance. Ms. Cribbs accepted with appreciation and thanked Dorothy Ellis of the City Manager's office for her work in drafting the resolution.

Mayor Pro Tem Scotto presented Resolution No. 2002-34 to former Mayor Dee Hardison, honoring her for her many years of dedicated service to the community. Ms. Hardison accepted with appreciation; commented on her activities since leaving office; and thanked those who have sent cards and letters.

#### 6c. PROCLAMATION RE "ASIAN/PACIFIC AMERICAN HERITAGE MONTH"

Councilmember Lieu read a proclamation declaring May 2002 as **Asian Pacific American Heritage Month**, in the City of Torrance, encouraging all citizens to celebrate Asian Pacific Americans for their remarkable role in our national heritage and culture.

Mayor Pro Tem Scotto presented the proclamation to Hazel Taniguchi, Sister City Association, who introduced Executive Director Christine Sato, Diane Tanaka and Terri Kuwahara of the "Go for Broke" Educational Foundation, along with WWII Veterans, Mas Takashi and Bob Ichikawa. Ms. Taniguchi commented on the many multi-cultural activities in Torrance and noted that on May 30, 2002, the Japanese-

American Historical Society of Southern California would be sponsoring a program at the Katy Geissert Civic Center Library featuring authors of *The Resettlement Years* 1945 – 1955.

# 70. <u>AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT WITH</u> MWH AMERICAS, INC.

#### Recommendation

Recommendation of the **Engineering Director** that City Council:

- Approve an Amendment to an existing Professional Services Agreement (SPO 00124) with MWH Americas, Inc., for a twelve-month extension of contract term for technical support and construction observation services during the design and installation of the City's Supervisory Control and Data acquisition System, a computer and telemetry system that will monitor and control the water, storm drain, and sewer facilities;
- 2) Authorize staff to prepare an Amendment for a twelve-month extension of contract term; and

Recommendation of the **City Manager** that City Council renew a General Services Agreement with the County of Los Angeles for a five-year period commencing July 1, 2002 through June 30, 2007.

Mayor Pro Tem Scotto noted supplemental material consisting of a resolution authorizing the renewal of the General Services Agreement with Los Angeles County.

#### **RESOLUTION NO. 2002-52**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TORRANCE AUTHORIZING THE EXECUTION OF A FIVE-YEAR GENERAL SERVICES AGREEMENT WITH THE COUNTY OF LOS ANGELES.

<u>MOTION:</u> Councilmember Witkowsky moved for the adoption of Resolution No. 2002-52. The motion was seconded by Councilmember McIntyre and passed by unanimous roll call vote (absent Councilmember Nowatka and Mayor Walker).

# 8. COMMUNITY SERVICES

# 8a. MCMASTER PARK REDEVELOPMENT PROJECT

# Recommendation

Recommendation of the **Finance**, **Parks and Recreation**, and **Library Directors**, **Police Chief**, and the **City Engineer** that City Council:

- 1) Adopt an authorizing Resolution with the California State Library Department for the City's California Public Library Construction and Renovation Bond Act grant application related to Phase I of the McMaster Park Redevelopment. The resolution will certify the project budget at \$7,565,576.20 and identify the City's matching funds identified in the Library program budget in an amount of \$1,922,565.83 including \$1,295,000 to be credited to the City for the acquisition of land, and \$2,072,530.99 in supplemental funds necessary to complete the project; and
- 2) Approve the funding strategy for the McMaster Park Redevelopment Project creating FEAP #293.

With the aid of slides, Administrative Analyst Witzansky provided background information about the McMaster Park Redevelopment Project; outlined the project's three phases; and discussed the funding strategy.

Parks and Recreation Director Barnett explained that the ability to apply for library grant funding was the impetus for moving this project forward and noted that it involves multiple departments as it will result in a new police community center, an improved North Torrance branch library, a new senior citizen center and relocated water facilities if the plans are realized. He noted that the project would be a nice complement to the Artesia Boulevard corridor improvements.

Councilmember Lieu asked if it would be possible to limit the project to Phase 1 should funding not be available for Phases 2 and 3.

Administrative Analyst Witzansky explained that the City would lose facilities should all three phases not be completed because some facilities scheduled to be demolished in Phase 1 will not be replaced until subsequent phases.

City Manager Jackson advised that if funding is received for the first phase, the City would likely be committed to do the second phase. He indicated that more information would be available regarding long-range implications when staff returns for approval of the funding.

Councilmember McIntyre asked about the City's chances of receiving a grant. Library Services Manager Weiner reported that at least 200 agencies will be applying for grant funds and that the City's chances were approximately 1 in 4.

In response to Councilmember Witkowsky's inquiry, Parks and Recreation Director Barnett confirmed that, once the Tillim Senior Center is demolished, arrangements will be made to house senior activities at a convenient location until the new one is constructed.

Responding to Councilmember Mauno's inquiry, Library Services Manager Weiner provided information regarding the judging of grant applications. Administrative Analyst Witzansky advised that the City's application would be strengthened by the fact that the project involves a multi-use facility.

Noting that he had seen a rendering of the project, Mayor Pro Tem Scotto commented that he thought it would be a great addition to North Torrance, along with Artesia Boulevard renovations, and that he hoped that all three phases could be completed.

<u>MOTION:</u> Councilmember Witkowsky moved to approve the project and funding for the McMaster Park Redevelopment Project in concept. The motion was seconded by Councilmember Mauno and passed by unanimous roll call (absent Councilmember Nowatka and Mayor Walker).

#### **RESOLUTION NO. 2002-49**

Recommendation of the **Engineering Director** that City Council approve and adopt a Resolution summarily vacating a portion of a water easement at the South Bay Galleria.

Engineering Director Burtt reported that this water easement has been superceded by relocation and is no longer needed.

# 11a. ADDITION OF JUNIOR LIBRARY CLERKS TO PERS HEALTH PLAN

#### Recommendation

Recommendation of the **City Manager** that City Council adopt a Resolution which adds the Junior Library Clerks to the Public Employees Medical and Hospital Care Act (PEMHCA).

Assistant to the Ctiy Manager Keane reported that the adoption of this resolution was the final step in the process to add Junior Library Clerks to the CalPERS system.

Mr. Alan Lee, Torrance Municipal Employees, AFSCME, Local 1117, thanked the Council for taking this action, which will allow Junior Library Clerks to have retirement benefits and health coverage.

#### **RESOLUTION NO. 2002-51**

A RESOLUTION BY THE TORRANCE CITY COUNCIL ELECTING TO BE SUBJECT TO PUBLIC EMPLOYEES' MEDICAL AND HOSPITAL CARE ACT ONLY WITH RESPECT TO MEMBERS OF A SPECIFIC EMPLOYEE ORGANIZATION AND FIXING THE EMPLOYER'S CONTRIBUTION AT AN AMOUNT AT OR GREATER THAN THAT PRESCRIBED BY SECTION 22825 OF THE GOVERNMENT CODE

<u>MOTION:</u> Councilmember Witkowsky moved for the adoption of Resolution No. 2002-51. The motion was seconded by Councilmember Mauno and passed by unanimous roll call vote (absent Councilmember Nowatka and Mayor Walker).

#### 11b. ASSIGNMENT AND ASSUMPTION OF AIRPORT PLAZA LEASE

# Recommendation

- b. Recommendation of the **City Manager** that City Council authorize the Mayor to execute and City Clerk to attest:
  - 1) An Assignment and Assumption of Lease from APA III LTD. to OMA Cerritos VB, LLC, a California limited liability company whose sole member will be OMA Cerritos Properties LLC, a California limited liability company; Staton VB, LLC, a California limited liability company whose sole member will be Staton Investment Co., a California general partnership; and Airport Venture 2002 LLC, a California limited liability company whose managing member will be Norman R. La Caze; all as

- tenants in common concerning City owned property currently known as Airport Plaza Shopping Center;
- 2) A Ground Lease Estoppel Certificate concerning the Lease for property known as Airport Plaza Shopping Center;
- 3) A 7<sup>th</sup> Amendment to the Lease extending the Lease term from March 2045 to May 2052; and
- 4) An Amendment of Memorandum of Lease reflecting the amended terms and conditions of the Lease.

City Attorney Fellows briefly outlined the above-mentioned documents. He advised that they were necessary to allow the transfer of the Airport Plaza Shopping Center Lease from the current Master Tenant to a new Master Tenant group whose managing member will be Norman La Caze, operator and lessee of Rolling Hills Plaza Shopping Center. He noted that the supplemental material available at the meeting was supposed to have included revised documents with corrected legal descriptions and the deletion of highlighted language in the Estoppel Certificate, however, the original versions were inadvertently reprinted. He indicated that as there were no substantive changes, other than corrected legal descriptions, the changes would be made administratively. He clarified that the tenant's request for a rent reduction of \$48,000 a year for a ten-year period was not before the Council at this time and would be brought forward at a later date.

Former Councilmember Marcia Cribbs, 2055 Johnson Court, reported on the previous City Council's action on this matter and voiced her opinion that the \$175,000 rent proposed for the 17,000-acre shopping center was an exceptionally good deal and an excellent inducement for any developer who wants to develop this site. She recommended that the Council ask staff to provide information about inducements given to this manager/developer in the past in conjunction with the Rolling Hills Plaza shopping center, as well as a comparison of rents for surrounding properties, when the proposal for the \$48,000 rent reduction is brought forward.

Mayor Pro Tem Scotto stated that he hoped Ms. Cribbs would return when this matter comes before the Council because he would appreciate her input.

**MOTION:** Councilmember Witkowsky moved to concur with the staff recommendation. The motion was seconded by Councilmember Mauno and passed by unanimous roll call vote (absent Councilmember Nowatka and Mayor Walker).

- **15d.** Councilmember Lieu stated that he was pleased the Council was able to honor former Mayor Hardison and former Councilwoman Cribbs for making Torrance a safer, stronger, better city with their many years of service.
- **15e.** Councilmember Lieu commented on the Armed Forces weekend events, commending all City employees involved for making it a tremendous weekend and Captain Paul Besse for a great job.
- **15f.** Councilmember Lieu noted that at the Reveille ceremony two airmen were awarded National Defense Service medals the first in the country.
- **15g.** Councilmember Lieu also commented on the Ted Tonouye ceremony at the National Guard Armory that concluded a moving weekend.
- **15h.** Councilmember Mauno noted his pleasure in attending the Police Memorial event, the RSVP luncheon, all of the Armed Forces weekend events, and the Ted Tonouye naming ceremony.
- **15i.** Councilmember McIntyre stated that she was pleased that former Councilwoman Marcia Cribbs and former Mayor Hardison were present to accept their well deserved proclamations and expressed her admiration for their many years of service in Torrance.
- **15j.** Councilmember McIntyre also thanked Captain Besse for a wonderful job at the Armed Forces Day Parade, stating that it was a very well organized, stirring event. She commented that the F-15 fly-over was an overwhelming experience but the highlight for her was seeing the World Trade Center flag.
- **15k.** Councilmember Witkowsky noted her agreement with remarks made about the Armed Forces Parade; commented on the display of patriotism throughout the parade route; commended the Police Department for security arrangements; and expressed thanks for the cooperation from the businesses in Torrance. She stated that she enjoyed meeting military personnel at various events, including WWII veterans, and that they greatly appreciated the City's recognition of the armed services.
- **15I.** Councilmember Witkowsky commented on the Beat the Odds reception held at the Attic, stating that the five students who were honored overcame many difficult challenges.
- **15m.** Councilmember Witkowsky thanked Councilmember Mauno for his comments on the RSVP luncheon and the volunteer seniors.
- **15n.** Mayor Pro Tem Scotto extended congratulations and thanks to the retiring Torrance Unified School District employees, noting that Torrance has benefited from their leadership and commitment.

- **15o.** Mayor Pro Tem Scotto noted that on June 11<sup>th</sup> animal control will be part of the budget hearing item and asked staff to include an estimate of the cost to provide temporary housing in Torrance before transporting animals to the County shelter.
- **15p.** Mayor Pro Tem Scotto echoed remarks about the Armed Forces Day Parade and thanked the Police Department and the Fire Department for a stellar job. He provided background information about the World Trade Center flag that was displayed at the event, noting that after being removed from the World Trade Center, it was raised at a military camp in Kandahar, Afghanistan, before being returned to the U.S.
- **15q.** Councilmember Witkowsky announced that the Armed Forces Day Parade would air on CitiCable on May 22<sup>nd</sup> at 5:45 p.m.
- **15r.** Councilmember Witkowsky announced a reception for artist Henry Fukihari's workshop at the Madrona Marsh Nature Center on May 31<sup>st</sup> from 10:00 a.m. to 5:00 p.m.; and an open house and slide show on pacific dragonflies, trees and frogs on June 1<sup>st</sup> at the Nature Center.
