MINUTES OF AN ADJOURNED REGULAR MEETING OF THE TORRANCE CITY COUNCIL

1. CALL TO ORDER

The Torrance City Council convened in an adjourned regular session at 7:25 p.m. on Tuesday, May 16, 2000, in City Council Chambers at Torrance City Hall.

2. FLAG SALUTE/INVOCATION

The Pledge of Allegiance was led by Boy Scout Troop 203, Scoutmaster Robert Morgan.

Pastor E. Lorne Jack, South Bay Alliance Church, gave the invocation for the meeting.

3. <u>AFFIDAVIT OF POSTING/WAIVE FURTHER READING</u>

<u>MOTION:</u> Councilmember Cribbs moved to accept and file the report of the City Clerk on the posting of the agenda for this meeting. The motion was seconded by Councilmember Nowatka and, there being no objection, it was so ordered by Mayor Hardison.

6c. PROCLAMATION RE "VETERAN APPRECIATION MONTH"

Mayor Hardison presented a proclamation declaring the month of May 2000 as "Veteran Appreciation Month" in the City of Torrance to Angel Gonzales, Veterans representative.

6d. PROCLAMATION RE "FIBROMYALGIA AWARENESS DAY"

Mayor Hardison presented a proclamation declaring Wednesday, May 12, 2000, at "Fibromyalgia Awareness Day" in the City of Torrance to Rose Ann Green, Fibromyalgia support group leader. Ms. Green invited interested parties to attend support group meetings at Torrance Memorial Hospital on the third Saturday of each month and educational programs at Torrance Memorial and Sam Levy adult school.

Attorney Wayne Flick of Latham Watkins announced that the United States Court of Appeals for the 9th Circuit affirmed the 1998 decision of a Federal judge awarding the City of Torrance attorney fees in the amount of \$1.7 million from the United States Department of Justice. He noted that the court found there was no basis for the suit to have been brought against the City for its hiring practices in the Police and Fire Departments. He discussed the potential for appeal, voicing his opinion that the Justice Department was unlikely to prevail, and estimated that the City would receive the money by early 2001.
