Ms. Doherty commented on her past 10 years on C/L/T PIC and expressed her appreciation for the support the City provides.

Recommendation of the Fire Chief that City Council authorize a purchase order in the amount of \$118,558.25 be issued to Air Cleaning Systems, Montclair, CA to furnish and install PlymoVent SourceCapture Exhaust Systems in all six fire stations as a Cooperative purchase with the City of Los Angeles.

Recommendation

Recommendation of the City Clerk that City Council approve a contract extension (C97-267) with David (Cal) Jackson to provide consulting services for a city wide Record Retention Schedule to December 2000 adding a not to exceed amount of \$6,000 for completion of a Records Retention User manual.

7i. JOB TRAINING PARTNERSHIP ACT FUNDING

Recommendation

Recommendation of the Human Resources Director that City Council accept and appropriate an additional \$23,029 in JTPA funding from the City of Los Angeles to the 1999-2000 Employment and Training budget, and authorize the execution of Amendment One that adds funds to 1999-2000 Agreement with the City of Los Angeles (C99-241) and extends the agreement term from July 1, 2000 to August 15, 2000.

7j. <u>EXTENSION OF VOCATIONAL TRAINING AGREEMENTS</u>

Recommendation

Recommendation of the Human Resources Director that City Council extend Agreements for employment and training services to June 30, 2001 with Brem Industries dba California Career Schools, Computer Education Institute, Educorp/Nova Institute, iNetVersity, New Horizons, and the Right Way Computer Training.

<u>MOTION:</u> Councilmember Walker moved for the approval of Consent Calendar Items 7a through 7j. The motion was seconded by Councilmember Witkowsky and passed by unanimous roll call vote.

Commenting on Item 7f, Councilmember Walker stated that he was pleased to see that the costs for the March 2000 election were substantially lower than those

originally projected. Mayor Hardison noted that the City received a 46 percent discount on March election costs, a discount that probably will not be available for future elections.

8. <u>COMMUNITY SERVICES</u>

8a. PURCHASE ORDER RE GASOLINE AND DIESEL FUEL REQUIREMENTS

Recommendation

Recommendation of the General Services Director, the Transit Director and the Fire Chief that City Council authorize the award of a purchase order in an anticipated amount not to exceed \$1,200,000 annually, to Southern Counties Oil Company of Orange, California (dba Total Energy Products), to furnish the City's anticipated gasoline and diesel fuel requirements for a five (5) year period (7/1/00-6/30/05).

General Services Director Tilden reported that after the posting of the agenda but prior to the release of materials, staff recommended that the purchase be limited to one-year rather than a five-year contract because alternative fuel sources were being explored which might affect the amount of fuel purchased.

<u>MOTION:</u> Councilmember Cribbs moved to authorize the award of a purchase order for gasoline and diesel fuel requirements for a one-year period. The motion was seconded by Councilmember Nowatka and passed by unanimous roll call vote.

11. <u>ADMINISTRATIVE MATTERS</u>

11a. STATEMENT OF INVESTMENT POLICY FOR FY 2000-01

Recommendation

Recommendation of the City Treasurer that City Council adopt a Resolution to establish the Statement of Investment Policy for FY 2000-01.

Mayor Hardison noted supplemental material available at the meeting.

City Treasurer Barnett presented the staff report (per written material of record). She advised that she was recommending an increase in the maximum percentage allowed for investments in federal agency securities from 40 percent to 45 percent and noted that the Investment Advisory Committee had concurred with the recommendation.

11b. <u>CONSENT TO ASSIGNMENT OF LEASE FROM CHAGAL</u> COMMUNICATIONS TO RODRIGUEZ COMMUNICATIONS

Recommendation

Recommendation of the City Manager that City Council authorize the Mayor to Execute and the City Clerk to Attest to an Assignment, Acceptance of Assignment, and Consent to Assignment of Lease by and between the City of Torrance and Chagal Communications, Inc., a California Corporation to Rodriguez Communications, LLC.

Assistant to the City Manager Sunshine presented the staff report (per written material of record). Noting that this assignment was part of a two-phase transfer of the lease, he explained that because Rodriguez Communications is a brand new corporation with limited resources, Chagal Communications, Inc. would continue to be responsible for all of the Lessee's duties and obligations, including non-monetary performance, until such time as the assignment to Spanish Broadcasting Systems is completed.

<u>MOTION:</u> Councilmember Cribbs moved to concur with the staff recommendation. The motion was seconded by Councilmember Walker and passed by unanimous roll call vote, with Councilmembers Messerlian and Scotto abstaining.

Mr. Sunshine thanked City Attorney Fellows and Deputy City Attorney Whitham for their assistance in the preparation of the documents.

12. HEARINGS

12a. <u>CITY OF TORRANCE LIGHTING DISTRICT NO. 99-1</u>

Recommendation

Recommendation of the Planning Director that City Council take the following actions:

- Hold the Public Hearing on the proposed levy of assessments within the City of Torrance Lighting District No. 99-1 for Fiscal Year 2000-2001; and
- 2) Adopt a Resolution confirming the diagram and assessment for Fiscal Year 2000-2001 and ordering the improvements in connection with the City of Torrance Lighting District No. 99-1.

Mayor Hardison announced that this was the time and place for a hearing on this matter, and City Clerk Herbers confirmed that the hearing had been properly advertised.

Transportation Engineer Sedadi presented the staff report (per written material of record).

In response to Councilmember Scotto's inquiry, a representative of David Tassig and Associates, project engineer, provided clarification of how the assessment rates were calculated for the Non-Residential and Undeveloped Land Use Classifications.

Mr. Newton Young, 22637 Hickory Avenue, requested a breakdown of Southern California Edison costs for the Lighting District.

Traffic Engineer Sedadi indicated that the requested breakdown of Edison costs was available from the monthly billing statements. City Manager Jackson noted that the City in effect rents poles from Edison inclusive of power usage and that the billing is based on a special rate structure used only for street lights.

Mr. Young questioned whether an annual public hearing is required to levy this assessment, relating his understanding that Proposition 218 does not mandate such a hearing. City Manager Jackson explained that in order to include the assessments on County tax bills, the City Council must hold a public hearing, evaluate the assessments, and transmit that information to the County.

MOTION: Councilmember Cribbs moved to close the public hearing. The motion was seconded by Councilmember Messerlian and passed by unanimous roll call vote.

<u>MOTION:</u> Councilmember Witkowsky moved to concur with the levy of assessments within the City of Torrance Lighting District No. 99-1 for Fiscal Year 2000-2001. The motion was seconded by Councilmember Scotto and passed by unanimous roll call vote.
