MINUTES OF A REGULAR MEETING OF THE TORRANCE CITY COUNCIL

1. CALL TO ORDER

The Torrance City Council convened in a regular meeting at 7:05 p.m. on Tuesday, September 26, 2000, in the West Annex Commission Meeting Room at Torrance City Hall.

Note: The City Council met from 5:30 p.m. to 6:45 p.m. in a joint meeting with the Cultural Arts Commission.

ROLL CALL

Present: Councilmembers Cribbs, Messerlian, Nowatka, Scotto, Walker,

Witkowsky and Mayor Hardison.

Absent: None.

Also Present: City Manager Jackson, City Attorney Fellows, City Clerk Herbers

and other staff representatives.

2. FLAG SALUTE/INVOCATION

The Pledge of Allegiance was led by Jim Mills, Transit Administrator.

The invocation was given by Pastor Lance Boloran, Vermont Avenue Baptist Church.

3. AFFIDAVIT OF POSTING/WAIVE FURTHER READING

<u>MOTION:</u> Councilmember Cribbs moved to accept and file the report of the City Clerk on the posting of the agenda for this meeting. The motion was seconded by Councilmember Nowatka and voice vote reflected unanimous approval.

<u>MOTION:</u> Councilmember Cribbs moved that after the City Clerk has read aloud the number and title to any resolution or ordinance on the meeting agenda, the further reading thereof shall be waived, reserving and guaranteeing to each Councilmember the right to demand the reading of any such resolution or ordinance in regular order. The motion was seconded by Councilmember Nowatka and voice vote reflected unanimous approval.

4. <u>WITHDRAWN OR DEFERRED ITEMS</u>

City Manager Jackson announced that item 11c was withdrawn as more modifications were needed and he noted that staff was proposing to continue items 12a and 12b.

5. COUNCIL COMMITTEE MEETINGS AND ANNOUNCEMENTS

Mayor Hardison announced a meeting of the City Council Ad Hoc Legislative Committee on Tuesday, October 3, at 4:00 p.m. in the City Hall Third Floor Council Conference Room to consider the measures on the November 7 ballot.

6. <u>COMMUNITY MATTERS</u>

6a. <u>PROCLAMATION RE EL CAMINO COLLEGE RADIOLOGIC TECHNOLOGY</u> <u>PROGRAM</u>

The Mayor presented a proclamation commending and congratulating the El Camino College Radiologic Technology Program upon its 30th anniversary to Donald J. Visintainer, Program Director of the Medical X-Ray Division. Mr. Visitainer thanked the Mayor for her support and introduced students and faculty of El Camino College involved with the program.

Fire Chief Bongard announced that the City of Torrance had received an award from the Chemical Education Foundation for the Torrance Early Warning System.

Mayor Hardison noted that all participants took the program quite seriously and the community had become more educated as a result of the very successful community meetings and school presentations.

6b. APPOINTMENT OF NEW COMMISSIONERS

Recommendation of the City Clerk that City Council review applications and appoint Commissioners to fill vacancies on the Planning Commission and the Traffic Commission.

Mayor Hardison noted that though they usually made appointments in January, there were two vacancies which currently needed to be filled. She explained the procedures and announced that Andy Peranelli had asked that his name be removed from the list of applicants for consideration.

<u>MOTION:</u> Councilmember Walker moved a unanimous ballot appointing Harvey Horwich to the Planning Commission with a term expiring on January 15, 2004. Councilmember Witkowsky seconded the motion and a roll call vote reflected unanimous approval.

<u>MOTION:</u> Councilmember Walker moved a unanimous ballot appointing Ron Ogden to the Traffic Commission with a term expiring on January 15, 2002. Councilmember Cribbs seconded the motion and a roll call vote reflected unanimous approval.

Mayor Hardison stated that Ron Ogden had previously indicated he would not be present at the meeting. City Clerk Herbers administered the oath of office to Mr. Horwich.

Mayor Hardison congratulated Mr. Horwich and encouraged applicants to reapply noting that there would be many more openings in January. City Clerk Herbers

explained that applications would be kept on file and applicants would be notified in November for the January appointments.

Mayor Hardison received clarification that there was no fee to join and the City would benefit from the program.

<u>MOTION:</u> Councilmember Messerlian moved for the adoption of Resolution No. 2000-118. Councilmember Nowatka seconded the motion and a roll call vote reflected unanimous approval.

11. ADMINISTRATIVE MATTERS

11a. REPORT OF THE SEPTEMBER 13, 2000 COUNCIL CITIZEN DEVELOPMENT AND ENRICHMENT COMMITTEE JOINT MEETING WITH TORRANCE USD

Recommendation that City Council, as a whole, receive and file the report of the September 13, 2000 Council Citizen Development and Enrichment Committee in a joint meeting with the Torrance Unified School District.

Councilmember Cribbs stated that it was an information item only and there were a number of items discussed including: Youth Services Task Force Action Plan; Site Modernization at Fern School and Hull Middle School; Street Widening adjacent to Walteria School; Eucalyptus Trees along Plaza Del Amo; Traffic, Drainage and Landscaping around Towers School. She noted that the joint committee was trying to meet quarterly and that other members included Councilmembers Walker and Scotto. She stated that Councilmember Nowatka served on the committee involved with the Conference on Hate Crimes meeting taking place on September 28, 2000 from 7 p.m. to 9 p.m. in the Cultural Arts Center Music Room.

In response to an inquiry from Mayor Hardison, Engineering Director Burtt explained the neighbors and the school district did not agree regarding parking. He reported that Torrance Transit had worked with them to relocate routes though there were still many issues which needed to be worked out with the school and its effects on a residential area. He clarified for Mayor Hardison that the school district had attended one community meeting and he expected that they would participate more this year.

Councilmember Scotto commented that he hoped they would address traffic, drainage and landscaping problems around Towers School and Engineering Director Burtt reported that data would be collected during the coming week.

<u>MOTION:</u> Councilmember Cribbs moved to accept and file the report of the September 13, 2000 Council Citizen Development and Enrichment Committee in a joint meeting with the Torrance Unified School District. Councilmember Walker seconded the motion and a roll call vote reflected unanimous approval.

11b. LEASE AMENDMENT RE DANIEL F. SELLECK – 25210 CRENSHAW BLVD.

Recommedation of the Land Management Team that City Council authorize the Mayor to execute and the City Clerk to attest to a second amendment to a lease by and between the City of Torrance and Daniel F. Selleck for City-owned property located at 25210 Crenshaw Boulevard.

<u>MOTION:</u> Councilmember Messerlian moved for the adoption of Resolution No. 2000-120. Councilmember Nowatka seconded the motion and a roll call vote reflected unanimous approval

Mayor Hardison noted that the City had entered into MOUs with some of its miscellaneous employees agreeing to make available the 2% at 55 PERS retirement option. She noted that the process for securing the benefit with PERS involved several steps and City Manager Jackson agreed to bring back the necessary documentation to begin the process.

12. HEARINGS

12a. <u>CONTINUED PUBLIC HEARING RE VACATION OF ALLEY EAST OF ANZA</u> FROM TORRANCE BLVD. SOUTH SERVICE ROAD TO SCOTT STREET

Recommendation of the Engineering Director that City Council continue the Public Hearing to November 14, 2000 on a resolution ordering the vacation of the alley east of Anza Avenue from the Torrance Boulevard south service road to Scott Street.

<u>MOTION:</u> Councilmember Cribbs moved to continue the hearing regarding the vacation of the alley east of Anza from Torrance Blvd. south service road to Scott Street to November 14, 2000. Councilmember Walker seconded the motion and a roll call vote reflected unanimous approval.

12b. <u>INDEFINITE CONTINUANCE RE PROPERTY LOCATED ON THE SOUTH SIDE OF DEL AMO BLVD.</u>, WEST OF REDBEAM AVE.

Recommendation of the Planning Director that City Council take the following action on property located on the south side of Del Amo Boulevard west of Redbeam Avenue:

 Approve an indefinite continuance pending redesign of a seven unit detached residential condominium development on property located in the Hillside Overlay District in the CR zone. ZON99-00007, CUP99-00032, TTM52429, (EAS99-00014): JCC/REDBEAM, LLC/RICHARD GOULD.

Mayor Hardison opened the public hearing at 7:39 p.m.

Jerry Katzen, 20121 Redbeam Ave., asked whether an environmental impact study have been conducted and read the following letter into the record.

"On August 22nd I along with scores of other concerned neighbors attended a city council meeting to discuss the proposed condo project on the south side of Del Amo and Redbeam. The notice submitted in the mail stated that the purpose of the meeting was to consider a request for approval of a zone change from CR [Restricted Commercial District] to R-TH [Residential Townhouse District]. However, the City Council meeting of August 22nd didn't address this issue. During the August 22nd meeting the City Council discussed the number of units to be built, the topography, security gates, and other issues associated with the proposed condo project. The one thing the City Council didn't address was the purpose of the meeting. That is, consideration of a request for approval of a zone change as stated above. It seems the City Council decided this issue prior to the meeting. Before we discuss aspects of a condo project we should discuss the request for a zone change.

The meeting notice sent out for tonight's meeting doesn't refer to a zone change or even discussion about the proposed condo project. It's for an indefinite continuance to allow the developer more time to submit a redesign of a project that is overwhelmingly rejected by the people who live in the area. Why is the Torrance City Council ignoring the residents of the area who made telephone calls to you voicing disapproval of the condo project, wrote letters to you expressing disapproval of the condo project and attended Planning Commission and City Council

meetings vehemently saying no to the proposed condo project? Why is the City Council favoring the developer over the people who live in the area who have said no to the condo project?

The City Council should hold hearings and vote on the rezoning of the property as stated in the notice for the August 22 meeting. The City Council is talking about the condo project without first deciding if the land will be rezoned.

At the opening of the hearing on August 22 Mayor Hardison stated that the City Council would not respond to questions from the audience. The City Council kept its word. It didn't answer or address our questions or concerns. However, it did answer and address every question or comment made by the developer. It went so far as to reopen the meeting for "public" comment however, the only person allowed to provide comment was the developer. So much for an open and honest meeting.

Ladies and gentlemen of the Torrance City Council, you are supposed to represent the residents of Torrance. You are supposed to make decisions that benefit us. You are supposed to represent us, the voters of Torrance, not the special interest groups such as developers.

Any thought to allow an indefinite continuance is outrageous and not in the best interests of the people.

We've made phone calls, written letters and attended meetings expressing our objection to the proposed condo project. What more do we have to do in order for this City Council to act on our behalf? The City Council should vote in accordance with the will of the people and reject the proposed condo project. The City Council should listen to residents, the voters and rezone the property as R-1, single family residence only."

Planning Manager Isomoto noted that the developer now had control of the property to the west and based on the recommendation of the Council they had met with the developer who is trying to formulate a project to meet the needs of the neighbors. She noted that the development would most likely be R-1 and stated that they would readvertise for a public hearing before the Planning Commission. She noted that when the item came back to the Council they would be considering both parcels, not just one.

Mayor Hardison stated that the Council had answered the questions of the public at the August 22 meeting and she had reopened the hearing to get concurrence from the developer, not to get additional dialogue. She apologized if she did not answer each person's question and was sorry that Mr. Katzen did not feel his needs were met.

<u>MOTION:</u> At 7:45 p.m. Councilmember Walker moved to close the public hearing. Councilmember Cribbs seconded the motion and a voice vote reflected unanimous approval.

<u>MOTION</u>: Councilmember Messerlian moved for an indefinite continuance pending redesign of a seven unit detached residential condominium development located in the Hillside Overlay District in the CR Zone with future hearings to be readvertised. Councilmember Walker seconded the motion and a roll call vote reflected unanimous approval.

12c. 25200 LOYTAN STREET

Recommendation of the Planning Commission and Planning Director that City Council take the following action on property located at 25200 Loytan Street:

- 1) Adopt a Negative Declaration;
- 2) Adopt an ordinance approving a Zone Change from C-2 (General Commercial District) to R-3 (Limited Multiple Family Residential District);

Mayor Hardison opened the public hearing at 7:46 p.m.

Planning Manager Isomoto provided a brief presentation summarizing the material of record and noting that the applicant was requesting approval to a series of land use entitlements. She noted that the Planning Commission considered the item and one person spoke in opposition citing the loss of parking. The Planning Commission voted unanimously to approve the project.

Tom Yuge, 1821 West 213th Street, noted that the property was underutilized and they had had difficulty securing tenants for it and he believed that this was a good use. He added that they had originally wanted three units, but after meeting with staff and discussing parking issues, among other things, they decided on the current plan.

MOTION: At 7:58 p.m. Councilmember Scotto moved to close the public hearing. Councilmember Cribbs seconded the motion and a roll call vote reflected unanimous approval.

In response to an inquiry from Mayor Hardison, Planning Manager Isomoto noted if the FAR exceeded .65, a loss of 93-sq. ft. total, they would change it. She noted that there would need to be a reason and Mayor Hardison stated that she was comfortable with them handling the matter administratively.

Councilmember Messerlian said it was a well-drawn plan and he would be pleased to approve it.

MOTION: Councilmember Cribbs moved to adopt a negative declaration. Councilmember Messerlian seconded the motion and a roll call vote reflected unanimous approval.
