

City of Torrance Airport Manager Herrera provided a report on the monthly update of aeronautical operational information under the purview of the General Services Department:

- Staff continues to work with Lean Corporation regarding the AWOS system. Design element is nearly completed; staff is optimistic that the system will be in service and installed by the end of 2024. Staff will continue to update the airport Commission regarding the project.
- Taxiway Light Project is still underway, it was halted due to heavy precipitation. The contractor will continue the project once the area is dry.
- Meeting Room Schedule continues to grow.
- Hangar waitlist continues to grow with new additions in December 2023; a few hangars were awarded to individuals in January and February 2024. The non-aviation hangar waitlist continues to grow.
- There were (4) incidents in the month of December 2023, the Torrance Fire Department was not required for any incidents.
- (13,371) operations occurred in December 2023.

7B. ACCEPT AND FILE TORRANCE MUNICIPAL AIRPORT NOISE ABATEMENT QUARTERLY REPORT FOR THE THIRD AND FOURTH QUARTERS OF 2023 UNDER THE PURVIEW OF THE COMMUNITY DEVELOPMENT DEPARTMENT.

Environmental Quality Officer Duncan presented Item 7B:

- The third and fourth quarterly report regarding Torrance Airport's Noise Abatement was presented to the Commission.
- The third quarter had a total of 11,359 complaints with 11,269 of the complaints coming from a regularly reporting party (person that makes 10 or more reports); the term "regular" is qualified by usage and not personal identification. During the third quarter, the highest number of complaints came from Zone 1, 3, 5, and 8.

• The fourth quarter had a total of 3,285 complaints with 3,207 of the complaint coming from a regular reporting party. The highest number of complaints came from Zone 3, 8, and 10.

Members of the Commission spoke.

A member of the public presented paperwork to the Commission regarding the Casper system.

Chair Minder inquired if airport reports (regarding noise and airport issues) could be put forth at City Council to reach more people. Community Development Director Ramirez replied that the Commission's Liaison can notify the City Manager of the request, the City Manager in turn will inform the City Council and the Council will direct whether to pursue or not.

Commissioner Marshall inquired if the quarterly reports were on the *Trending in Torrance* webpage. Community Development Director Ramirez replied that *Trending in Torrance* was made as a spot to see options the City Council has directed staff to follow up on and that there are links that lead to specific pages pertaining to projects. Staff can talk with the department that handles the website to see if a link can be created that can take individuals to the reports.

A member of the public spoke.

<u>MOTION</u>: Commissioner De Rago moved to accept and file Item 7B. Commissioner Cohen seconded the motion; motion reflected a 6-0 approval.

8. ORAL COMMUNICATIONS

Commissioner Love stated that a lot of hangars have leaks and maintenance issues and inquired how the process worked to getting issues rectified. City of Torrance Airport Manager Herrera replied that a Discrepancy Form is available to identify where the issues are, once obtained, staff will have a vendor come out to amend issues.

Chair Minder stated that the Commission previously expressed a desire to formulate a plan on how the airport can improve and potentially hire a coach to organize the plan, and requested on update on where the request stands. General Services Director Megerdichian stated that City Council discussed a visioning plan for the airport and wanted staff to bring back an Item to City Council; staff will be working on a staff report to bring back to City Council to see what direction the Council would like to take.

Chair Minder requested staff update the Commission on City Council Agenda Items pertaining to the Airport. General Services Director Megerdichian replied that staff will try to notify the Commission but did not guarantee that staff will be able to always provide notification.

ONGOING PROJECTS APRIL 11, 2024

Automated Weather

Observing System (AWOS) -

We have met with AWOS specialist, Federal Aviation Administration, an electrical contractor, airport engineering consulting firms to structure a plan for this project. This is a multi-component project that involves location, weather equipment, installation, and implementation. We have met with Lean Corporation staff and will continue to meet with them in the next several months' in the survey and design phase of this project. Lean has vast experience with numerous aviation projects throughout the county and they are locally based. We have met with Lean Corp. to review all the technical information to thoroughly review the project and analyze this every step of the way. We will have monthly updates as we progress throughout the project.

- Design phase 95% completed by December 2023.
- Project out to bid by late Spring 2024
- Construction to begin Summer 2024.
- Construction completion Fall 2024.
- Operational by late Fall 2024.

Taxiway Light and Wire Replacement

The Taxiway Light and Wire Replacement was awarded to Belco Elecnor an electrical contractor. This is a multi-location project that involves several taxiway sections. We held a preconstruction meeting on January 3, 2024 with Belco Elecnor staff and will continue to meet with them in the next several weeks during the construction. The construction project began January 2024. We have encountered some weather delays that have pushed our completion an extra month, but we continue to make good progress. We will have monthly updates as we move throughout this development.

Definitions:

<u>ACCIDENTS</u>: An occurrence associated with the operation of an aircraft, which takes place between the time any person boards the aircraft with the intention of flight and all such persons have disembarked, and in which any person suffers death or serious injury, or in which the aircraft receives substantial damage.

SUBSTANTIAL DAMAGE means damage or failure which adversely affects the structural, strength, performance, or flight characteristics of the aircraft, and which would normally require major repair or replacement of the affected component. Engine failure or damage limited to an engine if only one engine fails or is damaged, bent fairings or cowling, dented skin, small punctured holes in the skin or fabric, ground damage to rotor or propeller blades, and damage to landing gear, wheels, tires, flaps, engine accessories, brakes, or wingtips are not considered "substantial damage".

SERIOUS INJURY means any injury which: (1) requires hospitalization for more than 48 hours, commencing within 7 days from the date the injury was received; (2) results in a fracture of any bone (except simple fractures of fingers, toes, or nose); (3) causes severe hemorrhages, nerve, muscle or tendon damage; (4) involves any internal organ; or (5) involves second or third degree burns; or any burns affecting more than 5% of the body surface.

<u>INCIDENT</u>: Any occurrence other than an accident associated with the operation of an aircraft, which affects or could affect the safety of operations.

NOTE: Per the FAA, Airport Operations totals will no longer be reported for the previous month. Due to automation, the totals will now be reported two months after they occur.












The zones represented in this section of the quarterly report, are the zones with the highest number of complaints/reports. Some of these zones are also contain the highest percentage of "regular users."










Complaints and Violations 1st Quarter 2024
