# A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TORRANCE, CALIFORNIA, ESTABLISHING FEES FOR CERTAIN EMERGENCY MEDICAL SERVICES PROVIDED BY THE CITY OF TORRANCE FIRE DEPARTMENT

WHEREAS, user and regulatory fees are established by the City Council; and

**WHEREAS**, the City recently completed a study to identify the cost of providing services relating to the provision of various emergency medical services provided by the City's Fire Department; and

**WHEREAS**, the study examined the costs reasonably borne by the City in providing these services, the beneficiaries of these services, and the revenues produced by those paying fees and charges for special services; and

**WHEREAS**, the City Council hereby finds that the study provides adequate evidence to conclude that the fees do not exceed the cost to provide the services for which the fees are charged; and

NOW, THEREFORE, the City Council of the City of Torrance does hereby resolve as follows:

### **SECTION 1**

The City Council adopts the fees as set forth in Exhibit A, which is attached and incorporated herein by this reference. The adopted fees shall be incorporated into the City's existing Master Fee Schedule. Incorporating these fees into the fee schedule will allow for the fees to be considered with future comprehensive user and regulatory fee updates.

#### **SECTION 2**

Emergency medical service transport fees as set forth in Exhibit A shall be adjusted annually to correspond to amounts authorized by the Los Angeles County Emergency Medical Services Agency for general public ambulance rates.

#### **SECTION 3**

The fees listed in Exhibit A shall take effect on February 23, 2021.
