#### 7A. MILLS ACT OVERVIEW

Senior Planning Associate Chun presented Item 7A:

- The Mills Act is a property tax incentive program that is intended to be a component of a historic preservation program; it is an owner initiated, voluntary program that provides financial incentives to assist in preservation of historic structures.
- The Mills Act permits cities to enter into agreements with property owners of qualified historic structures to preserve their properties and allows local governments to design preservation programs to accommodate specific communities' needs.
- A formal agreement is executed between the city and property owner for a minimum
  of a 10-year term; contracts are automatically renewed each year and is transferred to
  new owners when the property is sold. An annual inspection by city staff will be done
  to ensure proper maintenance of the property.
- Mills Act participants can see property tax savings of up to 40% 60% each year.
- The Commission's role will be to review applications for the program and make recommendations to City Council to either approve or deny requests.

Members of the Commission spoke.

# 7B. PUBLIC OUTREACH DISCUSSION

Planning Manager Martinez presented Item 7B:

- Staff requested feedback from the Commission regarding the following items:
