The Torrance City Council reconvened in a regular meeting on Tuesday, January 7, 1997, at 7:41 P.M., in the Council Chambers of Torrance City Hall.

The Flag salute was led by Mr. Scott Gobble, a representative from the Southern California Edison Company.

Reverend Craig Rusch, Hope Chapel Gateway, led the invocation for the meeting.

At this time Mayor Hardison requested that the City Council meeting be adjourned in the memories of community members Dr. Rollin Smith, Ms. Velma Shelbourne, and Mr. John David Olson.

7b. CRENSHAW BOULEVARD IMPROVEMENT AGREEMENT/LOMITA

RECOMMENDATION

The Engineering Director recommends that your Honorable Body approve and authorize the Mayor and the City Clerk to attest to and execute the attached Agreement with the City of Lomita for the Improvement of Crenshaw Boulevard from Lomita Boulevard to South of Skypark Drive.

Councilman Messerlian highlighted the cooperative efforts between the cities of Lomita and Torrance.

MOTION: Councilman Messerlian moved for the approval of Consent Calendar Item No. 7b. The motion was seconded by Councilwoman Cribbs, and roll call vote reflected unanimous approval.

8. <u>LIBRARY/PARKS AND RECREATION</u>

8a. AWARD OF CONTRACT FOR THE LEASE AND FULL OPERATION OF THE LAS CANCHAS TENNIS FACILITY

RECOMMENDATION

The Parks and Recreation Director recommends that the City Council authorize the award of Contract to South Bay Tennis Center for the lease and full operation of the Las Canchas Tennis Facility, effective February 1, 1997; and instruct the City Attorney to prepare a Concession Agreement embodying the terms of the proposal.

Parks and Recreation Director Barnett reviewed Staff report/recommendation (of record) and commented on the bidding and selection process which was utilized for the Las Canchas Tennis Facility Concessionaire lease.

Mayor Hardison explained for the record that when this proposal for the concessionaire contract was awarded for the tennis facility in 1994, she abstained from voting on this item due to the fact that there existed a perception that she may have had a conflict of interest regarding this matter -- that she had a working relationship with the Torrance School District, with a relative of one of the applicants. Mayor Hardison clarified that she has not worked with that particular applicant since July 1994 because of a re-assignment from the Torrance School District.

Per Councilman Messerlian's inquiry, Staff provided further information and clarification concerning the bidding, rating, evaluation and selection process for the tennis facility concessionaire lease.

Mr. Mark Thomas, Los Angeles, pointed out that his bid for the tennis facility concessionaire lease was the highest -- noting his confusion with Staff's recommendation; requested, and received, clarification regarding the City's protocol for contract proposal revisions; and requested further input concerning the City's rating and Denise Bothe

selection process. Mr. Thomas noted that he was notified of Staff's recommendation 24 hours in advance of becoming public knowledge, not two weeks in advance as was told to him during his interview.

Mr. George Sulc, Torrance, expressed his gratitude of the Mayor and City Council, the Parks and Recreation Department for the past business opportunities which have been afforded to him; commented on the improvements he had made at the Las Canchas Tennis Facility; and expressed his appreciation for those individuals who supported the tennis facility and participated in the special events which took place at the tennis facility -- proudly noting that no complaints were received during his tenure at the facility.

Mr. and Mrs. Hance, Torrance, South Bay Tennis Center, thanked the selection committee for choosing them as the new tennis facility concessionaires; and advised that no plans exist at this point in time to change the scheduling of teams or leagues at the Las Canchas Tennis Facility.

<u>MOTION:</u> Councilman Messerlian moved to concur with Staff recommendation. The motion was seconded by Councilman Lee, and roll call vote reflected unanimous approval.

Councilman Walker, echoed by Councilman Messerlian, thanked and commended Mr. Sulc for providing a high-quality program. Councilman Walker congratulated Mr. and Mrs. Hance for being awarded the tennis facility contract and wished them success in their endeavors.

13a. METROPOLITAN WATER DISTRICT OF SOUTHERN CALIFORNIA TORRANCE APPOINTMENT - RESOLUTION 97-02

RECOMMENDATION

The current term of the City's Director on the Metropolitan Water District of Southern California's Board of Directors will expire as of December 31, 1996. The Mayor recommends that the City's current Director, Mr. Bill Wright, be re-appointed as the City's representative on the Metropolitan Board for a four-year term.
