11. PLANNING AND ZONING MATTERS

11a. OPTING OUT OF THE PERMIT PARKING ZONE IN TORRANCE GARDENS

RECOMMENDATION

The City Council has directed staff to develop a methodology for allowing certain streets to opt out of the permanent parking program. To this end, the Planning Director is recommending the following:

- 1. That the City Council approve a proposed methodology for enabling residents of certain streets to opt out of the permanent permit parking zone within the Torrance Gardens neighborhood;
- 2. That this methodology specify that no less than sixty-six percent of all property owners on a street must agree to opt out of the program;
- 3. That the following streets remain in the permit area: Maple Avenue from Maricopa Street to Torrance Boulevard, the south side of Maricopa Street and both sides of the Torrance Gardens frontage road; and,
- 4. That staff be authorized to implement the approved methodology.

Background information on this item was provided by Transportation Planner Buchman.

Mr. Jack Perry, 815 Cerise Avenue, commended the City Council and Transportation Planner Buchman's efforts relative to this matter. He asked that Cerise Avenue be considered in a manner similar to Maple Avenue; noted that he distributed a letter to each home in Torrance Gardens outlining resident concerns over parking in the area; and related his receipt of two telephone calls from residents adamant about parking and environmental problems in Torrance.

The Council suggested that the draft "Important Notice to Torrance Gardens Homeowners Regarding the Permanent Parking Restrictions in Torrance Gardens" be reformatted for easier reading and that staff contact Mr. Perry to determine what information he distributed so that efforts are not duplicated.

<u>MOTION</u>: Councilmember Messerlian moved to concur with the staff recommendation. The motion was seconded by Councilmember Cribbs and passed by unanimous roll call vote.

13a. TPSA SUPPLEMENTAL #1

RECOMMENDATION

A recommendation of the City Manager and the Fleet Services Director

14. **HEARINGS**

14a. APPEAL RE MIS 96-0152, JAMES DAHL

RECOMMENDATION

The Planning Commission and Planning Director recommend that the City Council deny an appeal of a Planning Commission decision to deny a Minor Hillside Exemption, MIS 96-0152, to allow the enlargement of a rear yard deck on property located in the Hillside Overlay District in the R-1: Single-Family Residential zone at 4305 Paseo de las Tortugas due to the potential for adverse impacts on the privacy of properties in the surrounding area.

With the aid of slides, Senior Principal Planner Gibson provided the staff report. In answer to questions from the Council, Mr. Gibson explained the following: that the caissons on the subject property were installed without the benefit of a permit and that the City has unsuccessfully attempted to have the property owner remove them; that the approval of the subject residence in 1991 was conditioned to require that the west elevation second floor windows shall be a translucent material; and that the windows were of such a material at the time of final inspection but, at this time, they are not.

Mayor Hardison opened the public hearing.

Mr. James Dahl, 4305 Paseo de las Tortugas, related that he had no comments.

Mr. Albert Lee Roberts, 4309 Paseo de las Tortugas, noted that the Planning Commission denied this project twice before it being forwarded to the City Council for consideration and he requested a denial at this time.

There being no additional requests to speak, the following motion was offered.

<u>MOTION</u>: Councilmember Messerlian moved to close the public hearing. The motion was seconded by Councilmember Cribbs and passed by unanimous roll call vote.

Council discussed that the project would negatively impact privacy, particularly from 4309 Paseo de las Tortugas (Roberts' residence). Council related concern over the lack of adherence to the requirement of translucent material for the west elevation second floor windows of the subject residence and over the fact that the caissons have not been removed.

Responding to an inquiry from the Council, Building and Safety Director Isomoto verified that the caissons do not provide any additional stability and that, if they are properly removed, no stability problems should arise.

<u>MOTION</u>: Councilmember Nakano moved to concur with the Planning Department and Planning Commission recommendations to deny the appeal. The motion was seconded by Councilmember Cribbs and passed by unanimous roll call vote.

Senior Principal Planner Gibson explained that a resolution for denial will be presented for the Council's adoption at a future meeting.

Following a question from the Council, City Attorney Fellows advised that written material on how to go about getting compliance with the requirements noted during this discussion will be provided to the Council.

19. ORAL COMMUNICATIONS

19a. City Attorney Fellows mentioned that he became acquainted with the City of Torrance City Council four years ago and he related his appreciation of the residents who participate in the City government.

- 19b. Councilmember Messerlian called attention to the increasing amount of graffiti throughout Torrance, particularly in the southern portion of the City. He noted graffiti on Downey Savings on Pacific Coast Highway across from Ross and along the back wall of Ralph's supermarket. He appealed to citizens who witness this type of activity to contact the City graffiti hotline.
- 19c. Councilmember Messerlian noted a sign is lying in the median at the intersection of Vista Montana and Anza Avenue.

City Manager Jackson indicated that staff will report this problem to Cal Trans.

- 19d. Councilmember Messerlian suggested that, at a future meeting, the Council recognize retiring Senior Deputy Leah Jeffries' long-standing service to the South Bay and the City of Torrance.
- 19e. On behalf of the Salvation Army Advisory Board, Councilmember Nakano thanked City employees for their generous donations of cash, canned foods and gifts for children.
- 19f. Councilmember Nakano related his understanding that the City of Los Angeles has prohibited the use of a particular metal in the construction of steel structures and he asked staff for additional input related thereto.

Building and Safety Director Isomoto advised that staff has requested pertinent information from the City of Los Angeles, which will be forwarded to the Council upon its receipt.

19g. Mayor Hardison suggested that Ms. Barbara Carswell, retired head of the Torrance Federal Credit Union, be honored at a future Council meeting for her many years of service.
