7. ADMINISTRATIVE MATTERS

7A. <u>PRESENTATION AND DISCUSSION – UPDATE REGARDING WATER SUPPLY</u> CONDITIONS

Senior Administrative Analyst Portman presented Item 7A:

- California has no areas in the state with drought. In 2022, the entire state was in a severe drought but wet conditions in 2023 2024 resulted in a drought free California.
- Due to migration of fish, environmental pumping restrictions are in place which limit the amount of water pumped in the State Water Project Aqueduct; an allocation increase is pending.
- Snowpack in the Northern California Watershed is at 123% of normal, due to this, California Department of Water Resources has been releasing water from Lake Oroville and other reservoirs. Snowpack on the Colorado River Basin is at 115% of normal; Lake Powell and Lake Mead are still at low levels.
- Metropolitan Water District's total available supply is projected to be at 1.64-millionacre-feet for the year with demand being at 1.4-million-acre-feet, resulting in a record high surplus.

Members of the Commission spoke.

<u>MOTION</u>: Commissioner Masnek moved to accept Item 7A. Commissioner Siani seconded the motion; a roll call vote reflected 6-0 approval.

7B. PRESENTATION AND DISCUSSION – METROPOLITAN WATER DISTRICT WHOLESALE RATES FOR IMPORTED WATER SUPPLIES IN CALENDAR 2025 AND 2026 AND PROJECTION FOR FUTURE RATES

Water Operations Manager Darlak presented Item 7B:

Metropolitan Water District rates increase is due to cost of chemicals, costs of power going up, and inflation throughout the industry. Property taxes will increase from \$30 to \$60. Without the property tax increase, it was estimated that there would need to be a 5%-6% on the rate increase, hence the decision to go with the property tax revenue.

Members of the Commission spoke.

MOTION: Commissioner Jay moved to accept Item 7B. Commissioner Deemer seconded the motion; a roll call vote reflected 6-0 approval.

7C. DISCUSSION - MONTHLY WATER OPERATIONS REPORT

 Well 9 has been running and Well 10 was reintroduced into the system successfully. Staff is working to get Well 11 introduced in the system once the manganese issue is remedied. Goldsworthy is currently offline due to a scheduled rehabilitation; it is projected to be online July 2024.

- There was (1) main break in April 2024 at Calle Mayor and Susana Avenue where a pressure regulator failed.
- North Torrance Well Field is getting a proposal for a permanent blower system, once this is received, engineers will review and approve to move forward with purchasing.

- Department of Water Resources paid for the Benefit Cost Analysis of the Delta Conveyance Project. Benefits of the Delta Conveyance Project include urban water supply reliability, agriculture water supply, water quality, and seismic reliability.
- Mr. Adel Hagekhalil, The Metropolitan Water District of Southern California's General Manager and Chief Executive Officer, spoke at a hearing for the US Senate Budget Committee to consider *Droughts, Dollars, and Decisions: Water Scarcity in a Changing Climate*. Mr. Hagekhalil's testimony highlighted Metropolitan's achievements, challenges, and plans to ensure water reliability and climate resiliency.
- The Metropolitan Water District owns approximately 14,000-acres in the Palo Verde Irrigation District with approximately 6,000-acres being non-farmable. Metropolitan is in negotiations to lease the land to an energy company who will place solar panels on the acreage to generate electricity.

OVERVIEW OF CURRENT TORRANCE MUNICIPAL WATER RATES

AND PENDING WATER RATE STUDY

On November 14, 2017, the City Council held a Public Hearing on setting municipal water rates for the area of the City served by Torrance Municipal Water (TMW). A comprehensive water rate study was conducted by an outside consultant with extensive experience in developing municipal water rates and related financial matters. The rate process was conducted in accordance with modified Proposition 218 requirements for the five-year period of 2018 through 2022. As a result of the public hearing, the City Council approved rate increases of 12.5% in January 2018 followed by an increase of 10% in January 2019, and subsequent rate adjustments corresponding to the annual changes in the consumer price index for the LA/Long Beach area for the years 2020 through 2022.

These rate increases only applied to customers served by TMW, which serves approximately 80% of the City, and there were no rate adjustments in either 2023 or 2024. The rate increases were necessary to fund local water resource projects, infrastructure replacements and refurbishments, cover increased operating costs, meet new regulatory requirements and maintain adequate reserve levels. Even with these increases, TMW maintains the lowest water rates in the local area.

We are currently in the process of developing a new five-year rate study for the period of 2025 through 2029. The findings and results of this study are expected to be presented to the Commission at both its July and August meeting for consideration. The recommended rate adjustments over the proposed five-year rate period are expected to be brought to the City Council in September 2024 for initiation of the Proposition 218 process, and the item will be brought for final consideration at a Public Hearing in November 2024. Staff will provide an overview presentation regarding current municipal rates and the upcoming rate study.

- 2. There were 2 water main breaks for the month of May 2024, same as May 2023. Total main breaks for calendar year 2024 are 11 compared to 16 in 2023.
- 3. Goldsworthy Desalter will be producing approximately 200 to 275 acre feet (AF) per month to prevent premature loss of production in wells due to over pumping. The Water Replenishment District (WRD) continues to work on plans to connect the Brewer Well with the Goldsworthy Desalter planned expansion. In addition, WRD is planning to begin preliminary construction work on the Desalter expansion project in Fall 2024.
- 4. TMW is exploring purchasing a permanent blower and scrubber system. Water continues to be introduced into the system based on a phased approach and is meeting all water quality requirements. We anticipate increasing groundwater production at the North Torrance Wellfield in the near future.
