13g. STATUS OF MOBIL OIL CONSENT DECREE

Recommendation

The Fire Chief and City Attorney recommend that City Council:

- (2) adopt a resolution approving a protocol for closure of Consent Decree recommendations post December 31, 1997.

In a slide presentation, Mr. Mike Leslie of Hedges & Caldwell, outside counsel for the City, provided information regarding the history of the Mobil Oil Consent Decree; Fire Chief Adams reported on its current status; and City Attorney Fellows outlined the proposed protocol for tracking and closure of recommendations that will extend beyond the Consent Decree's December 31, 1997 termination (per written material of record).

Councilman Nakano noted that it was a series of explosions at the Mobil refinery that heightened public concern about safety and precipitated the Consent Decree; stated that the refinery has become much safer as a result of the decree and recommended that vigilant monitoring continue to ensure that safety levels are maintained; and

congratulated all who participated in making this agreement work for the benefit of the community.

Mayor Hardison observed that great strides had been made in the two areas that most concerned residents, the implementation of the Modified Hydrogen Fluoride Alkylation Catalyst Process (MHF) and the Community Warning and Notification Systems; congratulated the present Council and the previous Council, under the leadership of Mayor Katy Geissert, for being able to successfully resolve this complex issue; and voiced support for the resolution.

Councilman Walker stated that the real credit should go to the approximately 12,000 Torrance registered voters who brought this issue to the attention of residents by means of the initiative process. He added that although the initiative was ultimately defeated, it was the impetus for the process that resulted in the "state of the art" refinery that Mobil operates today.

Ms. Hope Witkowsky, a member of Mobil Oil's Citizen Advisory Council, stated that as a North Torrance resident she had been apprehensive about the safety of the refinery, but after sitting on the council and touring the facility, she now felt very confident that her neighborhood is safe. She thanked Mobil Oil for allowing local residents to be a part of this process.

Ms. Marilyn Throssel, 3909 176th Street, voiced her appreciation for all the work that has been done on this matter and commended the warning siren and Radio Alert System for nearby residents and schools.

18a. **REGULATION OF COMMERCIAL LIGHTING**

Recommendation

The City Manager recommends that City Council consider the creation of an ordinance to regulate commercial lighting relating to lumens.

Assistant to the City Manager Sunshine presented the staff report (per written material of record) and advised that this matter was being brought before the Council in direct response to concerns that were raised at a recent City Council Meeting regarding bright lights located at a business in Torrance. Building and Safety Director Isomoto stated that current code requirements don't cover intrusive commercial lighting and such

issues are dealt with on a cooperative basis with the businesses; and noted that this is a comparatively new issue, insufficient lighting being a far more common problem.

Councilman Walker expressed his opinion that the lighting situation prompting this action is unique and that the problem is better solved with the owner's cooperation rather than enacting unnecessary regulations that impact businesses that don't require this type of control.

Councilwoman Cribbs observed that the problem at the subject location has not been corrected, despite discussions with the owner, and stated that she would like staff to explore minimum and maximum lighting requirements so that the whole lighting issue can be addressed.

Councilman Lee agreed with Councilwoman Cribbs, adding that he believes technology has progressed to such a degree that powerful commercial lighting can seriously impact residential neighborhoods, and that minimum and maximum standards should be investigated. Councilwoman O'Donnell concurred with Councilwoman Cribbs and Councilman Lee.

Mr. Charles Boughton, 4039 W. 175th Place, stated that he would like to see an ordinance proposed to regulate lighting in order to prevent future problems.

<u>MOTION:</u> Councilwoman O'Donnell moved to concur with the staff recommendation. The motion was seconded by Councilwoman Cribbs and passed by unanimous roll call vote.

18b. STAGING OF WEATHER CHANNEL BLIMP AT TORRANCE AIRPORT

City Attorney Fellows requested that the Council, by two-thirds vote, consider adding the Staging of the Weather Channel Blimp at Torrance Airport to tonight's agenda, recognizing that the need to take action on this matter arose subsequent to the posting of the agenda.

MOTION: Councilman Walker moved to add the above item to the agenda. The motion was seconded by Councilwoman Cribbs and passed by unanimous roll call vote.

Recommendation

The Airport Commission recommends that City Council approve the staging of the Weather Channel Blimp at Torrance Municipal Airport from December 19,1997 to January 25, 1998.

Airport Manager Hriz presented the staff report and confirmed that problems associated with the blimp's earlier visit in September had been resolved.
