#### 6A. <u>APPROVAL OF MINUTES - July 2, 2024 Commission on Aging</u>

<u>MOTION</u>: Acting Chair Mayfield moved and Commissioner Grundhaus seconded, to approve the minutes of the Commission on Aging meeting of July 2, 2024, as submitted. The motion passed by a 4 to 0 vote. (Absent: Commissioner Hileman)

#### 7. ADMINISTRATIVE MATTERS

#### 7A. PRESENTATION: COGIR OF SOUTH BAY

Jill Allen, Community Relations Director of Cogir of South Bay presented information on the recently opened facility in Torrance which provided resort style living for Active Seniors. She detailed the property features: 158 units, full-sized kitchens, salon and spa, movie theater, fitness studio, club room, outdoor deck with pool as well as multiple dining venues. She listed the amenities at Cogir: concierge services, social events, scheduled transportation and weekly housekeeping as well as routine maintenance. She noted that 90% of the residents at Cogir were independent and added that tours of the facility were available. She explained that everything was included in the price: with an average of \$7000 per month for a studio or \$8500 per month for 1 bedroom and explained that care was not included in the price.

#### 7B. PRESENTATION: TORRANCE TRANSIT UPDATE

Transit Planning Manager David Mach provided information on the "Connect Torrance" Microtransit Demonstration Pilot Program, which would supplement the current Senior Taxi Program, Transit program (TCTP) Taxi and the existing bus service. He explained that the program was on-demand transit and a hybrid model between individual private transportation, like Uber or Lyft, and public transit. He added that the service would be more flexible than traditional fixed route bus service and appointment-based paratransit. He noted that there would be a call-in center with representatives to assist in booking rides and the service would be able to provide the first/last mile connections to transit and the regional transit center. He reviewed the details of the Microtransit program: the service area, eight branded dedicated vehicles in service with four of the vehicles being wheelchair accessible, seven days a week service, expected wait times of less than 15 minutes, contact through a Torrance Rider app or through a call to the call center. He noted that the differences between the Senior Taxi Program, the fixed route bus services and the "Connect Torrance" Microtransit Demonstration Pilot Program. He confirmed that once the Pilot Program had been approved by City Council, the department would begin to market the program with outreach to the City, community organizations, local businesses and residents within the Microtransit zone.

Members of the public spoke of the current problems with the current Senior Taxi Program.

#### 7C. DISCUSSION: ELECTION OF OFFICERS

Commissioner Dojiri nominated Commissioner Mayfield to be Chair.

Commissioner Mayfield accepted the nomination.

<u>MOTION</u>: Commissioner Davis moved and Commissioner Grundhaus seconded, to nominate Commissioner Mayfield to be Chair. The motion passed by a 4 to 0 vote. (Absent: Commissioner Hileman)

Commissioner Davis nominated Commissioner Hileman to be Vice Chair.

<u>MOTION</u>: Commissioner Mayfield moved and Commissioner Dojiri seconded, to postpone the nomination of Commissioner Hileman to be Vice Chair to the next meeting, The motion passed by a 4 to 0 vote. (Absent: Commissioner Hileman)

#### 7D. DISCUSSION: TORRANCE CENTENARIAN PROGRAM

Senior Recreation Supervisor Castro noted that the presentation for the Centenarian Award for Joseph Gerson would take place on Tuesday, August 20 at the City Council meeting at 6:30 p.m. and requested that the Commissioner confirm with him by August 12, whether or not they planned on attending the event.

Chair Mayfield confirmed that she would attend.

## Why the ENGAGE Program



- Combat social isolation and loneliness
- Research looking at older adults and social isolation/loneliness
  - 2023 University of MI study
    - 1 in 3 adults aged 50 to 80 (34%) reported feeling isolated from others
    - 33% reported having infrequent contact (1x/week or less) with people from outside their home
    - 37% reported they felt a lack of companionship during past year

## Why the ENGAGE Program



- Causes of social isolation include:
  - Chronic diseases and conditions
  - Dementia
  - Mobility challenges
  - Sensory impairment (e.g. hearing loss)
  - Depression & anxiety
  - Low-quality relationships
  - Disruptive life events (e.g. loss of spouse)
  - Poverty
  - Language barriers
  - Lack of transportation
  - Lack of family nearby
  - Rural location

## Why the ENGAGE Program



- What does social isolation do to a person?
  - Studies have linked being socially isolated with a 29% higher all-cause risk for mortality and 25% greater risk for cancer mortality
  - Social isolation and loneliness have also been associated with higher rates of
    - High blood pressure
    - · Heart disease
    - Weakened immune system
    - Dementia, especially Alzheimer's disease
    - Functional decline (e.g. inability to drive, cook meals, pay bills, etc)
