MINUTES OF A MEETING OF THE TORRANCE SOCIAL SERVICES COMMISSION

1. CALL TO ORDER

The Torrance Social Services Commission convened in a regular session at 6:00 p.m. on Thursday, August 22, 2024 at the West Annex Commission Meeting Room, Torrance City Hall.

2. FLAG SALUTE

3. REPORT OF THE STAFF ON THE POSTING OF THE AGENDA

Deputy City Manager Hoang stated that the agenda for the Social Services Commission was properly posted on Thursday, August 15, 2024 on the Public Notice Board by the City Clerk's office and on the City's website.

7. ADMINISTRATIVE MATTERS

7A. ACCEPT AND FILE UPDATE ON 2024 DONATIONS AND DRIVES

Deputy City Manager Hoang presented the report for the item and listed the dates of the Toiletry Drive, April 15 - April 30, 2024 and the Torrance Unified School District (TUSD) Back-to School Drive, June 24, 2024 - July 25, 2024. He detailed the items from the Toiletry Drive which had been collected and distributed to 3290 Temporary Housing Village (3290), 1736 Family Crisis Center and Family Promise of South Bay, as well as the items that had been collected and distributed from the TUSD Back-to School Drive. He noted that there were also ongoing year-round donations for 3290 from multiple organizations in the community, including faith-based and student organizations. He introduced Hina Usuda and Nelly Yermakova, two South High school students who explained how they had organized a State Seal of Civic Engagement program which included a drive to collect supplies for 3290 and provided homelessness awareness to the South High community and peers, using the school's Instagram account and a partnership with the South High National Honors Society.

There was no public comment.

MOTION: Commissioner Sansalone moved to accept and file Item 7A as submitted; motion was seconded by Commissioner Reynolds. The motion passed by a 7-0 roll call vote.

7B. ACCEPT AND FILE PRESENTATION FROM CHAIR OF THE SOUTH BAY COALITION TO END HOMELESSNESS AND THE CITY OF TORRANCE STAFF SUMMARIZING THE 2024 GREATER LOS ANGELES HOMELESS COUNT

Deputy City Manager Hoang reviewed how Torrance had become involved in the homeless count and briefly discussed the South Bay Coalition to End Homelessness (SBCEH) connection to the City. He introduced Grace Weltman, Chair of the SBCEH who discussed her history with the Homeless Count and reported that the SBCEH's mission was to transform and end homelessness in the South Bay through education, advocacy and coordination and listed the SBCEH's four main objectives. She reviewed the components of SBCEH's ongoing partnership with the City of Torrance, provided an overview of the HUD requirements of the Homeless Count and the Federal definitions of "homelessness". She noted that Greater Los Angeles Homeless Count began in 2005 and was led by the Los Angeles Homeless Services Authority (LAHSA) which provided the breakdowns for the demographic statistics for the County and (Service Planning Area) SPA level and the reasons for homelessness. She discussed the various components to the methodologies for the Homeless Count. She noted that count results needed to be kept in perspective and added that SPA8's trends did not always follow those at the County level. She discussed the trend for both the Los Angeles County Homeless Count and the South Bay homeless count and listed other key 2024 findings. She discussed the many reasons for homelessness, including the lack of affordable housing.

Deputy City Manager Hoang provided key observations and feedback on the City-run Homeless Count in Torrance on January 24, 2024. He shared the raw data from the Torrance count from 2023 and 2024, but advised that the final data with multipliers had not yet been released by LAHSA. He noted that there were additional links included in the item attachments to access additional LAHSA data. He announced that the 2025 Homeless Count would be held on January 22, 2025.

There was no public comment.

MOTION: Commissioner Pryor moved to accept and file Item 7B, as submitted; motion was seconded by Commissioner Furey. The motion passed by a 7-0 roll call vote.

RECOMMENDATION

Recommendation of Staff that the Social Services Commission accept and file a presentation from Housing Specialist Thuy Do on Exodus Recovery's Full Service Partnership and Wellness Clinic in Service Planning Area (SPA) 8

BACKGROUND AND ANALYSIS

Exodus Recovery Inc. (Exodus) provides psychiatric and chemical dependency treatment services throughout Southern California. In addition to operating hospital-based inpatient and outpatient programs, Exodus has developed Full-Service Partnerships (FSP), Wellness Centers, Field Capable Clinical Services, and Psychiatric Urgent Care Centers in Los Angeles County.

Tonight, Housing Specialist Thuy Do will present an overview of Exodus' FSP and Wellness Clinic in Redondo Beach. The SPA 8 Wellness Clinic and FSP both serve adults impacted by chronic mental illness. The FSP is an outpatient program that focuses on assisting participants actively pursuing recovery-based goals such as employment, education, housing, medication, symptom management, and social skill building. The Wellness Center is an outpatient program that provides participants with therapy, rehabilitation, education, symptom management, life skills building, and socialization.

This evening, staff has asked Ms. Do to provide an overview of the FSP and Wellness Clinic including how the programs are accessed and targeted beneficiaries of the programs. Ms. Do will also provide ways in which the City can support Exodus and address questions from your Honorable Body.
